SEATTLE – The Seattle City Council is looking for three (3) representatives of the at-large Seattle community who do not reside in the recently formed [Waterfront Local Improvement District](#), at least one of whom brings expertise and perspective from the labor community, to serve on the newly created Central Waterfront Oversight Committee (CWOC).

Two of these positions will have an initial term of three (3) years, and one position will have an initial term of two (2) years. All subsequent terms shall be two (2) years.

The ideal candidates will have experience with operations and maintenance of a public or private asset, with special preference given to experience managing public areas and/or parks. These positions are appointed and confirmed by City Council.

The nineteen-member CWOC was established in 2019 by Ordinance 125761 and is comprised of the following members:

In addition, there are five permanent positions on the CWOC appointed by the Executive Director/President/CEO of the Pike Place Market Public Development Authority, Downtown Seattle Association/Metropolitan Improvement District, Seattle Historic Waterfront Association, Alliance for Pioneer Square, and Seattle Aquarium Society.

The CWOC shall advise and provide feedback to the City and Central Waterfront Operating Partner on the operations and maintenance and safety and security of the Waterfront Park and Public Spaces, beginning with a pilot management agreement for Piers 58 and 62, that shall include maintenance, public safety, outreach, communications, partnerships, and programming and activation. Committee shall help ensure there is clear planning, coordination, and delivery of high-quality, public space management services, broad, inclusive programming and activation and a safe and inviting environment for pedestrians and visitors. The Committee shall also review and provide input on the long-term Management Agreement that shall be developed between the City and Operating Partner.

Committee meetings will be held four (4) to six (6) times per year. Committee members generally must commit approximately six hours per quarter to Commission business and serve without compensation. Applications are due by July 3, 2019. The City of Seattle is committed to promoting diversity in the city's boards and commissions. Women, persons with disabilities, sexual and gender minorities, young persons, senior citizens, persons of color, and immigrants are encouraged to apply.
