Guest speaker

Roberto Maestas, Founder/Executive Director, El Centro de la Raza

- Introductions of both the panel and Mr. Maestas
- El Centro
 - o 35 years of existence
 - Community based organization
 - Work on multi racial unity
 - He thinks Seattle is way ahead of other cities in multiracial relations
- Mr. Maestas shared a couple of personal stories of police rudeness. He said 97% of his contacts with police had been negative, both harsh and adversarial. He felt the officers backed off and changed their tone when they recognized his name, and said he was not sure the same thing would happen to ordinary people.
- He thinks officers need to be friendlier, not so mean-spirited, and respect the citizen's dignity
- People from the community come to El Centro and share their stories of police aggressiveness.
 - El Centro doesn't have one particular staff person assigned to working on these issues
 - o Usually anyone available takes down notes of an incident
 - Then, El Centro reaches out to 'friendly' lawyers or police officers in attempt to help the public to resolve the particular situation. Maestas uses his personal relationships with the Chief and senior management. He thinks relations are improved at that level, but not at the street level.
 - o They don't bring their cases to OPA
- Biggest problems with the police
 - o Authoritarian approach
 - Power of the police guild vs. public
- Positive Experiences
 - o South precinct police
 - Community Policing
