11	WHEREAS housing vacancy rates are at low levels, making it increasingly difficult for people to			
12	obtain permanent housing; and			
13	WHEREAS, removal of residential units from the long-term housing market contributes to low			
14	vacancy rates; and			
15	WHEREAS, the conversion of long-term housing units to short-term rentals could result in the			
16	loss of housing for Seattle residents; and			
17	WHEREAS, according to data published by Airbnb in December 2015, 630 units were rented on			
18	the Airbnb platform for more than 90 nights a year; and			
19	WHEREAS, it is in the public interest that short-term rental uses be regulated in order to help			
20	preserve housing for long-term tenants; and			
21	WHEREAS, the exception created here for short-term rentals uses rented for less than 91 nights			
22	in any 12 month period provides flexibility for short-term rentals offered on an			
23	occasional basis; and			
24	WHEREAS, short-term rental platform's business depends upon participation and contact with			
25	local short-term rental operators; and

2	help preserve the City's permanent housing stock, reduce negative effects on affordable			
3	housing, and protect the livability of residential neighborhoods; and

5	and welfare of the general public,			
6	NOW, THEREFORE,

8	Section 1. A new Section 23.42.060 is added to the Seattle Municipal Code as follows:			
9	23.42.060 – Short-term Rentals and Bed and Breakfasts			
10	Short-term rental and bed and breakfast uses are subject to the following provisions:			
11	A. Short-term rentals and bed and breakfasts are permitted as an accessory use to any			
12	residential use.			
13	B. A short-term rental use may be located in an accessory dwelling unit.			
14	C. Limit on number of nights.			
15	1. Except as provided in subsection 23.42.060.C3, when a person provides a			
16	dwelling unit or a portion thereof as a short-term rental or bed and breakfast, and the dwelling			
17	unit is the person's primary residence, there is no limit on the number of nights the dwelling unit			
18	or portion thereof may be rented for short-term rental or bed and breakfast use.			
19	2. When a person provides a dwelling unit or portion thereof that is not their			
20	primary residence for short-term rental use, the dwelling unit or portion thereof may be rented as			
21	a short-term rental use for a maximum of 90 nights in any 12 month period.			
22	3. In multi-family zones, there is no limit on the number of nights the dwelling			
23	unit or portion thereof may be rented as a bed and breakfast use.

1	D. Business License.	
2	1. All owners or operators of short-term rental uses and bed and breakfast uses	
3	shall have a Business License Tax Certificate issued by the Department of Finance and	
4	Administrative Services.	
5	2. All operators of short-term rental uses that are rented for more than 90 nights in	
6	a 12 month period at a single dwelling unit, as permitted by subsection 23.42.060.C.1, shall have	
7	a Short-Term Rental Operator's License issued by the Department of Finance and Administrative	
8	Services.	
9	3. All operators of bed and breakfast uses rented for more than 90 nights in a 12	
10	month period shall have a Short-Term Rental Operator's License issued by the Department of	
11	Finance and Administrative Services.	
12	E. Number of residents and guests. The total number of residents and guests occupying a	
13	dwelling unit that includes a short-term rental may not exceed the number of residents allowed in	
14	a household. For sites with an accessory dwelling unit, the total number of residents and guests	
15	occupying both dwelling units may not exceed the number allowed for a household.	
16	1. A bed and breakfast use in a single-family zone may have up to five guest	
17	rooms and the maximum number of residents and guest allowed shall be as permitted by Title	
18	22, provided that there is no limit on the number of guest rooms in: (1) a bed and breakfast use in	
19	a multi-family zone, or (2) a bed and breakfast in a single-family that was lawfully established	
20	on or before April 1, 1987 and that has been continuously operated as a bed and breakfast since	
21	April 1, 1987.	
22	F. Short-term rental uses and bed and breakfast uses may display signs identifying the use	

if the signs are permitted by Chapter 23.55;
