Findings of Fact

2. Based upon the record both written and oral, the court finds that the defendant has been charged with, arrested for, or convicted of a stalking offense. The court issues this Stalking No-Contact Order under RCW 7.92.160 and Seattle Municipal Code 12A.06.035/SMC 12A.09.020/RCW 9A.46.110.

3. The court makes the following mandatory findings pursuant to RCW 9.41.800: The defendant used, displayed, or threatened to use a firearm or other dangerous weapon in a felony.
 The defendant is ineligible to possess a firearm due to a prior conviction pursuant to RCW 9.41.040; or Possession of a firearm or other dangerous weapon by the defendant presents a serious and imminent threat to public health or safety, or to the health or safety of any individual.

4. Defendant:

- A. do not contact the protected person.
- B. do not knowingly come within or knowingly remain within _____ (1,000 feet if no distance entered) of the protected person's home, school, business, place of employment, other locations: _____.

5. Firearms and Weapons and Concealed Pistol License, Defendant:

- do not access, obtain or possess a firearm, other dangerous weapon or concealed pistol license. (RCW 9.41.800. See findings in paragraph 3, above)
- shall **immediately surrender** all firearms and other dangerous weapons within the defendant's possession or control, and any concealed pistol licenses, to the Seattle Police Department.

6. **Electronic Monitoring, Defendant:**

must submit to electronic monitoring. See separate order or provider and terms of monitoring:

Warning: Violation of this order is a criminal offense under chapter 26.50 RCW and Seattle Municipal Code 12A.06.180 and will subject a violator to arrest. You can be arrested even if any person protected by this order invites or allows you to violate the order's prohibitions. You have the sole responsibility to avoid or refrain from violating the order's provisions. Only the court can change the order. (Additional warnings on page 2 of this order.)

Additional Warnings to Defendant: Willful violation of this order is punishable under RCW 26.50.110. Pursuant to 18 U.S.C. § 2265, a court in any of the 50 states, the District of Columbia, Puerto Rico, any United States territory, and any tribal land within the United States shall accord full faith and credit to the order.

Additional Orders

8. The clerk of the court shall enter this order into a computer-based criminal intelligence system available in the state used by law enforcement to list outstanding warrants or forward a copy of this order on or before the next judicial day to the protected person's local law enforcement agency.

9. This order replaces all prior no-contact orders protecting the same person issued under this cause number.
