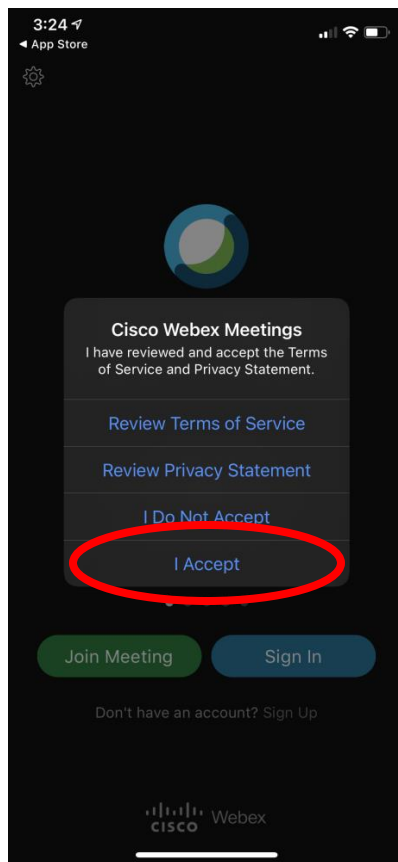
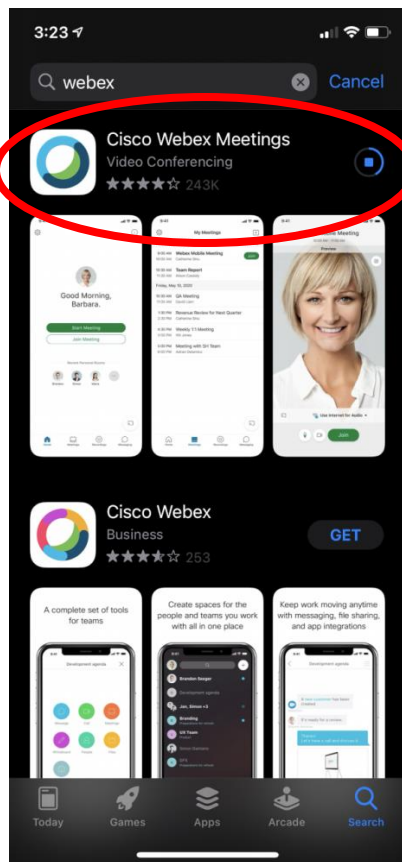




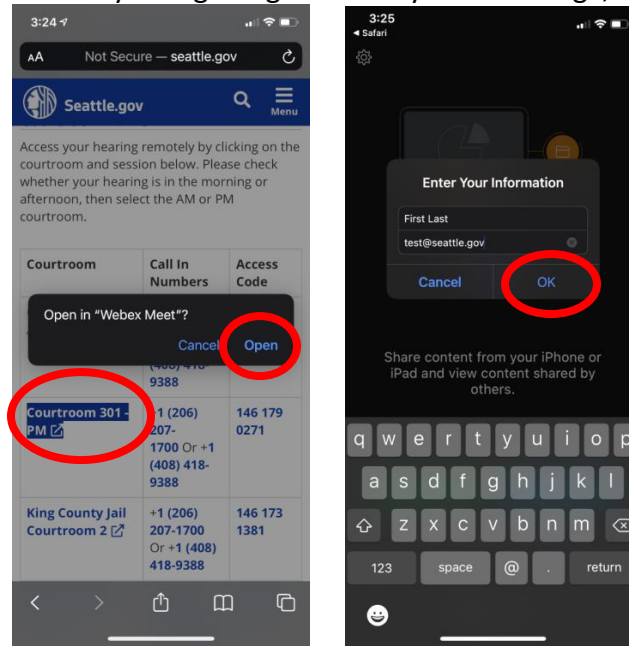
## Sida loo Galo Dhegeysi Khadka Webex – Foon-casri ah ama Tablet

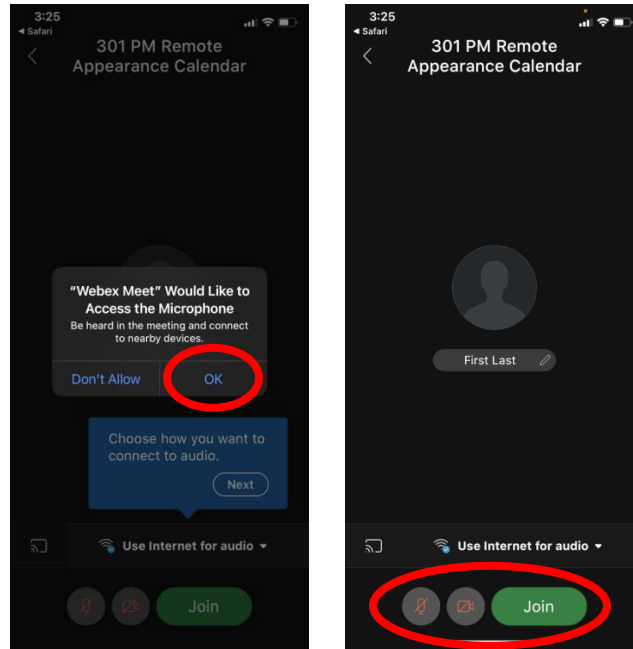
1. **Si loogu galo fiidiyow:** Kow, ka raadi WebEx dukaanka barnaamijta foonkaaga oo soo degso arjiga Cisco WebEx Meetings.
2. Fur arjiga WebEx oo aqbal Qodobbada Adeegga/Bayaanka Xog-dhawrista.



3. Kadib markaa ku shubatid arjiga, fur [bogga Maxkamadda Magaalada Seattle](#) oo guji isku-xiraha qolka maxkamadda dhegeysigaaga. Wuxuu kaaga furi doonaa WebEx —guji “Open.”
4. Geli magacaaga koobaad iyo magacaaga dambe iyo iimeelkaaga, kadib guji “OK.”



5. Hadii lagu weydiyo, sii oggolaansho WebEx xagga makrafoonkaaga iyo kaamirada ayadoo la gujinayo “OK.”
6. Waxaa ku daari ama ku damin kartaa makrafoonkaaga iyo kaamirada calaamadaha shaashadda hoosteeda. Markey calaamaduhu guduudanyihiin oo xariijin dhexmarsantahay, macnaheedu waa codkaagu waa xiranyahay kaamiradaaduna wey dansantahay. Fadlan makrafoonkaaga codka ka xir illaa aad hadleysid mooyaane kaamiradaadana daar inta dhegeysigaaga lagu jiro.
