

Phase I: RFI Application - Key Program Components

- Students must be enrolled in Seattle Public Schools
- Serve students experiencing homelessness or housing instability
- Be responsive to referrals from school staff within 48 hours
- Able to meet families at the location that is most convenient for them
- Implement culturally-responsive programming, which incorporates the following program elements:
 - Housing case management
 - Staff and professional development
 - Family and community involvement

Phase I: RFI Application - Co-Design and Continuous Quality Improvement

- Implement a scope of work that is complementary to existing resources
- Collaborate to develop a service delivery model and provide housing support services
- Collect, analyze, and regularly submit data to track student and family progress
- Attend quarterly meetings to discuss opportunities to improve the service delivery system.

- Partner(s) selected by September 2019
- Co-Design September 2019 -January 2020
- Program Implementation starting January 2020

- To help determine a partner's readiness to participate in the design process and ultimately implement homelessness and housing supports in collaboration with DEEL and SPS.
- To help determine a provider's interest in developing an external evaluation of the intervention.
