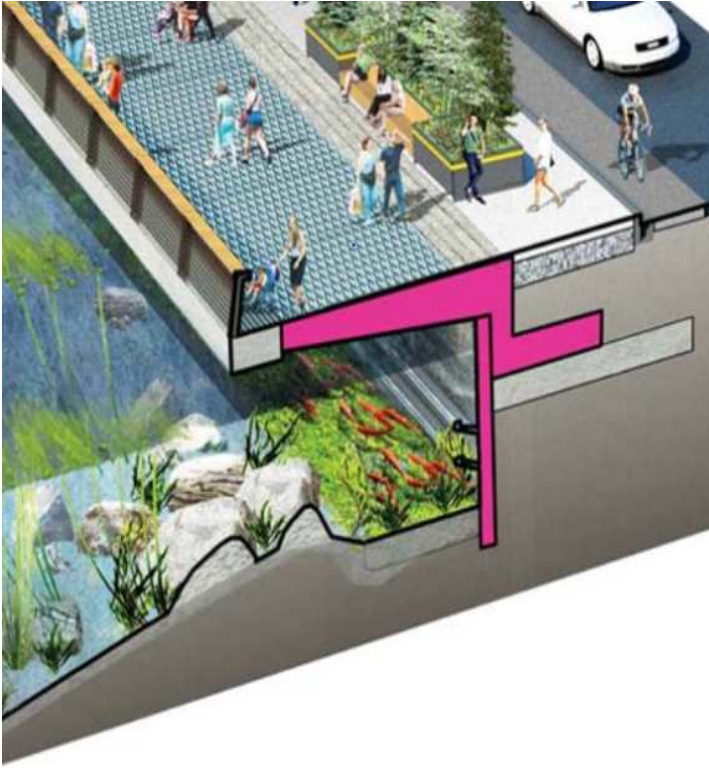


# Elliott Bay Seawall Project



## PROJECT DESCRIPTION:

The Elliott Bay Seawall runs underneath Alaskan Way along Elliott Bay in downtown Seattle from South Washington Street to Broad Street. This project includes construction of the central portion of the seawall from South Washington Street to the northern edge of Pier 63 (roughly Virginia Street). This includes constructing a new earthquake-resistant system that will support the street and right-of-way, provide access to the waterfront piers, improve marine habitat, and support upland uses. The successful completion of this project will form the foundation upon which the upland improvements in the Waterfront Program will rest.

**ESTIMATE:** Contract Value: \$220,000,000 for Construction.
