King County Economic Opportunity and Empowerment Program:

- Passed by King County Council to ensure economic opportunities created by the new Children & Families Justice Center (CFJC) are available to most disadvantaged
- \$1 million to support program from excess revenue of levy proceeds (9 year property tax passed in 8/12)
- Advisory board formed to advise/assist project administrator appointed by County Executive
- Develop a plan to provide employment and business opportunities in the construction of the CFJC \$210 million facility - achieve/exceed hiring and training goals for apprentices and utilization goals for small contracting and suppliers for CFJC project
