## ORDINANCE NO. 38523

AN ORDINANCE amending Section 6 of Ordinance No. 37,737, entitled "An Ordinance relating to certain property in Adam's First Addition to Fauntleroy Park, directing the improvement of certain streets in said addition, making an appropriation to pay therefor, appropriating an additional amount to relieve certain property in said addition from assessments heretofore levied, authorizing the acceptance of a deed to a portion of said property, and the payment of certain assessments without penalty, and declaring an emergency", approved the 26th day of September, 1917.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. That Section 6 of Ordinance No. 37,737, be and the same is hereby amended to read as follows:

Section 6. That the city treasurer be and he is hereby authorized and directed to accept, on or before October 9, 1918, as payment in full for any delinquent assessments as levied against the following lots in Adam's First Addition to Fauntleroy Park, Local Improvement District No. 2312, the amount of the original assessment plus the regular rate of interest, but without any penalty attached thereto:

Lots one (1) to eleven (11), thirteen (13), sixteen (16) to twenty-six (26) in block one (1); lots one (1) to eighteen (18), block two (2); lots one (1) to twenty-four (24), block three (3); lots one (1) to three (3) and five (5) to nineteen (19), block four (4); lots one (1) to four (4), block five (5); lots one (1) to ten (10), seventeen (17) to twenty-four (24), thirty-one (31) to thirty-five (35), and thirty-seven (37) to thirty-nine (39), block six (6); lots one (1) to seventeen (17), block seven (7); lots one (1) to eighteen (18), block eight (8); lots one (1) to thirty-one (31), block nine (9).

Section 2 This ordinance shall take effect and be in force thirty days from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the city charter.
