ORDINANCE 85733

AN ORDINANCE authorizing the City Engineer to negotiate for and to acquire by purchase property and property rights necessary for the widening of Empire Way between East Cherry Street and Yesler Way and of Empire Way South between Yesler Way and Dearborn Street pending condemnation proceedings under Ordinance 84354; and making an appropriation from the City Street Fund therefor and to pay certain agreed condemnation awards when accepted by the City Council.

WHEREAS, the City Engineer has advised (C. F. 230611) that certain properties and property rights necessary for the extension and widening of Empire Way may be acquired by negotiation and purchase; Now, Therefore,

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. That the City Engineer is hereby authorized to negotiate for and to purchase the property described in Condemnation Ordinance 84354 and such additional property and property rights as he may deem necessary for the widening of Empire Way between East Cherry Street and Yesler Way and of Empire Way South between Yesler Way and Dearborn Street.

Section 2. That there is hereby appropriated from the City Street Fund the sum of One Hundred Thousand Dollars (\$100,000.00), or so much thereof as may be necessary, for the purposes contemplated in Section 1 hereof and for the payment of such verdicts in Cause No. 499340, Ordinance 84354, as may be agreed to, provided that the City Council shall first have accepted such agreed awards.

Section 3. This ordinance shall take effect and be in force thirty days from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the city charter.
