2. Any spill, release of product, or fire shall be immediately reported to the Seattle Fire Department by dialing 9-1-1.
3. Shipping papers and other required documents shall be available for review in the jobsite's office (Section 1).
4. Call the Marine Terminals Inspector at (206) 386-1450 with any questions or changes in the scheduled shipment.
