Fireworks Use/Display Before a Proximate Audience

NOTICE

This permit shall be kept on the premises designated herein at all times and shall be readily available for inspection by the fire code official. (SFC 105.3.5)

1. All insurance requirements must be reviewed by and approved by the City of Seattle Office of Risk Management. (SFC 105.3)
2. Only those proximate fireworks products listed as follows may be used:
Optional Fireworks may be used with notification and approval by a representative of the Fire Prevention Division prior to the event.
3. During the setting up of the fireworks display, security personnel shall be in place to prevent unauthorized access to once the shells and fireworks products are moved into place. (NFPA 8.2.6)
4. In addition, a safety zone shall be established and maintained in . This safety zone shall be maintained clear of all spectators and personnel that have not been pre-approved by the on-site Fire Marshal's inspector. (SFC 105.3)
5. A safety zone shall be established and maintained for . This safety zone shall be maintained clear of all spectators and persons that have not been pre-approved by the on-site Fire Marshal's inspector. (SFC 105.3)
6. No shells and/or fireworks effects shall be shot directly over or towards spectators. (SFC 105.3)
7. There must be a minimum of four (4) fire extinguishers within 50 feet travel distance of all special effects devices. Two of the required fire extinguishers must have a minimum U.L. rating of "2A". The remaining two required fire extinguishers must have a minimum U.L. rating of "40BC". (SFC 105.3 & 906)
8. This fireworks show must be coordinated, supervised and fired by a Washington State Licensed pyrotechnic operator. (SFC 105.3)
9. All necessary precautions shall be in place to ensure that fireworks products stay dry and do not become wet prior to firing. (SFC 105.3)
10. All fireworks products must be kept in ready boxes until such time as they are loaded into firing positions. (SFC 105.3)
11. At the conclusion of the event, the permit holder shall maintain a fire watch at the discharge site for a period of not less than ½ hour. The fire watch shall be tasked with searching for and extinguishing any embers that may still be burning as the result of the display. (SFC 105.3 & NFPA 8.7.3)

12. The person responsible for overseeing the discharge of the fireworks/special effects shall maintain a cell phone at all times. The cell phone must be readily available to provide direct communications with a representative of the Fire Prevention Division and to summon the Fire Department if needed. (SFC 105.3 & NFPA 8.3.5)
13. If applicable, all on field operations and halftime events will be coordinated weekly with stadium staff. This information shall be reviewed by a representative of the Fire Prevention Division prior to the event.

ANY VARIATION FROM THESE WRITTEN CONDITIONS WHICH HAS NOT RECEIVED PRIOR APPROVAL FROM THE FIRE DEPARTMENT CONSTITUTES A VIOLATION OF THE SEATTLE FIRE CODE AND SHALL CAUSE THIS PERMIT TO BE INVALID. FIRE CODE VIOLATIONS ARE BOTH CRIMINAL AND CIVIL IN NATURE AND WILL BE DEALT WITH ACCORDINGLY.
