History/Background of Othello Village

Originally, the City sited seven potential sites for the three City-sanctioned encampments. The first three sites to be utilized were in Ballard, Interbay, and SoDo. The SoDo site, because of its proximity to electrical lines, proved to be unfit/unsafe for an encampment site. Meanwhile, the Low Income Housing Initiative (LIHI) had acquired two properties in the Othello neighborhood with intention to develop as affordable housing. LIHI proposed that this site be used as the third encampment while they are waiting for funding to be secured and design approval (at least two years). City approved this plan. LIHI is the property manager and provides case management services. Nickelsville is the site operator.

Othello Village Community Advisory Committee

For each of the three City of Seattle sanctioned encampments, there is a requirement that the encampment operator establishes a 7-person Community Advisory Committee. Each CAC member should represent a different stakeholder group/perspective. This group is responsible for advising on encampment operations, identifying strategies for handling community complaints/concerns.

Minutes of Meeting

1) Updates from Nickelodeons (aka Othello Village Residents)

- a) Number of people living at Othello Village 51 people including seven children and 6 couples. 6 people move out, 2 to an apartment.
- b) 2 incidences where Seattle Police Department was called in the last month One a medical emergency, one a domestic dispute.
- c) SPD officer volunteers to come by weekly and play with the kids.
- d) Many residents are finding part or full time work.
- e) Nickelodeons participated in the following community events.
 - i) 6 Nickelodeons attended a pizza party at a local church.
 - ii) Every third Sunday a community dinner at the Rainer Community Center 4:30 pm.
 - iii) Ethiopian Community Center hosted a dinner and health clinic.
 - iv) MLK Jr street clean up and Bridge to Beach clean up.
 - v) Seattle University Rotaract Dinner sponsored by Seattle International District Rotary was held on May 14 and raised money for Nickelsville and LIHI.
 - vi) Dearborn Encampment clean up.
 - vii) Emerald City Block Party hosted an information table.
 - viii)Sunday, May 22nd Othello Village Open House BBQ 2-5 pm & Community Potluck.
 - ix) Part of Nickelsville contribution to the community is a regular community service hours that they require from their residents (i.e. litter pick up).
 - x) Participation in the Southeast District Council.
 - xi) Drop in tours of Othello Village anytime Use the main entrance on MLK Jr. Way.
 - xii) Some of the projects that are currently in the works:
 - (1) Development of a Resource Center on site: computer, job search.
 - (2) Youth Tent for activities for children.
 - (3) Othello Village Completion Party Sunday, June 5, 11:00 am 5:00 pm Professional mural, collage making, live music, food, volunteer activities, familyfriendly, all-ages. 11:00 am – 5:00 pm. Volunteer shifts: 11 pm – 2 pm, 2 pm -5pm. Speakers at 2 pm. Donations welcome.

- a) Two families are about to move out to housing.
- b) Two people have moved into permanent housing.
- c) LIHI continues to oversee case management for residents.
