**Brief Summary:** The meeting convenes with the board recognizing that quorum is not established for the meeting and all voting will be postponed until the July meeting. The status of the May action items are updated and the board members check in on several issues including the meeting with Seattle's Office of Intergovernmental Relations (OIR), update on the Arizona Boycott and the search for the new police chief. The protocol for meeting presentations is reviewed with the board and suggestions are given. The board checks in about the status of subcommittees and the need for a mandate from the ad-hoc subcommittee. The board discusses possibly hosting an event to celebrate the accomplishments of the board.

# Office of Intergovernmental Relations (OIR) Follow Up

- Shankar met with Marco Lowe lobbyist with OIR
  - He encouraged board to go directly to federal lobbyist to state I&R concerns
  - Shankar will schedule meeting with OIR federal lobbyist to discuss extension of refugee benefits
    - Jesus, Shankar, Muhamed and Yasemin will attend meeting

# Updates Re: Arizona Boycott

- Suggestion to create standard I&R letter to send out when anti-immigrant legislation is presented in various governments
- Another strategy is to create list of contacts to extend reach of advocacy efforts
  - Board would like to put together directory of advocates for immigrant rights
    - Ask board members to send preliminary list of contacts to add to directory
      - Jesus will take lead on this

# Police Chief Search

- One candidate dropped out of race for police chief
- Mayor's office is looking for feedback from community about next police chief
  - Board could look into possibly supporting remaining candidates: Davis or Diaz
    - Board discusses which candidate to endorse as there is not a lot of info about the background of each candidate
      - Determined that board will not come to consensus but individual board members should reach out to city and give feedback regarding police chief

# Protocol for Presenters

- Draft was received from Paulina and Halima. Suggestion for additions include:
  - Determine meeting goals and send to presenters in advance so they can be prepared for meeting
    - Chairs will take lead on this and send agenda to presenters
  - Add info on how protocol will differ based on whether board members are meeting with city council members or if presenters come to meeting
- Board requests that city staff make summary of city council members and some bullets regarding the committees they serve on for board members to review prior to meeting

### Review Subcommittee Mandates

- City and state/federal subcommittees have sent mandates which are posted on website
  - $\circ$  Ad-hoc subcommittee still needs to submit mandates
  - Request to send subcommittee mandate document to board members
- Question raised about what happens to the subcommittees that have been eliminated such as outreach, cultural competency etc.
  - Concern that the city continues to implement these areas but I&R is not giving input since subcommittees have been eliminated

- Input that these areas are captured in new subcommittees
- RSJI must take the lead on these areas and continue to push this forward and I&R needs to also continue monitoring
  - Ad hoc subcommittee can potentially pick up these pieces

### **I&R Board History**

- Question about how long board has been in existence
  - January 2008 board was implemented
- Suggestion to have a celebration for the accomplishments of the board
  - o Request to resend board accomplishments compiled at retreat to board
  - Ask city staff to look into planning this (i.e. space, refreshments, invites) and get back to board
