#### 1. Welcome and Housekeeping/Approve September Minutes

Send photos of commissioners to them from OIRA Event No September Minutes – sorry! Jesus will give Sahar his written notes for September meeting.

#### 2. OIRA Report

Safe communities – Michael Neguse feels they haven't been doing a good job (poels). Jesus hasn't been contacted yet. Sahar will follow up with him.

Sahar email website. Put up rules around I and R commission.

Jesus says each new group changes the rules. Jesus would like to know to what extent will their voices be heard. Legislation doesn't have details. The people should be appointed regardless. Jesus's understanding is that it was left up to them to recommend and do out reach for new commissioners. Send them to mayor to appoint or not appoint. Is OIRA an equitable role with commission? Devon said they have been involved in resumes and interviewing since the office started.

Jesus and Yemane did their jobs and submitted to commission. How far do they want to go back?

Commission wants clarity on the process. From both council and mayor. Find out from Harrell.

Devon will contact "yes" people and send to the commission for charter schools. Can ethics write a formal piece on what commissions can do?

#### 3. Charter Schools

Melissa Westbrook –charter schools get public funds, operated by nonprofit. Only state to bring ballot, 3 times, 3 times said no. 41 states have them. WA doesn't fund our public schools to national average. How does bringing more underfunded schools when we have already struggling schools going to help? Lists supporters included in packet (see attachment). No language to address at-risk kids or transportation. No oversight by any elected official.

This initiative will do harm to the district. Legislature has passed in last two years two innovation school laws. Tacoma has closed achievement gap, it can be done. Ninth straight year WA is at top for SAT scores. We need to talk about fully funding. Family and Ed Levy will help, but we need to do more for our kids. Initiative doesn't have anything in it for at-risk kids, but it does have "conversion charter" – as

part of proposal they take petition to any existing public school and they can take over the school. Asking you to go out to your communities and talk about this.

Devon asked for clarification on "conversion charter." Melissa gave a response indicating that jurisdiction would be with district to decide. Most charter schools come from outside state. While nonprofit has to start out charter, they can contract out any service except operations.

Mohammad asked who drives the campaign for charter schools. Melissa responded that key funders are Bill Gates and Paul Allen and some other families from Microsoft and Amazon. Under this initiative – all charter schools get money from capital initiative, other schools go through different prioritization process.

Jesus asked what do you say to refugee or immigrant parent who feels the system already failed? Melissa responded that she has been working on this for 15 years. Working on the "World School." Because legislature has passed more innovation school laws there will be more schools that address special needs. She feels as though the community will be more disillusioned than ever. Doesn't want to minimize the community's experience. Some charters do very well with ELL students but the problem is that there aren't enough of them, they may not want the students that you are hoping to help. They consistently screen them out. Agrees that traditional schools have not done enough.

Maria asked how students are screened out of the process. Melissa responded that they might respond they can't afford certain luxuries. KIP does very well with African American students, but very strict discipline. Big attrition rate. For some kids it's too much.

Per Ethics suggestion, Devon will contact the Yes on 1240 people and ask them provide information in support of I 1240. Devon will email out both the Yes on 1240 and the No on 1240 information to the rest of the commission.
