## 021319.1 APPLICATIONS FOR CERTIFICATES OF DESIGN APPROVAL

Staff Report, Design: Ms. McAuliffe explained the application to install two weatherproof structures in outdoor seating area annually for the months of March, April and October. Exhibits reviewed included site plan, photos, and specifications for structures and lighting. Guidelines that applied to this application included 3.1, 3.4, 3.5, and 3.8.

DRC Report: Ms. McAuliffe said the committee cited 3.1, 3.4.3 f, 3.5.1, 3.8.7 and recommended approval, with discussion of the structures per 3.1.

## **Applicant Comment:**

Wilfried Boutillier explained adding the structures will be a way to use the space at a time when they wouldn't be able to otherwise. He sid it will be fun to try it as a novelty when the weather is inclement to see if it helps accommodate a longer span of use of outdoor space. He went over mock-up.

Ms. Vaughan asked if it will be furnished.

Mr. Boutillier said yes.

#### **Landlord Comment:**

Jessica Carlson, PDA, said it is a different approach and is a way to help them through the shoulder season. She said it is an attraction to activate the space. She said she was excited about the plan. She said there will be some tables and chairs; they will be moved around to accommodate the structure. She said there is a wood platform 'floor' with sandbags beneath to which tent is attached to secure it. She said lighting is adjustable; they will keep the warm look at 2700 Kelvin.

Ms. Vaughan asked about heat.

Mr. Boutillier said it is like a greenhouse. He said he has seen them used in Chicago – even in the winter.

Public Comment: There was no public comment.

## Commission Discussion:

Mr. Hale said DRC reviewed and discussed if it would fit the character of the Market. He said the committee noted that a weatherproof structure had been used outside the Desimone Bridge.

Ms. Rudeck asked about the proposed material.

Mr. Boutillier said it is real wicker.

Mr. Hale said the supports are metal, but that PVC would be OK, not preferred, but OK.

Mr. Ogliore cited 3.1.2 and asked how it maintains the character of the Market.

Mr. Hale said it has an unusual shape; the dome is different. He said it is a temporary use.

Ms. Vaughan asked if it is a success, the desire will be to continue its use so to make sure the character fits.

Mr. Boutillier said it will be used only in the shoulder season; they can fit more people with tables and chairs.

Ms. Vaughan said it is not contradictory to Market.

Mr. Hale said the expression of the structure is not trying to be something that it is not.

Mr. Hammond said that area is on its own so there is no competition with anything else; it won't interfere, especially at that time of year. He said it is an interesting idea.

Action: Mr. Hammond made a motion to adopt a resolution to approve the application as presented.
