## JOHN AKAMATSU

Mr. Akamatsu is a Capitol Hill native who practices commercial and residential architecture. He also served on the Seattle Opera Bravo Board and Three Dollar Bill Cinema Board. John advocates good, thoughtful design, and vibrant streets that attract pedestrian activity and citizens of all sorts.
