

Applicants sought to fill vacancies on the Swedish Medical Center Cherry Hill Campus Major Institution Master Plan Citizens Advisory Committee

The Seattle Department of Neighborhoods is seeking community members to fill four vacancies on the Swedish Medical Center Cherry Hill Campus Major Institution Master Plan Citizens Advisory Committee (CAC). This committee advises the city and Swedish Medical Center during the development of a new master plan to guide future development at the Cherry Hill campus (previously known as Providence Hospital). The CAC consists of representatives of the neighborhood surrounding Swedish Medical Center's Cherry Hill Campus, plus city residents at-large and users of the Medical Center.

The master plan will include the types and locations of new physical development at Swedish Medical Center's Cherry Hill Campus and establish guidelines for the design of future development on campus, a transportation management plan, and other actions to reduce the possible negative impacts of proposed development on the surrounding neighborhood. The advisory committee meets monthly. The process is likely to last about 12 additional months. More frequent meetings may at times be necessary.

Members are being sought for the following positions:

- Position #8 Person participating in broader planning or institutional development
- Position #9 A general neighbor residing within the Central Area Community who has some economic Development or general Development Experience
- Alternate #1 A near neighbor with land use, zoning and building development experience
- Alternate #3 General community/citywide representative with Architecture or Urban design background.

The near neighborhood is the area bounded by: 13th Ave, 21st Ave, mid-block between E Alder and E. Spruce Streets and mid-block between E Columbia and E. Marion Streets.

The Central Area Community is the area bounded by: 11th Avenue - essentially the boundary of the Seattle University Campus; 23rd Avenue; E Fir Street and E. Spring Street.

The city is committed to promoting diversity in the city's boards and commissions; so women, young persons, senior citizens, persons with disabilities, sexual and gender minorities, persons of color, and immigrants are highly encouraged to apply Employees of the City of Seattle, Swedish Medical Center or its development partner(s) are not eligible for these positions.

Those interested in being considered for any of the positions listed above should submit a letter or e-mail to the address below indicating their interest to serve and describing any special or unique qualifications they would bring to the CAC by 5 p.m., Monday, May 5th.
