

What is community planning?

Community planning is an opportunity for neighborhood stakeholders to come together to shape the future of an area of city—to ensure livable, healthy communities as Seattle grows and changes. The Office of Planning and Community Development (OPCD) initiates community planning processes with other departments, agencies and community members to:

- Work together to identify long-range visions, goals and policies for a neighborhood that are socially, economically and environmentally sustainable;
- Identify strategies for future community development to ensure that neighborhoods grow as envisioned in the City's Comprehensive Plan;
- Provide analysis and guidance on issues affecting neighborhoods in more detail than citywide or regional policies can address;
- Implement actions or coordinate investments in neighborhoods consistent with community visions.



Who is involved?

Everyone! Every voice in your community brings value. We strive to ensure that a broad cross section of stakeholders are involved, including traditionally underrepresented groups, and people who live, work, and visit the neighborhood. Some types of participants include:

- Community council or neighborhood organization
- Local business association
- Any individual resident or business owner or employee

- Social and racial justice organizations
- Renter or tenant-based organizations

Crown Hill Urban Village Community Planning

Background

The Crown Hill Urban Village (CHUV) is located in northeast Seattle, and has never had its own community plan. Through this planning effort, we will work with community towards developing a future vision for the CHUV and within the proposed urban village expansion.

This work builds on efforts already underway by community members and City departments including Seattle Department of Transportation and Seattle Public Utilities, and will strive to produce recommendations that address lasting and coordinated investments in the built environment with multiple community benefits.

Project Timeline & Phases
