#### 1 Approval of Minutes:

**March 16, 2017 PSCSC Meeting:** The Commission reviewed the minutes of the March 16, 2017 monthly meeting of the PSCSC. All Commissioners approved the minutes as written and they were signed by the Chair.

2 Request for Reconsideration-SFD Battalion Chief Oral Board Exam Protest Appeal: Captain Tim Munnis was present to request reconsideration of the Commission's July 2016 decision regarding the exam protest appeal from the June 2016 SFD Battalion Chief Oral Board Exam. Rick Verlinda,

retired Battalion Chief and Chair of the (exams) Development Committee was also present. At the July 14, 2016 meeting, Captain Munnis protested ratings from Boards A and C. At that meeting, the Commission granted unanimously the appeal to remove ratings 1-7 of Board A and Rating 3 of Board C and *denied* the appeal to remove the entire oral board and additional relief. Captain Munnis requested reconsideration at the March 16, 2017 meeting. The Commission tabled the Issue to allow time to review statistical data on Board A. The Commission reviewed an April 12, 2017 letter by SFD Chief Scoggins, stating he did not support a reconsideration of the matter and stated his concerns that it may "skew" testing results or, at minimum, create and appearance of unfairness or special treatment that could diminish employees' faith in the consistency of the
