



## Clean Cities Community Clean Teams Weekly Report

June 17, 2021

Reporting Week June 7 through June 13

### Week in Review

This week the community clean team focused on two large emphasis areas including Columbia Park and Jackson Park Golf Course, besides the various litter and trash pick-up locations citywide. 36 additional Clean Cities sites were completed by the Parks/SDOT Clean Cities Teams and 17 additional sites were completed by SDOT crews alone. The following summary includes Clean Cities work accomplished by Parks/SDOT Clean Cities Crews.

#### **By the Numbers:**

- 573 needles collected
- 6,000 lbs. of debris removed during the jamboree clean at Jackson Park Golf Course
- 54,890 lbs. trash collected via Community Clean Teams
- 3 blocks of litter pickup by SDOT crews
- 365 tents counted onsite
- 14.5 miles of vegetation management by SDOT crews
- 6 signs of graffiti cleaned

**Clean Cities Emphasis Areas**

- Columbia Park: 6/8. SC District hosted their jamboree at Columbia Park with 7 district staff supporting the project. The crew weeded, laid burlap, mulched shrub beds and tree rings. Picnic table pads and benched were line trimmed around the and edged. Litter was removed throughout the park. The district plan is to return later to plant flowers in the beds and at the Rainbow sign.

- Jackson Park Golf Course: 6/10. 5-Tents, 1-Structure, 200-Needles, 6,000lbs of debris. NE district hosted 7 other park districts and SDOT's Traffic Control Team with work along State Route 523 (SR 523, named NE

145th Street) between 5<sup>th</sup> Ave NE to 12 Ave NE. Crew members line trimmed, hedged trimmed, overgrown vegetation that encroached into the pedestrian sidewalk. Some trees were limbed up for safety.
