### **From I-5 Northbound**

- Take the SWIFT AVE. exit- exit number 161- towards ALBRO PLACE.
- Turn RIGHT onto SWIFT AVE S.
- Turn LEFT onto S EDDY ST.
- Turn LEFT onto BEACON AVE S.
- Turn RIGHT onto S COLUMBIAN WAY.
- Turn SLIGHT RIGHT onto S ALASKA ST.

### **From I-5 Southbound**

- Take the W SEATTLE BR/COLUMBIAN WAY exit- exit number 163A.
- Keep LEFT at the fork in the ramp.
- Merge onto COLUMBIAN WAY S.
- Turn SLIGHT RIGHT onto 15TH AVE S.
- Turn SLIGHT LEFT onto S COLUMBIAN WAY.
- Turn SLIGHT RIGHT onto S ALASKA ST.
