## **15th Ave NE Paving Project**

#### **PROJECT BACKGROUND**

The 15th Ave NE Paving Project will pave approximately 1.3 miles to make the road safer and more comfortable to travel on, and to extend the useful life of the pavement. This project also provides opportunities to cost-effectively update street designs to promote safety, and build features required in citywide transportation plans. Key elements include:

- Sidewalk repair and curb ramp upgrades
- Removal of peak-hour parking restrictions to make parking available 24/7 on 1 side of the street
- New protected bike lanes
- New exclusive left-turn lanes
- Stormwater drainage improvements
- Parking removal
- Safe Routes to School and neighborhood greenway crossing improvements at Roosevelt High School
