PROJECT BACKGROUND

Crossing improvements and public art are coming to Aurora Ave N! This project was requested by the community as part of the City's Neighborhood Street Fund (NSF) program. It includes a new street crossing at Aurora Ave N and N 92nd St, and using art to help create an identity for the Aurora-Licton Urban Village between N 85th St and N 105th St.

PROJECT ELEMENTS

- New signal on Aurora Ave N at N 92nd St for people walking and biking (see photo on reverse side)
- Modified curb ramps on Aurora Ave N at N 92nd St
- Median island on Aurora Ave N at N 92nd St
- Public art on Aurora Ave N

PROJECT BENEFITS

- Enhances safety for people crossing Aurora Ave N at N 92nd St
- Supports the Safe Routes to School connection between existing neighborhood greenway on Fremont Ave N and Robert Eagle Staff Middle School, Cascadia Elementary School, and Licton Springs K-8 east of Aurora Ave N
- Adds visual identity for the Aurora-Licton Urban Village

FUNDING

Funding comes from the 2015 voter-approved, 9-year Levy to Move Seattle, which will improve safety for all travelers, maintain streets and bridges, and invest in reliable, affordable travel options for a growing city. The levy includes \$24 million to continue the Neighborhood Street Fund program over the 9 years.

A panel of community leaderas, project staff, and local artists selected local artist Vicki Scuri to develop public art for Aurora Ave N between N 85th St and N 105th St.
