

RESTRICTED PARKING ZONE (RPZ) 19 EXPANSION

How permits work

On blocks with Zone 19 signs:

- Vehicles without permits can park for up to two hours from 7 AM to 7 PM weekdays.
- Vehicles with permits are exempt from the posted time limits.
- Parking is unrestricted overnight and on weekends.
- Permits are not valid on blocks with paid parking or time-limited blocks that do not say “Except by Zone 19 permit.” Some blocks have different designations on different parts of the block, so be sure to check the signs.



Permit eligibility

- Each household is eligible for up to four (4) decal permits and one (1) visitor/guest hangtag per address. For decal permits, the vehicle must be registered in your name and at your eligible address.
- The visitor hangtag allows your guest the same parking privileges as a decal permit.

Costs

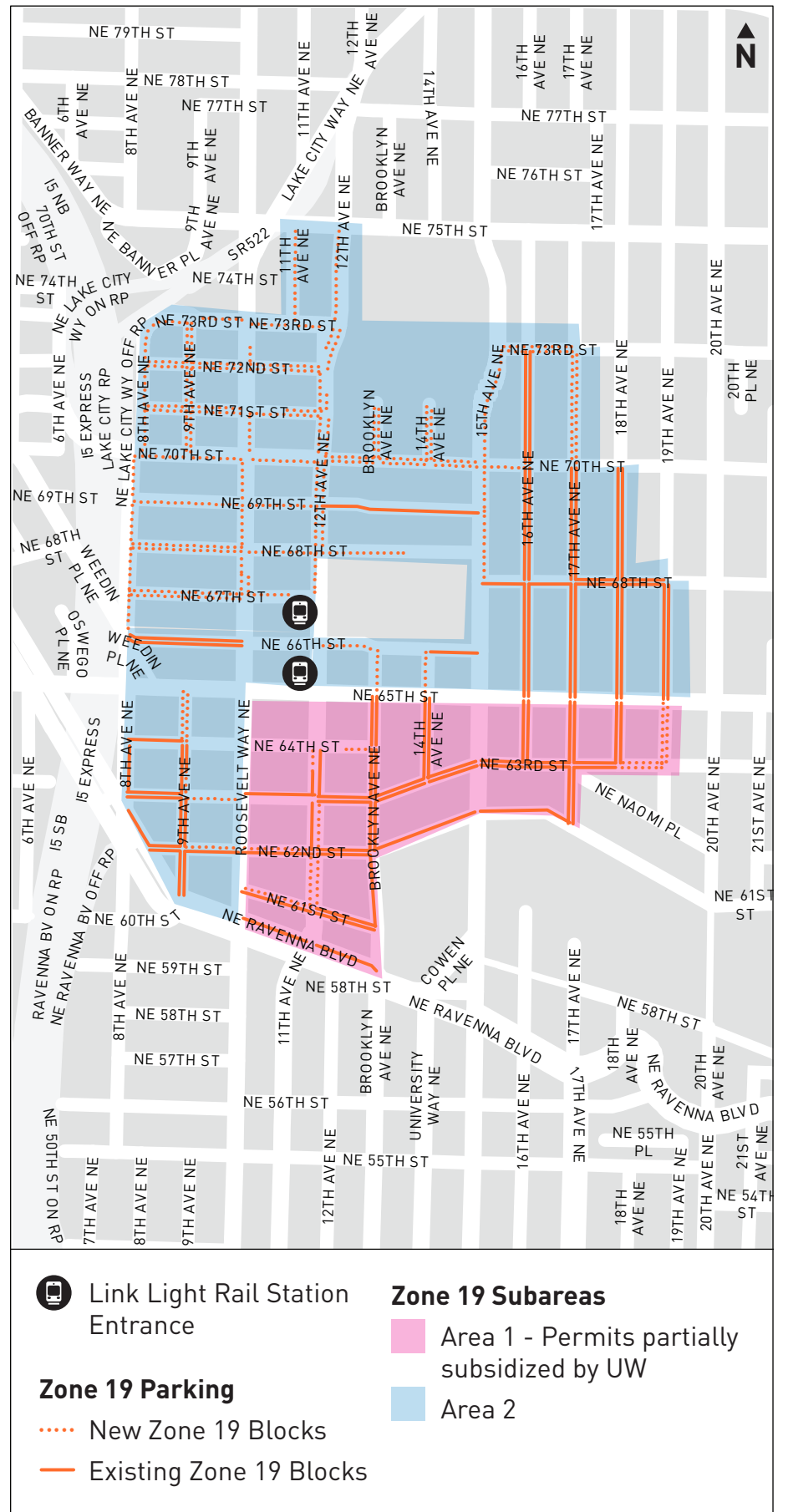
- Permits cost \$65 per vehicle decal. When purchased on the same application with a decal(s), the guest permit is \$30. If you purchase a guest permit only, it costs \$65.
- If you live in Area 1, east of Roosevelt Way NE AND south of NE 65th St, the University of Washington partially subsidizes your first permit and you will pay \$16 for that permit. See pink shaded area on map.
- An income-eligible permit is available for qualifying individuals at a cost of \$10.
- All Zone 19 permits expire April 30 of even-numbered years. Regardless of when purchased during the 2-year cycle, permit fees are not prorated.

How do I get a permit?

- To obtain RPZ permit(s), you must provide proof of residency and your vehicle must be registered in your name and at your RPZ-eligible address

Additional info

- Businesses and employees are not eligible for RPZ 19 permits.
- RPZ 19 signs are placed adjacent to ground floor residential uses.
- Once you receive your permit, you can use it on RPZ 19 blocks near your residence where signs already exist.
- If you have a disabled parking placard or plate, you do not need an RPZ permit to park on an RPZ-signed block.
- Property owners who do not live at their RPZ-eligible address can purchase one permit.
