

**SEPA DETERMINATION OF NON-SIGNIFICANCE (DNS)  
SEATTLE DEPARTMENT OF TRANSPORTATION (SDOT)  
GREENWOOD AVENUE N PEDESTRIAN IMPROVEMENTS PROJECT**

**Description of proposal:** The Seattle Department of Transportation (SDOT) proposes to construct a new sidewalk, planting strip, curb and gutter along the east side of Greenwood Avenue N, between N 145th and N 136th Streets, as well as a new pedestrian activated signal at N 137th Street. Other improvements include Americans with Disabilities Act-compliant curb ramps at each intersection in the project area and pedestrian signal improvements at N 143rd and N 145th Streets. Excavation would occur on private properties for sidewalk improvements. Pipes, inlets and a detention vault would be installed between N 143rd and N 137th Streets as part of drainage improvements.

**Location of proposal including street address, if any:** The project would extend along Greenwood Avenue N from N 145th Street to N 136th Street in the Bitter Lake/Broadview neighborhoods.

**Lead Agency:** SDOT

This decision was made after review of a completed environmental checklist and other information on file with the lead agency.
