#### **VENDING PERMITS**

The City of Seattle encourages street-food vending to increase public use, enjoyment, and safety of our public right-of-way. With proper design and management, street-food vending can be a great way to encourage walking, add vitality to the street, and promote local economic development. Street Use vending permit applications may be submitted at the SDOT Permit Counter on the 23rd floor of the Seattle Municipal Tower at 700 5th Avenue.

Description	Vending of food from a food vehicle is allowed in curb spaces only with a valid curb space vending permit. It is issued for daytime (6 AM – 8 PM) or nighttime (8 PM – 6 AM) use.	Vending of food or flowers from a vending cart is allowed on a public sidewalk or plaza with a valid sidewalk or plaza vending permit. It is issued for daytime (6 AM – 8 PM) or nighttime (8 PM – 6 AM) use.	A vendor may vend food or merchandise from an approved site during stadium events.	Food trucks parked on the street may also be permitted to vend at private or public events through a temporary curb space vending permit. Fees are charged fees per day.	Mobile food vending includes selling flowers, food, and beverages from mobile units on public streets, sidewalks and plazas. This does not apply to food vehicles located in the curb space.
