#### Indemnification

The permit holder agrees to defend, indemnify, and hold harmless the City of Seattle, its officials, officers, employees, and agents against: (1) any liability, claims, causes of action, judgments, or expenses, including reasonable attorney fees, resulting directly or indirectly from any act or omission of any permit holder, anyone directly or indirectly employed by them, and anyone for whose acts or omissions they may be liable, arising out of the permit holder's use of the public right-of-way; and (2) all loss by the failure of the permit holder to fully or adequately perform, in any respect, all authorizations or obligations under the permit.

### Acceptance of terms, conditions, and requirements

The permit holder shall accept the terms, conditions, and requirements of the permit and agree to comply with them to the satisfaction of the Seattle Department of Transportation, Traffic Management Division. The permit holder further agrees to comply with all applicable city ordinances, including but not limited to Title 11 SMC, and all applicable requirements of state and federal law.
