### 1. Welcome & Introductions

### 2. Getting to Know You Breakouts

SWAC members, guests and staff were placed into breakout rooms for icebreakers to get to know each other.

### 3. SPU's Solid Waste Framework

• Jeff Fowler shared a presentation which highlighted our four focus areas: Delivering Equitable Essential Services, Stewarding Environment and Health, Empower Our Customers, Community, and Employees, Strengthening Our Utility's Business Practices

- **A SWAC member asked** "In the Metrics box (Focus Area: Empowering Our Customers, community, and Employees), does the customer satisfaction rating come from the commercial customer survey?
- A SWAC member asked, "Are there plans to develop metrics for a few of the strategies & actions that don't have metrics associated with them currently like the action to explore innovative ways to collect/managed difficult materials and the action to enforce all solid waste codes equitably?"
- A SWAC member asked, "Is there already available data for the listed metrics?"
- **A SWAC member asked**, "How were the metrics numbers determined?"
- Jeff Fowler confirmed to the SWAC that these questions were being captured by Jemini. Jeff will work with Solid Waste staff to provide updates on each question.
- SWAC members were placed into breakout discussions to discuss the presentation. Guests were invited to observe the discussions.

## 4. 2020 Waste Prevention & Recycling Report

- Stephanie Schwenger shared a 2020 Waste Prevention & Recycling Report Presentation which shared the preliminary results for waste generation, recycling and composting, and disposal tonnage in 2020.
  - **A SWAC member asked**, "Is C&D considered a divert in this report?
  - Stephanie responded: Yes, it is.
  - **A SWAC member asked**, "Do you have a sense whether the numbers in this report will drive things up or down?"
  - Stephanie responded: We think it will drive things up if we can confirm the numbers that were reported are for Seattle only
  - **A SWAC member asked**, "Between single-use plastic carryout bags, paper carryout bags, thick reusable plastic carryout bags and green or brown compostable bags, is there a particular one the city advocates for?"
  - Sego responded: We would support bringing your own bag as the number one option
  - **A SWAC member asked**, "Did SPU do anything differently this year to get high numbers from commercial companies reporting?
  - Stephanie responded: Yes, we partnered up with Finance and Administrative Services since they can enforce fines for non-compliance.
