1. Regular Business

A SWAC member asked: "Is there a requirement for public comment?"

SPU Response: "No, it will be looped in with the Solid Waste Comprehensive Plan."

3. Solid Waste LOB Updates

- CROP
 - Just want to congrats Socorro on her hard work to pull the CROP together and how well it has come together. She has worked with the entire SWLOB to ensure it stays on track so a draft can be shared with Ecology soon.
 - o Ultimately, it will be incorporated into the SW Plan Update
- 2022 Budget Development
 - Busy over the last month developing our 2022 Budget Proposal, which will be reviewed and finalized by E-team, before sending to the MO for review and approval.
 - o Final budget adoption occurs by Council around Thanksgiving time in November.
- Surveys
 - Commercial Customer Satisfaction Survey is in the finalization stage and will be fielded in June.
- Special Item Collection
 - Staff is working on improving MF and UDP customer access to special item
 collection currently and will be reviewing other potential SPU enhancements later in year

4. Legislative Updates

Sego reviewed a number of bills that passed the legislature and have been signed by the Governor, or that are ready for his signature in the next several weeks. All the bills discussed, and more, are summarized at Zero Waste Washington's legislative page. Legislative Work - Zero Waste Washington

- SB 5022: SPU was particularly engaged in development and advocacy for SB 5022 The bill:
 - Bans Expanded Polystyrene Foam foodservice products, including foam cups and takeout containers, expanding Seattle's 2009 ban on these products to statewide.
 - Requires food service businesses to only provide straws, utensils, and other single
 use food service items on customer request only. This complements Seattle's
 existing ordinance and rules that ban plastic straws and utensils.
 - Removes the confusing requirement that the "chasing arrow" be included in plastic resin codes used on plastic packaging. The code is still required, but without the recycling symbol.
 - Establishes post-consumer recycled content for a range of plastic products and packaging sold in Washington, including plastic waste/trash bags, beverage containers, and other products.

- Organics Budget Proviso: SPU Solid Waste proposed text for a successful budget proviso to address carbon sequestration in soil from compost and other organic amendments. Results of work by WSU could set the stage for vastly increasing markets for compost through inclusion in carbon markets and trading.
- **HB 1145:** SPU has concerns about this bill that passed and has been signed by the Governor. It allows wheat straw waste to be used to meet a portion or all of the 40% post-consumer recycled content requirement for paper carryout bag in Seattle's existing bag ordinance (now preempted) and in the state's new bag law. This erodes the intent which is to create market pull for paper we collect for recycling. This could be a "slippery slope" as we anticipate other special interests will also want their materials to be included in the future: bamboo, hemp, corn waste, sugar cane waste, etc.
