The Seattle Pedestrian Advisory Board would like to express its support of the efforts that the Friends for a Greater Maple Leaf Park Subcommittee have taken regarding the construction of the Maple Leaf Park. Specifically, we support the design elements that call for the completion of the sidewalks located along the perimeter of the park, completion of lighting around the main walkways and paths located within the park, marked crosswalks complete with ramps that lead to the park entries and appropriate signage that promotes way finding. In order for this park to achieve the status of a vibrant attribute to not only the Maple Leaf neighborhood, but also the City of Seattle, these designs elements need to be supported to allow access for everyone.

Sidewalks are a key component of Seattle's walkable system that helps identify where pedestrians can travel. Currently, Maple Leaf Park does not have a complete sidewalk system from the south end of 14th street to the east side of 85th street. This missing link of the pathway prevents access for all members of the community; especially those that require accessibility identified by the Americans with Disabilities Act (ADA) and therefore needs to be completed in order to provide full access to the park. In addition, crosswalks and curb ramps will need to be added to allow for safe passage to the park's main entry points located on Roosevelt. Finally, lighting upgrades throughout the park and way finding signage, that is ADA compliant, will create a much safer environment for all visitors that use the park facilities by providing information and deterring criminal activity. These design elements support the stated goals of the Pedestrian Master Plan of **Safety**, **Equity, Vibrancy** and **Health**.

The City of Seattle offers its residents a unique experience of lush parks located within an urban setting. These shared resources help to foster community by providing a safe and welcoming place for individuals and families to come and interact with one another. In order for all residents to be able to experience the full benefit that comes with living in this city, accessibility to parks such as the Maple Leaf Park is essential. The Seattle Pedestrian Advisory Board applauds the efforts being made by the Friends for a Greater Maple Leaf Park Subcommittee and looks forward to the completion of this project as it incorporates the improvements mentioned in this letter.
