There will also be workshops in the Othello, Rainier Beach, and South Park neighborhoods next year – exact dates are TBD.

Urban Village is a term used to describe parts of Seattle that have more people living there, businesses, and public transit options – in other words, greater density.

As part of Seattle's plan to address housing affordability (<u>HALA</u>), there are some proposed changes to Urban Villages. Some of these would allow buildings to be taller, in exchange for developers to pay into a fund that would provide affordable housing (<u>Mandatory Housing Affordability</u>). Neighbors have a lot of opinions about these changes, and these design workshops aim to invite discussion around those opinions.

Spencer invited you all to attend and participate in these workshops. He has also offered to come back and let us know what they've heard in these workshops. There is also a great

Discussion with Seattle Police Department's Sgt. Adrian Diaz and Det. Cookie

We had an opportunity to hear from Detective Cookie about strategies that she uses to build trust between police and youth. She facilitates the GREAT program (Gang Resistance Education and Training) for 5th graders and for 8th graders. She also runs a chess club at several locations in South Seattle as a way to talk about choices. Both Sgt. Adrian Diaz and Det. Cookie stayed to talk more in depth with the Public Safety Sub-Committee.
