Date(s):	Sunday, August 25, 2019
Location:	11 th Ave between E Pine St and E Union St
Organizer(s):	Natalie Curtis

Event Notes:

- Event organizer not present
- One day event from 11am 9pm
- Quick set up and closure of 2 blocks of 11th Ave between Pike and Pine and Pike and Union
- Understanding that it was a similar closure for the SDOT Pike People Street program, but since that program is not active in 2019, organizer is requesting their own closure
- Idea is to close street and clear parking to activate street with food trucks and vendors

Committee Discussion:

- The anticipated attendance is a concern since requesting a 2-block closure
- The map doesn't show it, but there are 3-4 driveways that need access, SDOT will need to see notification and mitigation of traffic impacts and garage access
- Is attendance accurate?
- It is a lot of parking that they are requesting; Impact to the neighborhood is a concern since very dense neighborhood
- SPD East Precinct will be able to monitor with resources; No issues with it
- SDOT suggesting maybe organizer could reduce footprint to have one block closure in front of businesses participating (between Pine and Pike); 2 parking lots impacted in this block closure
- Chair Not hearing approval, there is a lot more information that needs to come from organizers which includes participation, benefit to neighborhood, footprint and see if organizers are willing to reduce, and outreach plan; Committee will not approve without this

Event:	Chinatown International District Block Party	
Date(s):	Saturday, August 3, 2019	
Location: Private property at 900 S King St		
Organizer(s):	Tuyen Kim Than, Sonny Nguyen	

Event Notes:

- Event produced in 2016; A lot smaller so didn't need a Special Events Permit
- CID Block Party is opportunity to showcase Asian American talent
- Event will take place at 900 S King St underneath the I-5 underpass in the private parking lot
- No street closures and minimum pedestrian impact
- Organizers wanted to increase pedestrian impact and show that the underpass is a place to see and activate
- No signed notifications, organizers have talked to adjacent businesses and they agree or partnering with event
- Truck stages used; In 2016, sound didn't get too loud but had some issues with cars parked closely to the stage
- Boozy Boba beer garden run by the Eastern Café; Eastern Café will do all of the fencing and appropriate things to make sure beer garden follows guidelines; Bar is also a block away so if there are issues, they will activate bar as alcohol service
- Anticipating 300 people
- WSDOT land which is leased to Interim Parking Services

Committee Discussion:

DON – Did a great job with notification to the businesses, sees event will be very inclusive of community; Good with notification plan; Organizer sends out weekly newsletter for Chinatown and adds the event; Organizer will continue with notifications

SDOT – No issues, off street and no parking requested

SPD – Lt. Williams – Seafair Hydro weekend, west precinct said given the alcohol sales and proximity to I-5 corridor, they would like to staff and will touch base with the staffing; Joel will touch base with precinct and get back to organizer

WSLCB – Prior event didn't have alcohol service; Will need Special Occasion License, application needs 45 days for the event; Non-profit is Seattle Chinatown International District Preservation Development Authority (SCIDpda); Participating businesses will need extended service to participate; Organizers responsible for staffing to make sure safety and security, no over service, and ID checks Parks – Great place to see activated since it is an interesting area

FMO – Will need to see maps for the beer garden and to assign occupancy load; Will need to know names of the food vendors, dimensions of the beer garden; The occupancy load will be determined with the dimension map

SDCI – keep it at a reasonable level, amplified sound is cutting off at 10pm, so no TNV needed

Event:	Cycle the WAVE
Date(s):	Saturday, September 7, 2019
Location:	Gas Works Park and Lake Union Loop
Organizer(s):	Ariana Orford

Event Notes:

- 12th annual year but first year in Seattle; Historically held in Bellevue
- Foundation founded in 2011, event started in 2008; Funds programs that work to address issues with domestic and sexual violence; Funds going to prevention organizations

- Event held at Bellevue college, but decided to bring to Seattle; Looking to provide more community involvement
- 10am 12pm participants cycling and walking event; No competition, more family friendly event
- Cyclists have option of 6 or 18 miles
- Using rules of the road; Highlighted areas for safety monitors and asking if needing SPD officers at some of the heavily used intersections
- Ride with GCS to draw the exact route for cyclists; There is a que sheet for cyclists that they can follow
- Capping at 400 cyclist; Usually 900 cyclists cap
- Only experienced cyclists and cyclists will need to provide their own bikes
- In addition, there will be a 3 mile walking route for participants that are not cycling
- Walking route will be on the Burke Gilman Trail; 3 mile walk that goes up and down the Burke
- Anticipating about 100 participants; New aspect to event, could have run on the route too, as long as if not timed
- 12pm 2pm Community festival at Gas Works Park
- Beer garden, area for vendors, entertainment and food at Gas Works Park; Beer garden opening at 12pm; Breweries are sponsoring the service
- Hiring DJ company to do all of the music
- Looking to have capacity and entrance and exit plans for beer garden, Kids play area is planned inside Gas Works Park play area
- Usually just the cycling activity, this year trial for the community festival; Seeing if people will stick around and have lunch

Committee Discussion:

DON – Notifications needs to be done to all the residential and business neighbors; Go beyond the 1 block radius to help everyone know about the event; Notification is outlined in the packet; No official sign off since no street closure; Give notification to community and neighborhood stakeholders

SDOT – Riders and walkers are both crossing Northlake way; In the past, there was a control signal with monitors, there are crosswalks, but also very busy intersection; Run will be ok as long as not timed; Trail will be heavily used so will need to keep that in mind; Fairview bridge is still open; Notification will need to be done – Obliteride and Lake Union 10k in August, so neighbors will be feeling some fatigue; SDOT will notify bridge tenders, organizers will need to notify riders that bridges will be going up

SPOC – North precinct for the park activity; SPD will need to take a look to see if traffic will need to be assigned to help event along the way

SPD Traffic – Capping at 400 cyclists; They have a rolling start – show up, get packet and start the ride; When cyclists sign up for event, can either sign up for 1 loop or 3 loop; Family event so will have more children at community festival and on the walk; Not many cycling; Organizer will have monitors in the larger intersections; Open to suggestions for what SPD suggests; Monitor in the south near Lake Union Park for a water stop and check in; Monitors should know that they can't override any intersections and are not authorized to do so; 3 areas that could see need for SPD support are Northlake way on the path, Stone Way and at the South end near Lake Union Park near street car; Organizers had no police staffing for events happening before, always on paths and rules of the roads; Many volunteers that follow the participants to monitor the cyclists and the

WSLCB – There will be a lot of people in the park at that time, make sure there are enough staffing for safety and security; Special Occasion license 45 days prior to event, organizer will have event planner will help with vendors and licensing

Parks – Keep path available through Gas Works Park; Portable restrooms will want inside of the park and not in the parking spaces, if any ADA needs, restrooms are ADA compliant so can use restrooms in the park; No real concerns, gravel path to get into the park; Parking is first come first serve, if organizers need parking for infrastructure, then can look at a few stalls, will not approve VIP parking; Carl need to check if electricity is

requested at park, if electricity is requested, it will come in the NE corner in the fence; Parks will connect organizers and electricians; Amplified sound aimed towards the towers; Coming to the water station, don't want on LUP, there is another event at LUP that day, so should stay on the path; If bringing in a sponsor, then will change the banner fees, there will be some different fees for signage that are promotional/marketing; Send request to Parks to amend timing for clean up

SFD – Right now with one entrance and exit, the occupancy load is 49; For 30x30 minus tables and bar dimensions, can determine occupancy load; Beer garden participants will need to remain in the beer garden, entrance and exits cannot be on same side; Requesting an updated map

Will need to have vendors list and if they are using open flame then will need to send over to review **SDCI Noise**– Anything after 9am is ok out there

Chair – Organizer should contact FAS to see if need to pay admission tax

SPD Traffic – 1 sgt and 6 officers for the 3 locations that identified – just for traffic control; There will be some security volunteers to checking ID, open for security personnel in lieu of SPD officers

Date(s):	Saturday – Sunday, September 14-15, 2019
Location:	NE 72nd St between East Green Lake Drive N and 5th Ave NE; and Woodlawn Ave N
	between NE Maple Leaf Pl
	and NE 71st St
Organizer(s):	Brian Oster

Event Notes:

- First year of event, but event has been in the works for the past couple of years by the Green Lake Chamber
- Green Lake Chamber exists to promote businesses and get community engaged; Promote community engagement with other communities
- Concept is what you would expect, but smaller scale
- 2-day event; Footprint will be 4 city blocks off of Green Lake Drive
- 21+ event; Alcohol service, just beer sticking with local craft breweries
- Some craft breweries will be putting together some specialty beers
- Tasting of beer will be available; Will want to engage the community, so sampling the brews and moving on to other businesses
- Some food trucks and food vendor trucks
- Everything will be fenced in
- Organizer can provide more detailed maps within the next week; Keeping set up simple, no tents over 400 ft
- No big beer hall in the side of the street
- 72nd is near the Shelter and the Lunchbox Lab; Activation will go up to Woodland; Woodland will be closed in 1 block in each direction
- School is right there, talking to them to utilize parking lot

Committee Discussion:

Chair – 21+ gated and ticketed; Organizers trying to get businesses to offer a discount to get participants into the restaurants; Businesses in the area will serve their own liquor, no extended service or outside service; No alcohol outside the fence line; Main entrance will be on Woodland; The sidewalks will be open, if outside the venue, will still be able to access the local businesses; Working on buyoff from all of the businesses; Working with Green Lake Chamber; Notification ready to go and will include a map **DON** – A lot of businesses and residents in the area; DON will require door-to door notification with

signatures, 60-day and 30-day notification plan; Couple of churches that are within a few blocks, they will need to be notified; Green Lake Chamber and Foodworks are beneficiary – for volunteers and staffing; A lot of the businesses are a part of the chamber

SDOT – Briefly talked about turnaround time and notification; Woodland is an arterial street and a bus line; Metro would like to keep Woodland open longer on Friday until 5pm, for Saturday and Sunday, Metro will re-route to route 26; Organizer knows the school is right there and they have pick up and drop off in the area on Friday and will push timeline back so they don't interfere; Any detours to the north, will need to take a look at the detours; Will need to no-park both sides; Notifications to any driveway access and will need plan on how will maintain or get signoff for closure of the garages; Alley near Rosita's very crowed, will need to notify

SPOC - SPD will be reviewing event next Tuesday to go over safety and security impacts

SPD – Didn't ask for SPD staffing, using Landmark for staffing inside the event; Looking to bring in off duty support for inside; Looking for feedback on number of off duty officers may be needed; SPD will have north precinct look at requested event and then will see if they want to provide staffing

WSLCB – 21+ event, nonprofit will be Green Lake Chamber of Commerce; Sizes of the services will be 5 ounces will be sold; Wristband system for tickets + tokens for drinking, and designated driver wristband; For tickets and tokens, LCB will want a designated number of drinks per ticket – 1 ticket and have 2 drinks Parks – Regatta going on in the Park; If the event were to grow, the event will need to grow into the street, it won't be able to grow into the Parks

SFD – Will need access to the fire lanes, the vendor set ups can't block the SDC for the buildings, New Maps will reflect the fire lane; Will also need a list of food vendors; Requesting dimensional map
 SDCI Noise – Need to see speaker layout and where placed; TNV needed

- Port valet available to passengers to help with the congestion of the City; Luggage transferred to your airline at the end of the cruise; Passenger checks in luggage on the ship, then is able to disembark in Seattle
- Homeport Cruise Lines
 - o Norwegian
 - o Royal Caribbean Celebrity
 - o Holland America
 - o Princess
 - o Carnival
 - o Oceania
- Home port ship, means passengers aboard the ship and then come back and disembark a week later
- Pier 66 accommodates 1 ship and Terminal 99 accommodates 2 ships
- Every day except for Wednesday and Thursday
- 11 different ships will come into Seattle
- Looking at building a new terminal at Pier 46 that will accommodate 1 ship
- Expect over 1.2 million passengers to go through terminals in 2019
- Norwegian Joy ship is getting larger and larger; This ship comes Saturday and Sunday 5,000 passenger capacity
- Ovation of the Seas operate out of Terminal 9q and carries about 5,000;
- 9,350 guess coming from Saturday Sunday; Out on the streets and to Seattle; Some stay for a day or 2, some just go to the airport; Increase in hotel shuttle activity and TNC
- Pier 91 has a TNC hub, can pull in and have number for the car loading zone
- 15, 500 guess coming through the terminal with Ovation and Summer Solstice
- Economic impact

- o \$893.6M revenue to local businesses
- 5,500 total jobs related to cruise
- \$4.2M in regional economic activity per vessel call
- o \$1,547 average non-resident per passenger spending in Seattle
- o \$14.5M Contributed in state taxes per year
- For homeport cruise days, there is a new pullout lane on Alaskan Way that helps to get out of the lane of traffic; Busy times you'll see a crunch of cars, trucks, TNC
- Typical Homeport Cruise Day
 - o 6am ship arrives
 - o 7am provisioning
 - 7:30 10am Disembarkation of passengers
 - 11am 3pm Embarkation of passengers; 11:30am 1pm rush of passengers to terminal
 - o 4-5pm Ship Departure
- 20-30 provisioning trucks per ship; Some are going from P66 to T91; Each ship takes about 20 -30 throughout the day
- Working with the State and City during the Alaskan way demo; If passenger get stuck in traffic, then will delay schedule, there were some people that missed the ship when there are other events happening in town
- 2018 Rock 'n' Roll Marathon (RNR) proposed to close Elliott at the height of the provision load-in; RNR provided access plan for the Port
- Proposed Pier 46 terminal
 - Take 1/3 of cargo facility and turn into a cruise terminal (North end of the terminal); Requesting for partnership for development of terminal
 - o Looking at 2023 to open the terminal
 - o Currently within the RFP process
 - Still very early, but no information about transportation
 - Will be able to get people off of the street to help deal with the traffic
- As committee considers large events, it is important to consider and partner with Port for impacts to the cruise terminals

- If traveling from I-5 (North or South), take exit 167, Mercer Street/ Seattle Center.
 Continue west on Mercer Street
- For Terminal 91, continue west and turn right onto Elliott Ave W. Follow signs to reach Terminal 91.
- From Mercer, turn left on 5th Ave or from westbound Denny Way, make a slight right onto Broad St.
- Continue on Broad St.
- Continue slightly left onto Alaskan Way to reach Ferries/Piers 69 and 66.
