想要一张ORCA卡吗？

如果你不符合Seattle Public Schools配发的ORCA卡的条件，你仍然可能有资格通过City of Seattle ORCA Opportunity计划办理。此类ORCA卡能够改善学生的出行状况，无需步行或乘坐付费交通上学。

通过此计划办理的ORCA卡有效期为2019年9月至2020年8月。收入要求与许多其他类似计划相同，如SNAP、免费和补贴午餐和ORCA LIFT等。ORCA卡可在King County Metro、King County Water Taxi、Seattle Streetcar、Sound Transit、Community Transit、Pierce Transit、Kitsap Transit和Everett Transit系统中使用。

其他符合资格的情况

接受特殊交通的学生均可通过ORCA Opportunity计划办理ORCA卡。

其他可能符合资格的情况将根据具体申请进行评估。咨询可发送至ORCAOpportunity@seattle.gov。

办理方法

去年已注册的学生无需再次申请，计划中的学生会自动重新注册。

新的申请人需填写申请表，并由家长或法定监护人签名。18周岁以上的学生不需家长或法定监护人签名。
