- Provide design & construction direction for private and public development projects.




### What We Do

- Oversee design and construction of SDOT Major Projects and Capital Improvement Projects.
- Provide public information through outreach and education.
- By administering, maintaining, protecting, and expanding Seattle's urban landscape in the street right-of-way, we maximize economic, environmental, safety and aesthetic benefits for the public.



## Move Seattle Levy

- \$930M transportation funding beginning 2016
- 30% of Seattle's transportation budget
- Maintained previous funding for street trees
- Added \$5.4M street tree maintenance funding (over 9 years)



## MOVE Seattle Levy Goals and Accomplishments 2018

 We exceeded the annual target for most deliverables. SDOT Urban Forestry continuously plants 2018 and 2019 levy delivered street trees throughout the winter as it is the ideal time to plant trees for optimal survival. Both 2018 and 2019 tree planting goals will be met by the end of April 2019. In addition to these levy deliverables, Urban Forestry crews plant trees in support of Seattle City Light Urban Tree Replacement and Safe Routes to School programs.

- Residential point of contact




# Urban Forestry Operations


- Tree, Landscape and Irrigation Maintenance
- 40,000+ street trees, 50+ irrigation systems,
   120+ acres of landscapes
- Street tree and landscape maintenance (pruning, planting, specialty tree maintenance)
- Customer Service related to SDOT owned trees
- Emergency Response including windstorms, snow and ice, and encampments
- Irrigation maintenance, winterization, emergency response
- Volunteer support



9-year Street Tree Management Plan (STMP)

- Funded 2016 2024
- 27 management units
  - City council districts divided along
     U.S. Census tracts
- Emphasize 3 units annually
