Any Property Owner seeking a new connection to Seattle's water supply system or to change an existing water service must fill out a Water Service Application.

### PREPARE A COMPLETE APPLICATION

- Obtain a valid Water Availability Certificate (WAC). See <u>Client Assistance Memo (CAM) 1201</u>.
- Complete this Water Service Application. If you have additional water services, typically associated with a short plat or unit lot subdivision, complete a <u>Request for Additional Water Services Addendum</u> for each assigned parcel address.
- Provide a site plan that meets the requirements of <u>CAM 1202</u>.
- Obtain a Seattle Department of Transportation (SDOT) 51M Street Use Permit or Street Improvement Permit (SIP) for work in the public Right-of-Way (ROW). If outside of Seattle, contact your local jurisdiction for paving restoration requirements.
