



## Seattle-King County Taxicab Advisory Commission

The Seattle-King County Taxicab Advisory Commission was established in 2010 to improve the industry for customers, taxicab owners and drivers by studying, making recommendations and issuing an annual report to local lawmakers (specifically, the City and County Councils, Mayor and Executive) in the following areas:

- Customer service;
- Governmental taxicab regulations;
- Administrative rules;
- The City of Seattle and King County taxicab codes and legislation affecting the taxicab industry;
- Taxicab fares;
- Taxicab licensing;
- Availability of taxicab service in Seattle and King County; and
- Evaluating current taxicab regulations, including making recommendations to each jurisdiction's respective executive and legislative bodies.

The Commission is comprised of eleven members:

- Three representing taxicab license owners (positions #1, #2, and #10);
- Three representing taxicab drivers but not license owners, and who have not been an owner within the previous five years (positions #3, #4, and #9);
- Three representing the hospitality and/or tourism industry and medical facilities as clients of taxicabs (Positions #5, #6, and #11);
- One representing persons with disabilities (position #8); and
- One representing senior citizens over the age of 60 (position #7)

Individuals shall be appointed to a specific numbered position. Members in odd numbered positions (1, 3, 5, 7, and 9) shall be appointed by Seattle. Individuals in even numbered positions (2, 4, 6, 8, and 10) shall be appointed by King County. Of Seattle's five appointed positions, three (3) shall be appointed by resolution of the City Council and two (2) shall be appointed by the Executive. Position eleven shall be appointed by the Commission itself.

For the initial round of appointments the positions will be staggered: one, two and five shall serve one-year terms, three, four, nine, and ten shall serve two-year terms, and six, seven, eight, and eleven shall serve three-year terms.

At the conclusion of the initial term of each appointment, all subsequent terms of each position shall be for three years and the term of 1/3 of the positions shall expire each year. A commission member whose term has expired shall continue to hold office until a successor has been appointed by the appropriate body. No members shall serve more than two consecutive terms. Any vacancy for an unexpired term shall be filled in the same manner as for an original appointment under this section.

Members serve without compensation. Interested applicants for the City of Seattle must either work or live in the City of Seattle for the City appointments.
