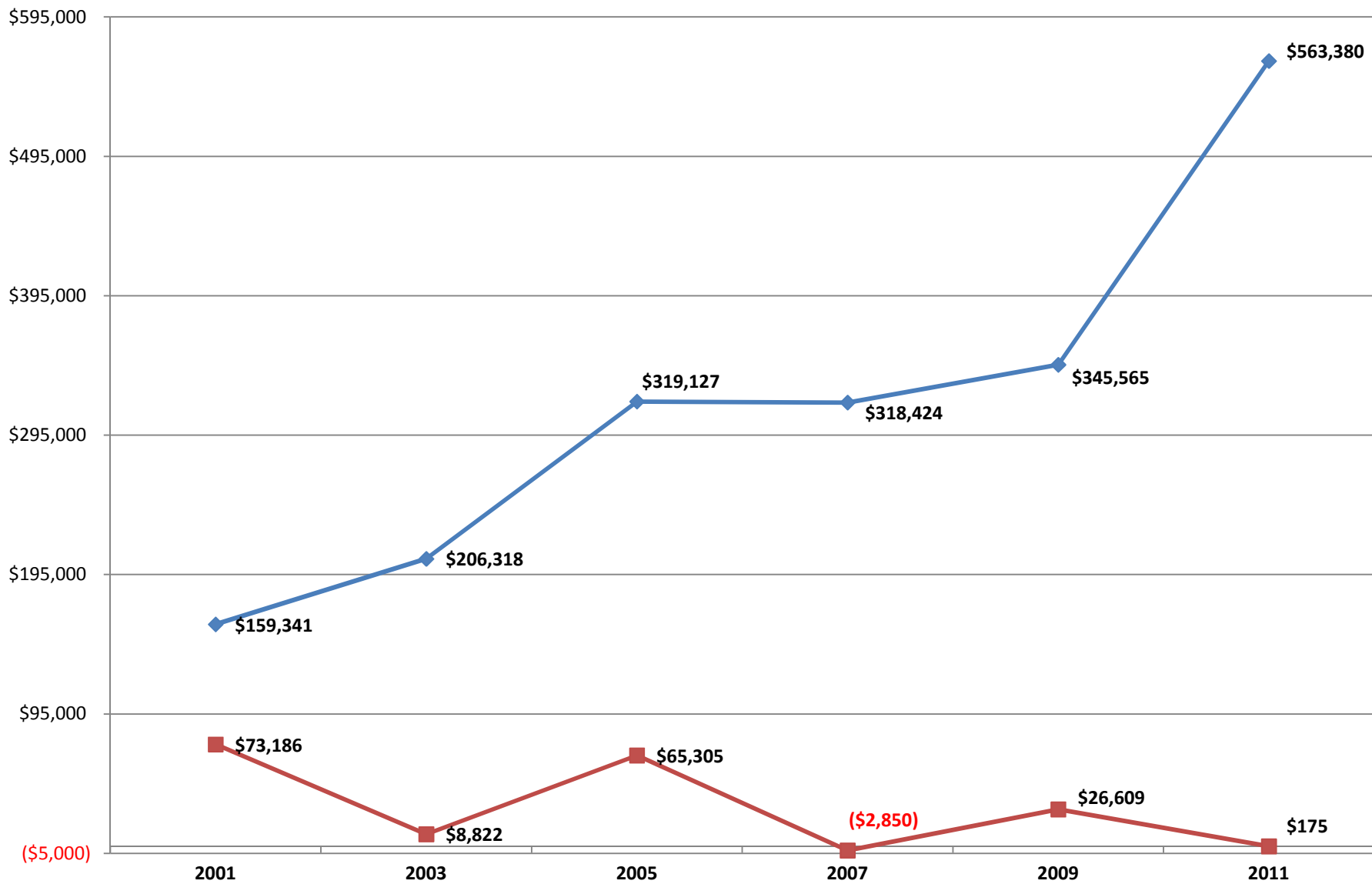

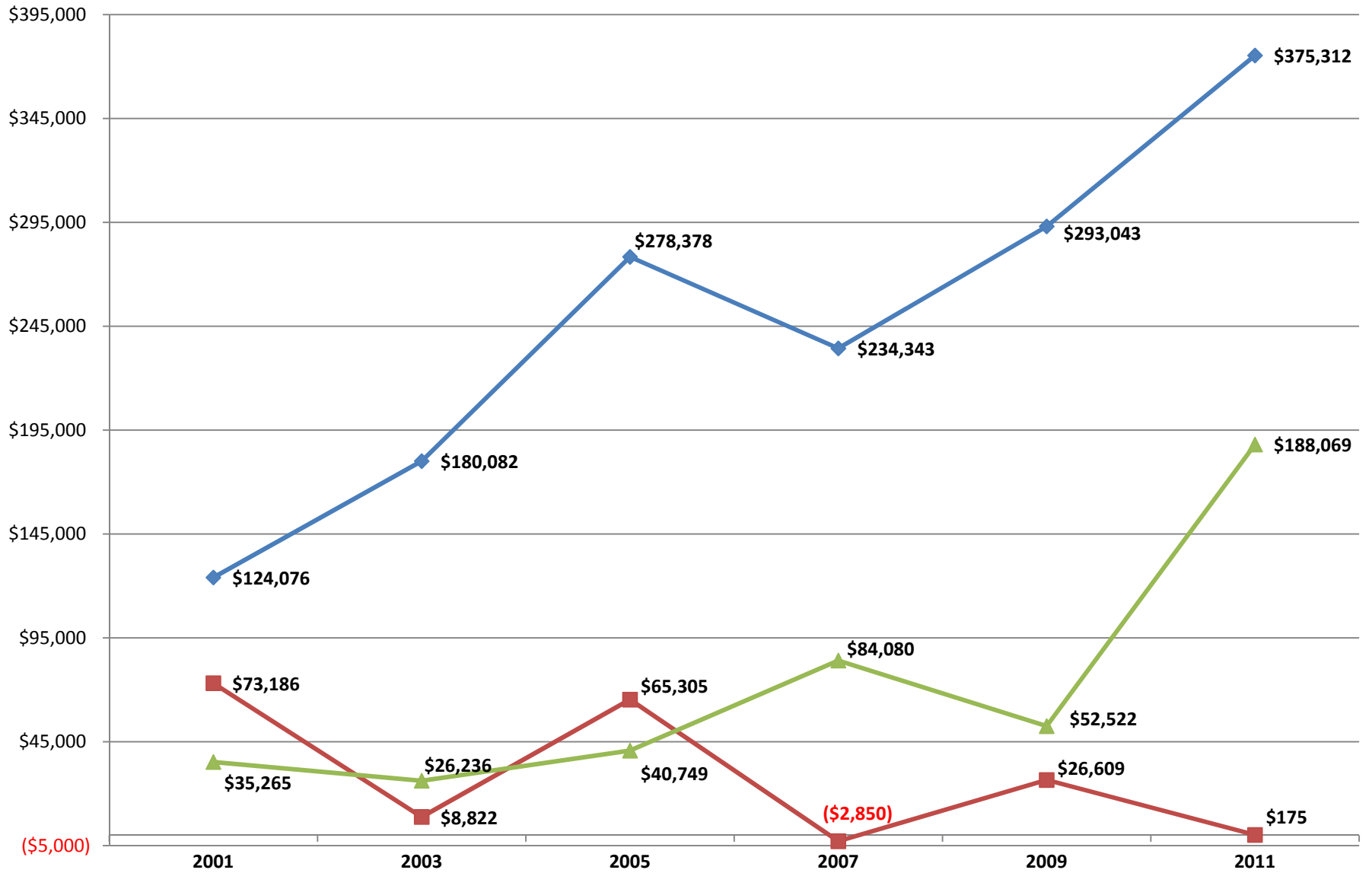
Total Fundraising Before 1/1 of Election Year

Incumbent Challenger

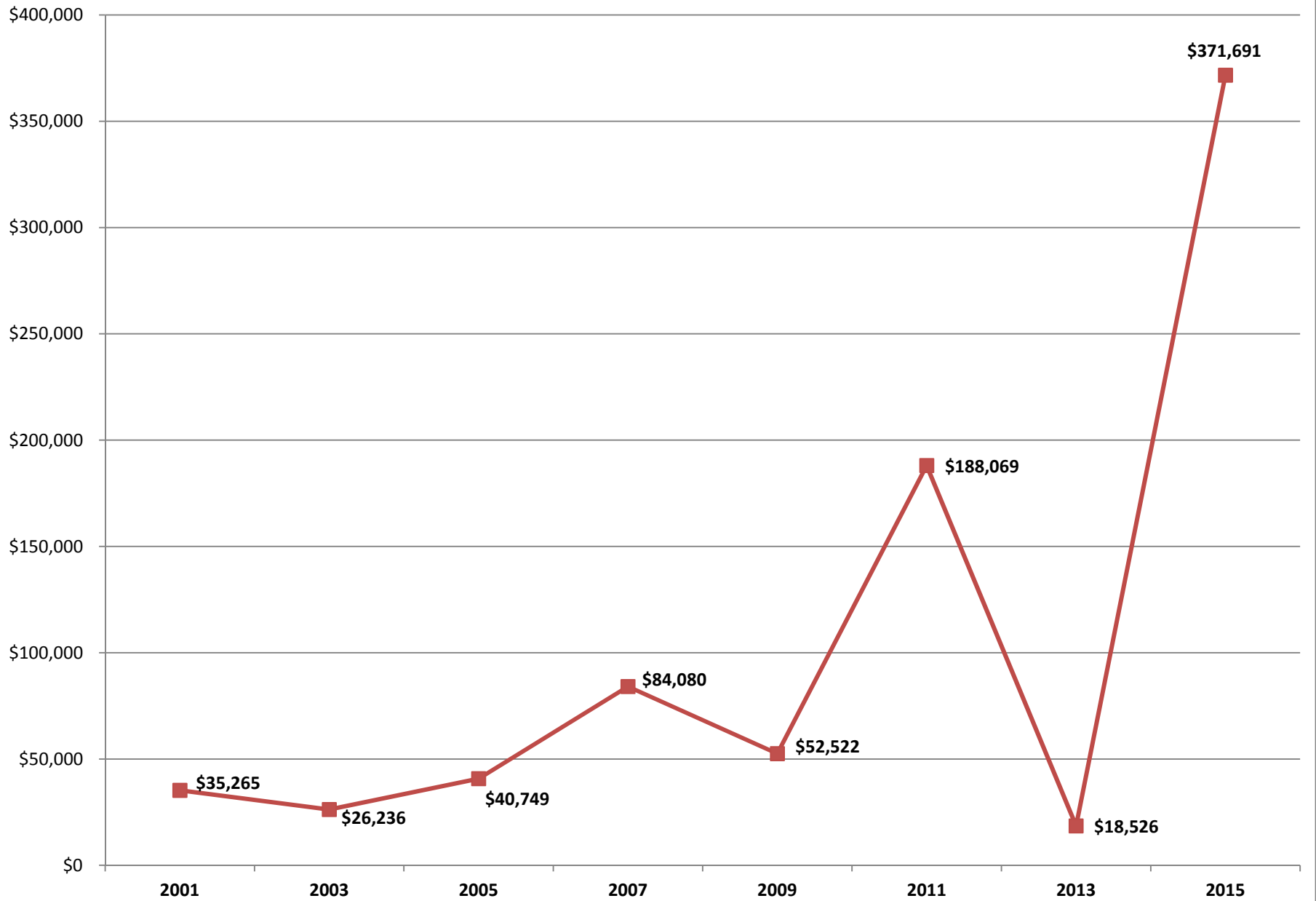


Total Fundraising Before 1/1 of Election Year

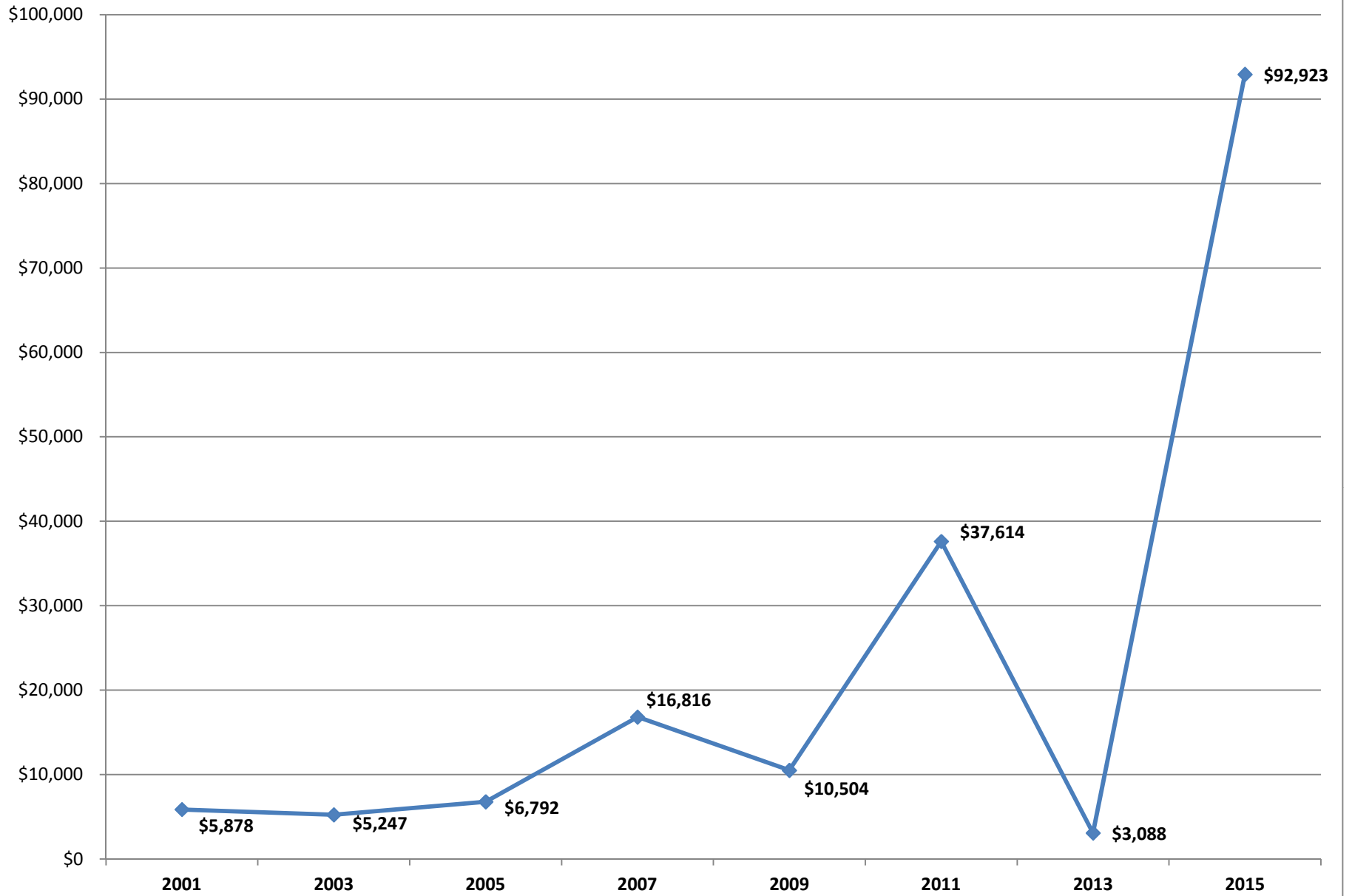
Incumbent Challenger Rollover Funds



Total Rollover Funds Available for All Candidates

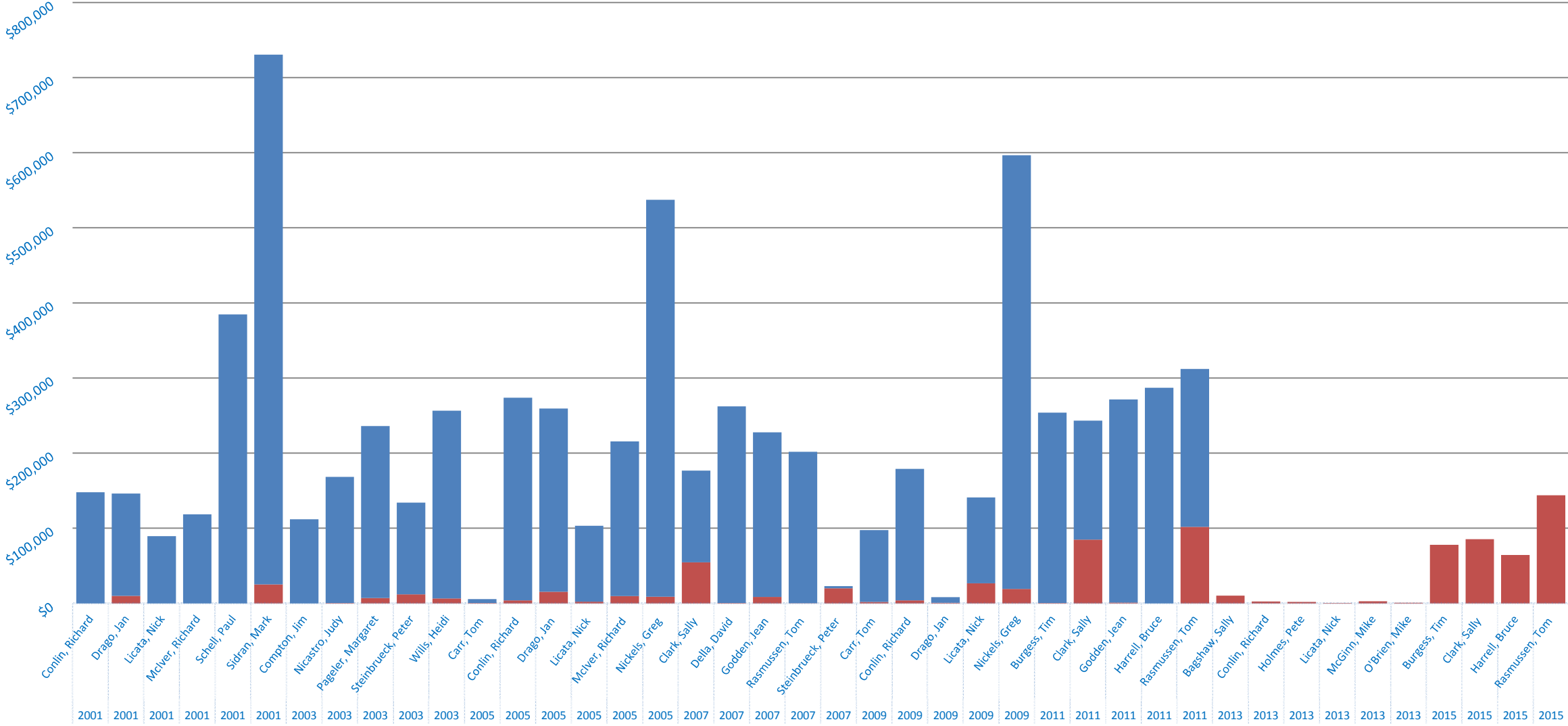


Average Rollover Funds Available Per Candidate

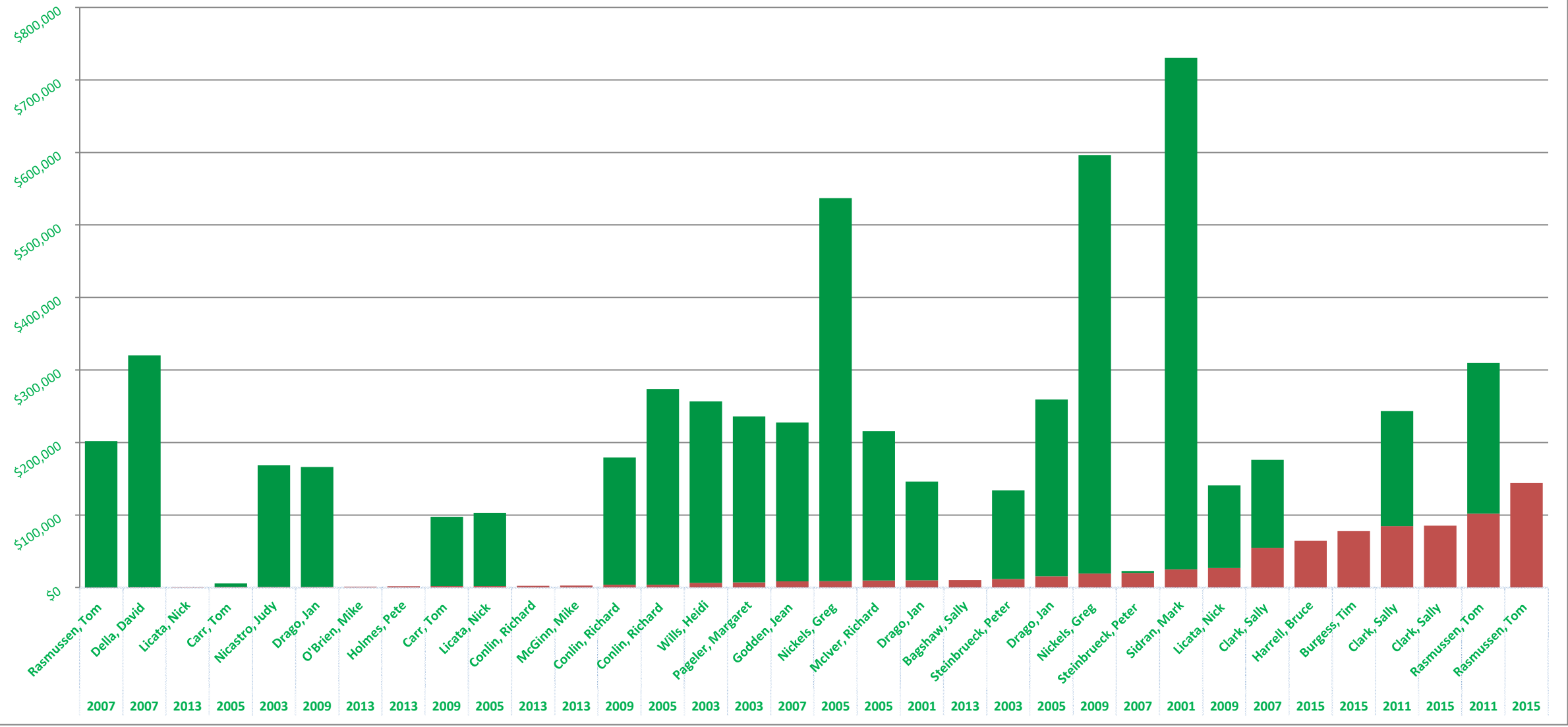

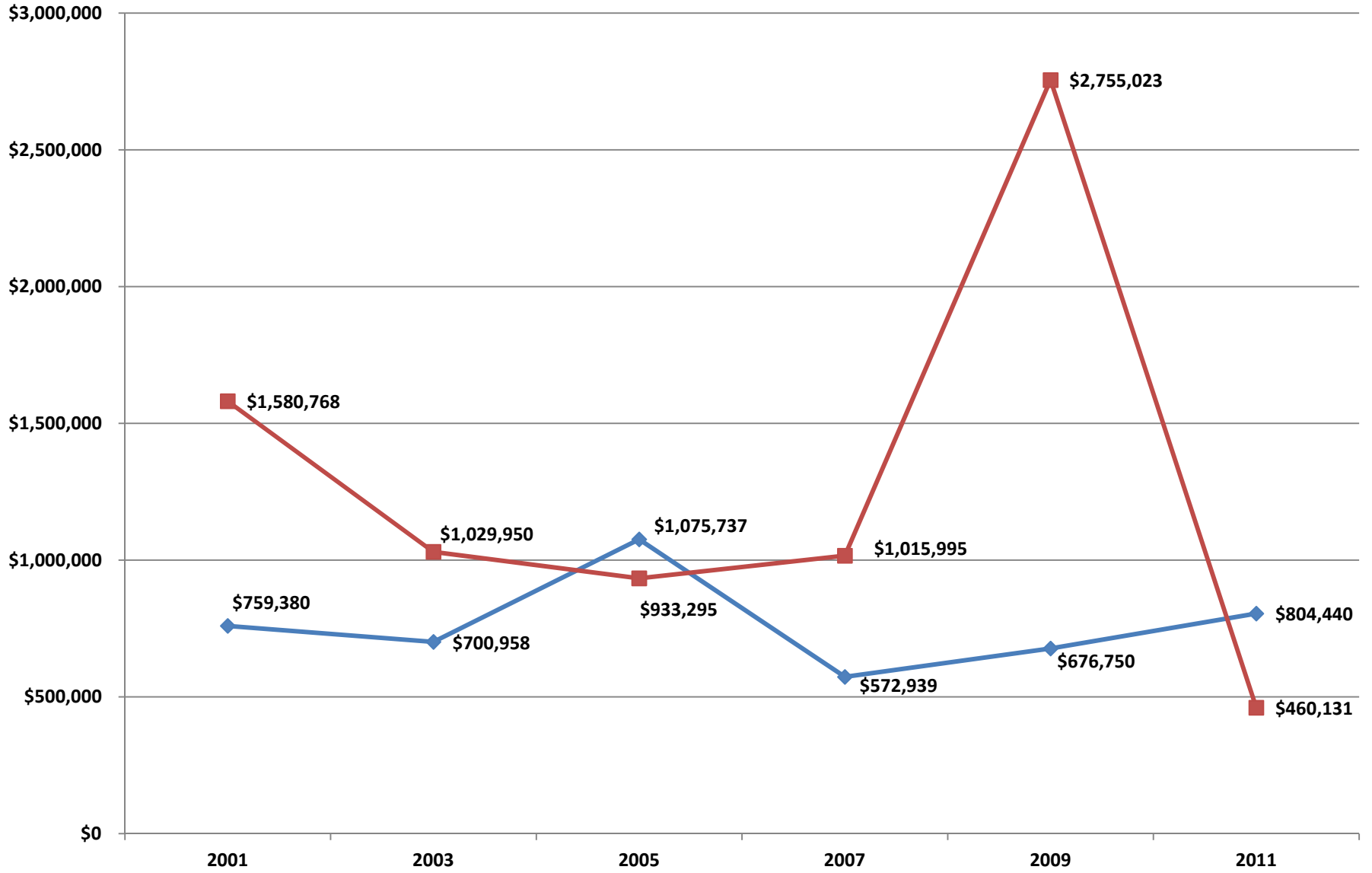

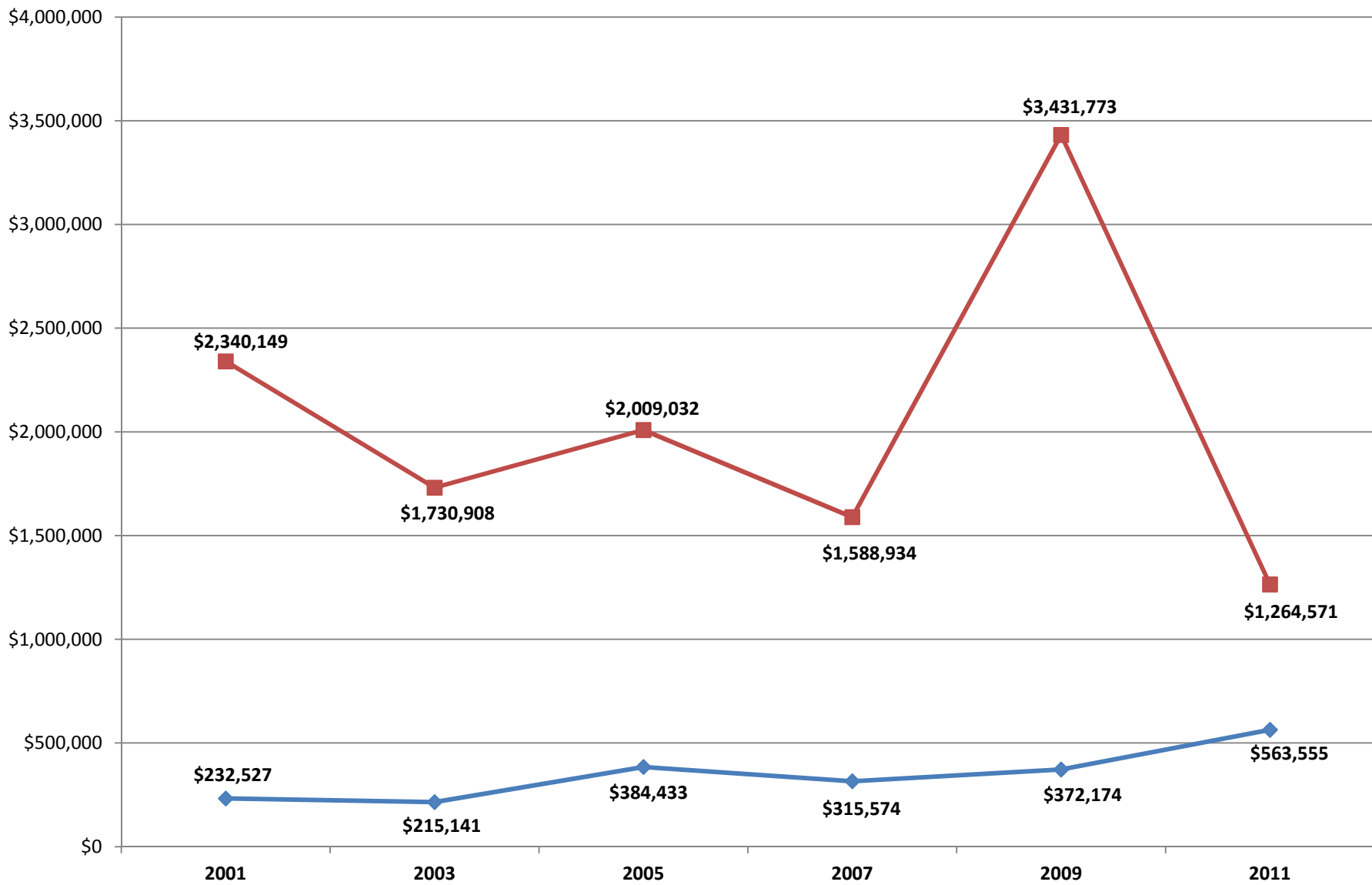
Total Fundraising After 1/1 of Election Year

Incumbent Challenger



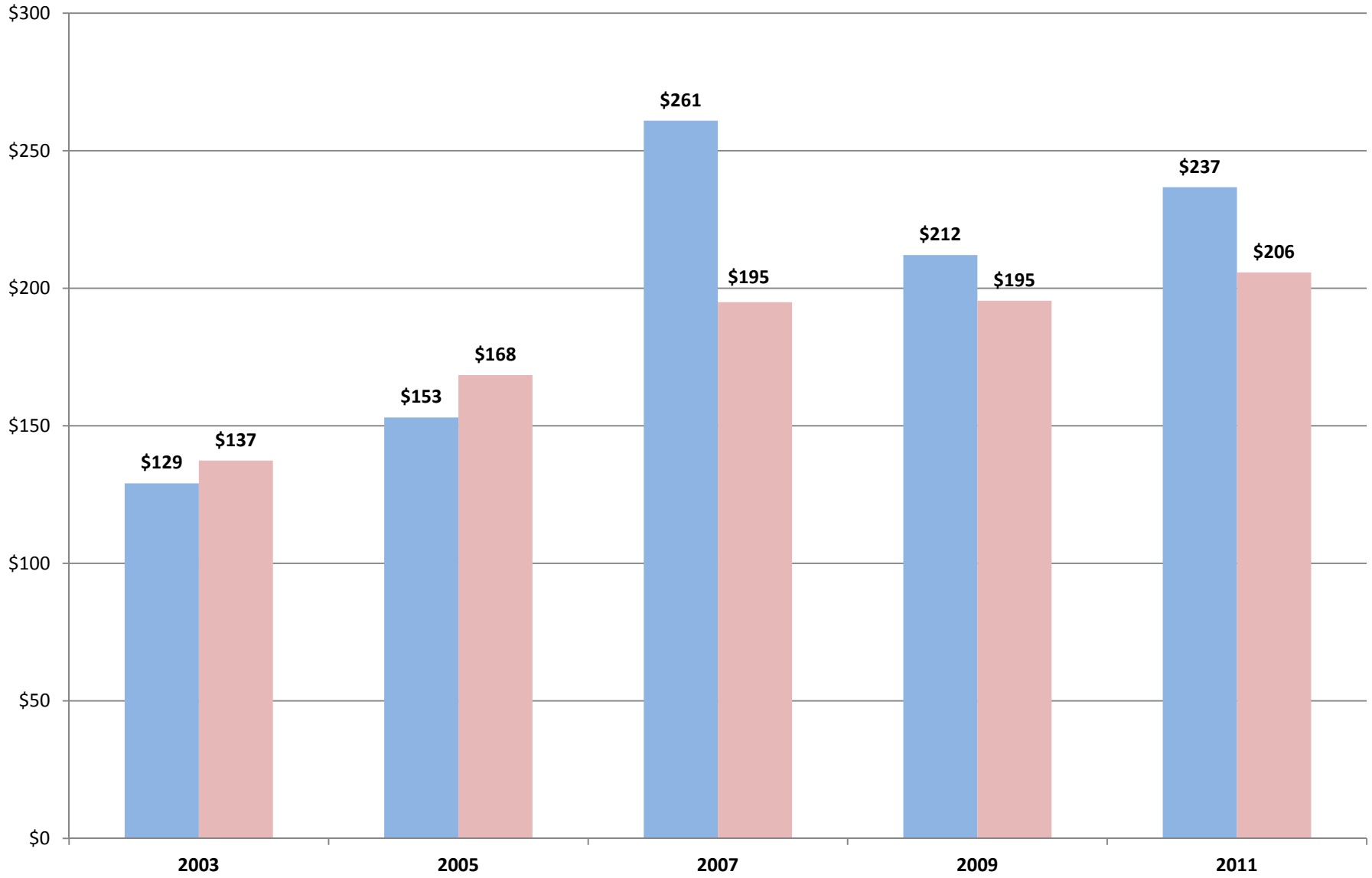
Total Raised by All Candidates, Including Rollover Funds

◆ Prior to Jan. 1 of Election Year ■ After Jan. 1 of Election Year



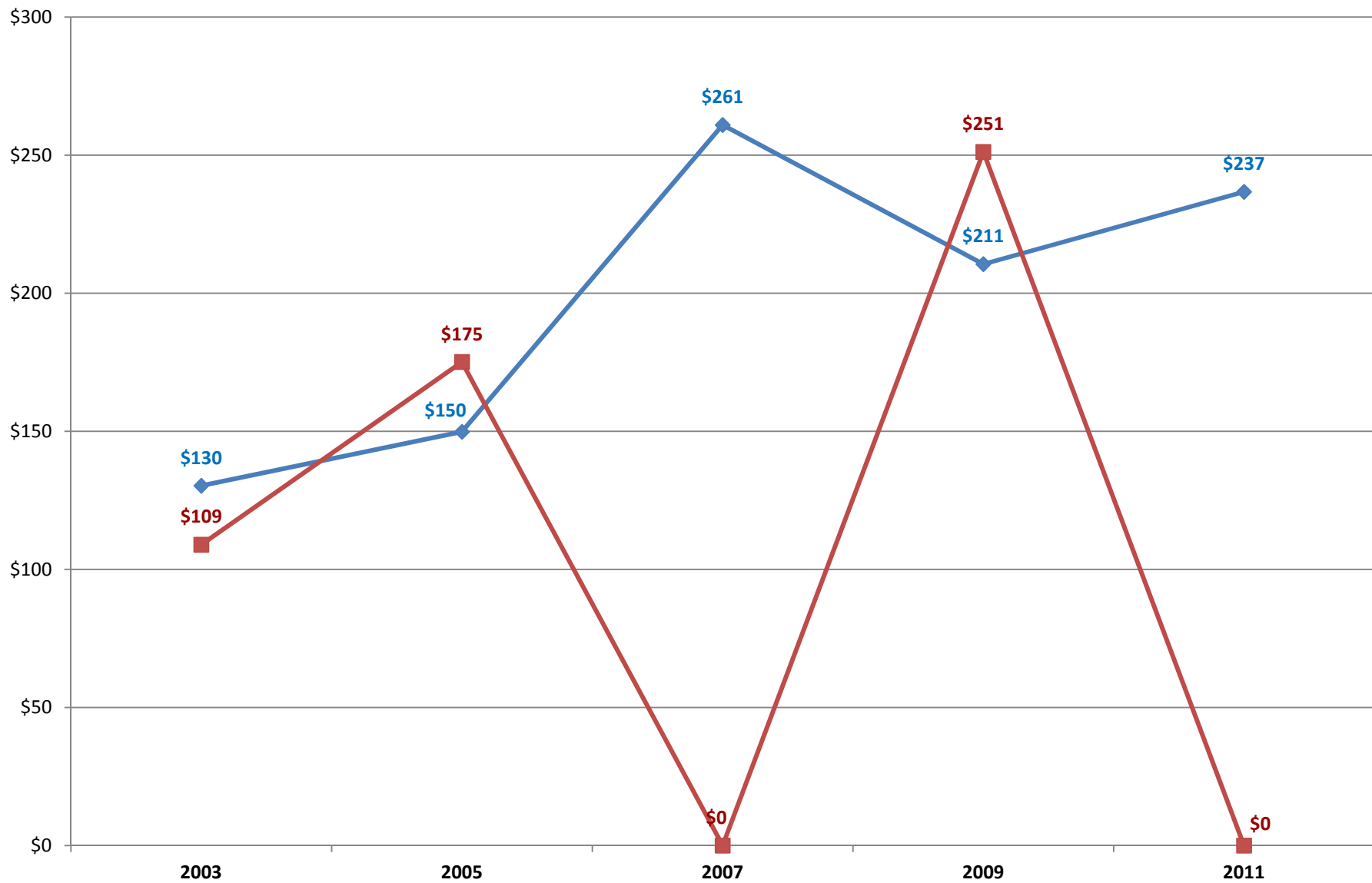
Average Individual Contribution Amounts
