Approve July Minutes and August Agenda

City budget for trans community

- 1. Diondra: Committee has met once and has sent dates to meet with the MO
- 2. Budget proposal drafted with the help of Leo and has been sent to the commission for review

2. Capacity: The commission might not have the capacity at this moment, other ideas to include:

- a. Push back the timeline
- b. Provide more time for other agencies, like AAOC to provide feedback to the commission
- c. Align with AAOC Policy committee as the main lead and then provide commission support meet with council members

3. Brett: Would be helpful to meet with the MO and how we could hold a collaborative relationship with AAOC, the MO and what that would entail

a. Follow up discussion set for Monday evening for commissioners – Brett to send invite

Facilitator's budget for annual retreat

- 1. Chris: The annual retreat in some years included paid facilitators, unpaid facilitators, facilitators part of the commission or from OCR
- 2. Other ideas include reaching out to prior commissioners with no monetary contribution
- Last year around \$1,000 was set aside for an outside facilitator that included 4-5 planning meetings leading up to the annual retreat and the retreat was spilt into 2 separate meetings
- 4. This year's retreat will be 1-day on Sat, Dec. 11 from 10a-3pm. TBD in person, hybrid or virtual and people's comfort level. Save the date has been sent by Janet
- 5. If an outside facilitator is hired, can we set a monetary budget for this service open to discussion
 - a. This would include their service for the day of the retreat, 3-5 planning meetings leading up to the date, discuss if the annual planning sessions is productive in a way that is inclusive give the feedback from commissioners who have left the commission
- 6. Victor: Supports the idea of a similar setup to last year and to note this will be posted as a public event
- 7. Nate: Supports giving to an outside facilitator, especially to be successful in addressing concerns of those raised by Chris. As for the retreat, a lot of work goes into preparing these goals and sometimes these ideas get dropped or don't get revisited throughout the year
- 8. Chris: sounds there is an agreement to an external facilitator that has a bypass intersectionality background
 - a. Ask: is \$1,000 an appropriate amount do we want more or less while being cautious of the language we use
 - b. Commission Budget clarification for newer commissioners– each year the commission is awarded \$2,000 with a large portion of that going to the annual retreat. Current balance to date is \$2,000 since there was no expenses towards public events this year
- 9. Janet: Reminder the \$2,000 needs to be allocated by December of each year, if not used any balance does not roll over
- 10. Motion to use up to \$1,000 towards a facilitator for the annual retreat with the requirements to include someone from the BIPOC community and carries intersectionality and facilitator skills. create a position of Treasurer to be monitor our finances, to be elected by the Commission. Unanimous consent Motion passes
 - a. Will begin outreach, please submit suggestions/recommendations to be emailed to Chris to compile a list of facilitators
