

**Project Description:** Council Land Use Action to adopt a new Major Institution Master Plan (MIMP) for Seattle Pacific University (SPU). A rezone is required for a modification to the Major Institution Overlay (MIO) height limits. Environmental Impact Statement (EIS) is being prepared by Seattle Department of Construction and Inspections (SDCI). Project may include street and alley vacations.

The following approvals are required:

SEPA Environmental Determination – Determination of Significance Council Land Use Action – New Major Institution Master Plan Council Land Use Action – Rezone to expand the boundaries of a MIO Council Land Use Action – Rezone to allow changes to height in a MIO

The Director of the Seattle Department of Construction and Inspections (SDCI) has reviewed the application described above and has issued a Determination of Significance (preparation of an Environmental Impact Statement is required).

The Department has preliminarily identified the following elements of the environment for discussion in the Environmental Impact Statement: Height, Bulk and Scale; Land Use; Parking; Traffic and Transportation; and Shadows on Open Space.
