### Week Overview

Week five of the 2018 legislative session saw the house of origin fiscal cutoff (February 6<sup>th</sup>) and the beginning of floor action. Over 1,000 bills made it out of committee by fiscal cutoff which is still a significant number of bills to still be considering. Both chambers continue to work at a rapid pace and have been scheduled late into the night, as well as through the weekend, as they try to pass bills out of their respective floors before the house of origin floor cutoff on February 14<sup>th</sup>. It is worth noting that despite these important cutoff deadlines, bills considered “necessary to implement the budget” (NTIB) are exempt from these deadlines. So, though a bill may not have met its deadline, no bill is truly dead until session concludes.

### **A Primer on the Rules Committee**

Before a bill can make it to the chamber floor for debate and vote it must first make it out of the Rules Committee. This can be a fairly confusing process, especially since the House and Senate use different terminology for parts of the Rules Committee process. To help better understand this process, we have provided primer on the Rules Committee.

The Rules committee is a powerful committee and is often referred to as "The Gatekeeper". Some people also say that the Rules committee is where bills go to die. This is because it is a big hurdle to get pulled out of the Rules committee and brought to the floor and many bills don't make it through. The process for getting pulled from Rules can seem complicated and can also be difficult to influence.

The simplified explanation of the Rules committee is that it is a two-step process to determine which bills will be placed on the floor calendar for amendment, debate, and ultimately for a vote by the full chamber (House or Senate). The following is a brief summary of each chamber's process for the Rules Committee. The processes are very similar, but given the use of different terminology and some nuances, they will be explained differently.

#### *Senate Rules Committee Process*

In Senate Rules there are two calendars – the white sheet and the green sheet. The white sheet is where bills are sent immediately after passing out of a standing committee. The green sheet is a consideration calendar made up of bills that have been “pulled” by Rules committee members from the white sheet and is essentially the list of bills eligible to go to the floor. Bills can be pulled from the white to green sheet without debate or vote. Senate Rules Committee members get a predetermined number of pulls.

Once on the green sheet they are eligible to pull to the floor at the next Rules meeting, but to make it to the floor they are first debated and voted on by Rules committee members. Bills can also be pulled in “packages” where groups of bills may be voted out of Rules at one time. Senate Rules also allows what is known as a “leadership pull”, which is where a package of bills can be pulled by leadership from the Review and/or Consideration calendars to the floor. If a bill is voted out of the Rules committee it is added to the floor calendar for second and third reading.

#### *House Rules Committee Process*

There are also two calendars in House Rules – the “Rules Review” calendar and the “Rules Consideration” calendar. Bills referred from a standing committee are placed on the Rules Review calendar. Rules Committee members can then pull a bill from the Rules Review calendar to the Rules Consideration calendar. This is the first pull. House Rules Committee members get a predetermined number of pulls. At a later meeting a member can do a second pull to move the bill from the Rules Consideration calendar to the floor calendar. Rules members vote on every motion to pull a bill. If a bill is voted out of the Rules committee it is added to the floor calendar for second and third reading. House Rules also allows what is known as a “leadership pull”, which is where a package of bills can be pulled from the Review and/or Consideration calendars to the floor.

#### **A Primer on First, Second, and Third Reading**

During floor activity, we also hear a lot about 2<sup>nd</sup> and 3<sup>rd</sup> reading. These terms are important steps in the legislative process.

For all three readings, a bill is almost never actually read in its entirety. This is why you will hear the Speaker or Lt. Governor stop the person reading the bill after a few words and say, ‘last line.’ A member can ask for a bill to be read in its entirety, but this rarely happens.

- *First Reading:* This is the first of three readings required to pass bills. When a bill is on first reading, that is when it is first introduced into a chamber and is referred to standing committees. At this point in session, we are seeing the second round of first readings because bills that passed out of their house of origin are being introduced and read into the opposite house for the first time and then referred to a standing committee.
- *Second Reading:* When a bill appears on the calendar for second reading, this means it can be put on the order of consideration and brought to the floor for debate and can be amended. After the debate and potential amendment, the bill in theory would be returned to the Rules Committee where it must receive a favorable vote before being placed on the third reading calendar for final passage. This referral to back Rules [between second and third reading] is almost always bypassed and the bill is placed on final passage immediately following its second reading. This happens when a member says, “Let the Rules be suspended, that (the bill) be advanced to third reading, let the second reading be considered the third, and the bill be placed on final passage.” This means they will be doing second reading and then immediately following will do the third reading without the bill going back to Rules.
- *Third Reading:* This is the final consideration of a bill before either house. The bill can be debated, voted on, or tabled. It cannot be amended during third reading. Final passage of a bill takes a constitutional majority.

## **Priority Areas**

### **Homelessness and Housing**

*Affordable Housing Development:* [SHB 1797](#), sponsored by Rep. McBride, allows cities to apply for a one-time remittance of 4.37 percent of the state sales and use tax on public purchases for affordable housing development or public infrastructure to support such development, allows the governing body of a county with a population over 1.5 million and the cities within such county to authorize the existing 0.1 percent local sales and use tax used for mental health services and affordable housing, and allows revenue from the local real estate excise tax to be used for affordable housing development through 2022, so long as other local capital projects have adequate funding. The bill was placed on second reading by Rules Committee on January 16<sup>th</sup>.

*Affordable Housing Investments:* [SHB 2437](#), sponsored by Rep. Robinson, authorizes the governing body of a county to impose a local sales tax, credited against the state sales tax, for affordable or supportive housing. SHB 2437 has been placed on second reading by the Rules Committee as of February 8<sup>th</sup>.

*Condominium Bylaws:* [SSB 6001](#), sponsored by Sen. Keiser, provides an alternative process for acquiring and counting votes to amend condominium bylaws, requires notice of a vote to owners who fail to vote, and subtracts the number of unreturned ballots from the total number of unit owners before applying the minimum percentage required to amend. The amended bill was passed to the Senate Rules Committee on February 2<sup>nd</sup>.

*Facilities Financing:* [HB 2364/SB 6371](#), sponsored by Rep. Ryu and Sen. Mullet, concerns facilities financing by the housing finance commission (HFC). The bill increases the Housing Finance Commission's debt limit from \$6 billion to \$8 billion and expands the organizations eligible for lower-cost financing through the HFC's Nonprofit Facilities Program. HB 2364 is on second reading and SB 6371 was voted off the Senate floor on February 9<sup>th</sup> with a 44 – 2 vote.

*Preventing Fires:* [SHB 2864/SSB 6473](#), sponsored by Sen. Lias and Rep. Eslick, directs the director of fire (Director) protection to investigate ways to prevent fire deaths in rental dwellings and requires the Director to convene a task force of various stakeholders, allow for public comment at task force meetings, and provide a report on the task force's findings and recommendations to the Governor and Legislature. SHB 2864 and SSB 6473 are on second reading.

*Property Tax Exemptions:* [2SHB 1532/ESSB 5143](#), sponsored by Rep. Lytton and Sen. Zeiger, clarifies the property tax exemption for nonprofit homeownership development by specifying that land that is to be leased for 99 years or life to a low-income household qualifies for the exemption and specifies that the lease of the exempted land to a low-income household terminates the property tax exemption. 2SHB 1532 passed out of the House on February 1<sup>st</sup> with an 89 – 5 vote count. ESSB 5143, passed out of the Senate on January 24<sup>th</sup> with a 41 – 8 vote count and has been scheduled for a public hearing in the House Committee on Finance on February 16<sup>th</sup>.

[SSB 6251](#), sponsored by Sen. Dhingra, modifies the qualifying income thresholds for the property tax exemption and deferral programs for low-income senior citizens, individuals with disabilities, and veterans, beginning in calendar year 2020. The bill is currently on second reading.

[SHB 2597/SSB 6314](#), sponsored by Sen. Dhingra and Rep. Sullivan, permits cities and counties to provide senior citizens, individuals with disabilities, and veterans with an exemption from any portion of their regular property tax attributable to a levy lid lift, with voter approval. SHB 2597 and SSB 6314 have been placed on second reading.

[SSB 6361](#), sponsored by Sen. Billig, allows the governing authority of certain cities to adopt a local property tax exemption program, under which qualifying new construction is exempt from local property tax for ten years. The bill has been placed on second reading.

*Homeless Housing Surcharge:* [E2SHB 1570](#), sponsored by Rep. Macri, makes the temporary \$40 local homeless housing and assistance surcharge permanent, allows counties to charge and retain an additional surcharge for homeless housing and assistance, allows additional homeless housing and assistance surcharges imposed by a county to be used to pay off general obligation bonds issued by the county for homeless housing and assistance, changes the Home Security Fund from an appropriated account to a nonappropriated account, and creates new and updated reporting requirements and studies for certain homeless assistance programs. The bill was voted off the House floor February 7<sup>th</sup> with a 51 – 47 vote count.

*Notice of Termination of Tenancies:* [HB 2040/SSB 5408](#), sponsored by Rep. Frame and Sen. Cleveland, extends the required notice period for termination of a periodic tenancy. SSB 5408 was placed on second reading by the Rules Committee on January 25<sup>th</sup>.

*Real Estate Excise Tax Exemption:* [HB 2444](#), sponsored by Rep. Slatter, provides a real estate excise tax exemption for the transfer of a qualified low-income housing development or controlling interest in a qualified low-income housing development. The bill was placed on second reading February 8<sup>th</sup>.

*REET:* [HB 2876 /SSB 6490](#), sponsored by Sen. Takko, removes a provision requiring voter approval before a county choosing to plan under the Growth Management Act (GMA) and cities within those counties may impose additional real estate excise taxes (REET II) and allows initiatives and referenda to repeal REET II imposed by counties and cities choosing to plan under the GMA. SSB 6490 has been passed to the Rules Committee for second reading. HB 2876 did not receive action before the house of origin policy cutoff.

[HB 2875/ SB 6557](#) sponsored by Sen. Mullet and Rep. McBride, exempts the building and sale of self-help housing by an affordable homeownership facilitator from retail sales and use tax and the real estate excise tax (REET). HB 2875 was placed on second reading on February 8<sup>th</sup>. SB 6557 did not receive action before the fiscal cutoff.

*Restrictive Covenants:* [SB 6379/SB 2674](#), sponsored by Sen. Fain, clarifies that a local government wishing to remove a restrictive covenant from land it owns need not first hold a public hearing unless the restrictive covenant is recorded. SB 6379 has been placed on the second reading consent calendar. HB 2674 was placed on second reading on February 8<sup>th</sup>.

*Source of Income:* [E2SSB 5407](#), sponsored by Sen. Frockt, prohibits landlords from refusing to rent property, expel tenants, discriminate, or discourage a rental to a tenant based on their source of income, creates a landlord mitigation program in the Department of Commerce (Commerce) allowing landlords to seek reimbursement for repairs of documented damages to qualifying rental units, and authorizes a \$3 increase to a surcharge on document recording fees with a portion of the new surcharge deposited

into the Landlord Mitigation Account. E2SSB 5407 was voted off the Senate floor on February 9<sup>th</sup> with a 33 – 14 vote count.

[2SHB 2578](#), sponsored by Rep. Riccelli, while not a companion to SB 5407, also prohibits discrimination based on a tenant's source of income, creates the Landlord Mitigation Program and Account, and increase the affordable housing surcharge to \$13 from \$10 with 40% of the additional \$3 to go to the Account. The bill was voted off the House floor on February 9<sup>th</sup> with a 61 – 37 vote count.

*Surplus Property:* [3SHB 2382](#), sponsored by Rep. Ryu, was amended in Rep. Ryu's committee to say public benefit means affordable housing for households at or below 80% of the local adjusted median income, as well as related facilities that support the goals of affordable housing development. It was further amended by the House Transportation Committee to provide exemptions to the requirement that WSDOT and WSP remit 10% of any net proceeds from the sale of state real property to Housing Trust Fund through 2020 where such remittance is otherwise prohibited by law. It now also exempts the sale of surplus property acquired for use related or that is in the vicinity of the SR 520 bridge replacement and HOV program, AWW replacement project, Southbound Tacoma Narrows Bridge, I-405 corridor program, Puget Sound Gateway program, and the US 395 North Spokane Corridor Program. The bill was pulled from the Rules Committee on February 8<sup>th</sup> and awaits floor action. The bill was voted off the House floor February 9<sup>th</sup> with a 53 – 45 vote count.

### **Safety Net and Civil Rights**

*Ban the Box/Fair Chance Act:* The Washington Fair Chance Act, [SSB 6110](#) and [2SHB 1298](#), sponsored by Sen. Saldaña and Rep. Ortiz-Self, prohibits an employer from, among other things, including any question on an application or inquiring into an applicant's criminal background until after the employer initially determines that the applicant is otherwise qualified for the position, exempts certain employers from the prohibition, and authorizes the Attorney General to enforce the provisions and impose penalties. SSB 6110 was passed out of committee on February 6<sup>th</sup>, the bill was then referred to the Rules Committee for second reading. 2SHB 1298 passed out of the House Committee on Labor and Workplace Standards on January 9<sup>th</sup>. The bill was voted off the House floor February 7<sup>th</sup> with a 52 – 46 vote count. The bill has now been referred to the Senate Committee on Labor and Commerce.

*Civil Service Qualifications:* [SB 6145](#), sponsored by Sen. Saldaña, changes the civil service qualification for police officers, fire departments, and county sheriff departments by expanding who can apply for a position to include a lawful permanent resident. The bill was voted off the Senate floor February 7<sup>th</sup> with a 31-17 vote count. The bill is now scheduled for a public hearing in the House Committee on Labor & Workplace Standards on February 15<sup>th</sup>.

*Equal Pay:* The Equal Pay Act, [2SHB 1506](#) and [SSB 5140](#), sponsored by Rep. Senn and Sen. Cleveland, prohibits discrimination in providing employment opportunities based on gender and prohibits retaliation for certain workplace discussions about wages and other matters. 2SHB 1506 was voted out of the House on January 17<sup>th</sup> 69 – 28 and is now on second reading in the Senate. SSB 5140 has been placed on second reading by the Senate Rules Committee.

*Families in Need of Services:* [2SSB 6467](#), sponsored by Sen. Darneille, creates a families in need of services (FINS) petition model that replaces and merges the at-risk youth (ARY) and child in need of services (CHINS) petition model, while expanding the definition of petitioner to include a youth,

parent, or other suitable adult. The second substitute bill passed out of the Senate Committee on Ways and Means on February 6<sup>th</sup> and has been passed to the Rules Committee for second reading.

*HEN Expansion:* [SHB 2667/SSB 6502](#), sponsored by Rep. Macri and Sen. Dhingra, expands eligibility for referrals to the Essential Needs and Housing Support (HEN) program to include recipients of the Aged, Blind, or Disabled cash assistance program and requires information sharing of limited recipient data between the Department of Social and Health Services, the Department of Commerce, and HEN providers. The bill was voted off the House floor February 8<sup>th</sup> with an 88 – 10 vote count. SSB 6502 received a public hearing in the Senate Committee on Ways and Means on February 5<sup>th</sup>, but no action was taken before the fiscal cutoff.

*I-200 Repeal:* [SB 6406](#), sponsored by Sen. Chase, repeals the 1998 Initiative 200 (I-200) language regarding discrimination and preferential treatment in the operation of public employment, education, or contracting. The bill has been placed on second reading by the Rules Committee.

*Keep Washington Working Act:* [2SSB 5689](#), sponsored by Sen. Wellman, establishes a statewide policy supporting Washington state's economy and immigrants' role in the workplace. The bill enacts the Keep Washington Working Act, establishes a Keep Washington Working Statewide Steering Committee to: develop strategies; conduct research; support various organizations; and make recommendations. It also requires the Attorney General to publish model policies for limiting immigration enforcement to the fullest extent possible consistent with the law, restricts the use of state resources to assist in unconstitutional or illegal registration or surveillance programs or any other unconstitutional or illegal laws, rules, or policies targeting Washington residents on the basis of race, religion, immigration, or citizenship status, or national or ethnic origin and restricts agencies and other departments from using their resources or transferring or detaining an individual to federal immigration authorities absent a proper warrant. 2SSB 5689 is currently in the Rules Committee waiting to be assigned to second reading.

*Occupational Disease:* [SB 6213/SHB 2633](#), are sponsored by Sen. Ranker and Rep. Doglio. SB 6213 includes EMTs and fire investigators for the occupational disease presumptions provide for firefighters, adds strokes and additional types of cancers to the presumptions, and provides occupational disease presumptions for specified law enforcement officers for certain heart problems and strokes, and for infectious diseases. SB 6213 has been passed to the Rules Committee for second reading. SHB 2633 was passed out of committee on February 6<sup>th</sup> and referred to the Rules Committee.

*Posttraumatic Stress:* [SSB 6214](#), sponsored by Sen. Conway, allows industrial insurance coverage for posttraumatic stress disorders affecting law enforcement officers and firefighters. The bill was passed off the Senate floor on February 9<sup>th</sup> with a 47 – 0 vote count.

*Sexual Harassment:* [SSB 5996](#), sponsored by Sen. Keiser, prohibits an employer from requiring an employee, as a condition of employment, to sign a nondisclosure agreement that prevents the employee from disclosing sexual harassment or sexual assault, provides that any nondisclosure agreement that has the purpose or effect of preventing an employee from disclosing or discussing sexual harassment or sexual assault is void and unenforceable, and provides that it is an unfair practice under the Washington Law Against Discrimination (WLAD) for an employer to retaliate against an employee for disclosing or discussing sexual harassment or sexual assault. The bill was passed unanimously by the Senate on February 8<sup>th</sup> and has now been scheduled for a public hearing in the House Committee on Labor & Workplace Standards on February 15<sup>th</sup>.

[SSB 6313](#), sponsored by Sen. Keiser, provides that certain employment agreements are void and unenforceable unless they preserve the employee's right to file a sexual harassment or sexual assault complaint in a court of competent jurisdiction and with the appropriate state or federal agency. The bill was passed to the Rules Committee for second reading on February 1<sup>st</sup>.

*Voting Rights:* [SHB 1800](#), sponsored by Sen. Gregerson, enacts the Washington voting rights act by establishing a state voting rights act that seeks to protect the equal opportunity for minority groups to participate in local elections, creates a cause of action and authorizes courts to order appropriate remedies for a violation of the act, including redistricting within a political subdivision and authorizes local governments to change their election system to remedy violations of the act. The substitute bill has been placed on second reading by the Rules Committee as of January 19<sup>th</sup>.

[ESSB 6002](#), sponsored by Sen. Saldaña, enacts the Washington voting rights act of 2018. ESSB 6002 creates a state voting rights act to protect the equal opportunity for minority groups to participate in local elections and elect candidates of choice, creates a cause of action and authorizes courts to order appropriate remedies for a violation of the voting rights act, including redistricting within a political subdivision, and authorizes local governments to change their election systems to remedy potential violations of the act. The bill was voted off the Senate floor on January 19<sup>th</sup> with a 29 – 19 vote count. It has moved to the House for consideration where it has received a public hearing in the House Committee on State Government, Elections and Information Technology on January 26<sup>th</sup>. It has been scheduled for executive session for either February 15<sup>th</sup> or February 16<sup>th</sup>.

*Wrongful Death:* [2SHB 2262/2SSB 6015](#), sponsored by Rep. Santos and Sen. Hasegawa, concerns actions for wrongful injury or death and makes a number of changes to statutes governing wrongful death and survival causes of action, including changes to the beneficiaries entitled to recoveries and the damages that may be recovered under these actions. 2SHB 2262 was placed on second reading on February 8<sup>th</sup>. 2SSB 6015 passed off the Senate floor on February 9<sup>th</sup> with a 26 – 21 vote count.

## **Health Care**

*Opioid Treatment and Prevention:* The House version of Governor Inslee’s proposal for addressing the opioid crisis, [HB 2489](#), would implement a “hub and spoke” system that would allow every community access to medical expertise on the issue, establish statewide access to treatment, and would make medication-assisted treatment more available in the state. There were two floor amendments proposed that related to safe consumption sites, but both amendments were ruled as being outside of the ‘scope and object’ of a bill and therefore were not brought to a vote. There was a small floor amendment that was adopted that exempted veterinarians from requirements to have in-person discussions with patients about the risks of opioids. The House bill passed off the House floor unanimously on February 9<sup>th</sup> and has been scheduled for a public hearing in the Senate Committee on Health & Long Term Care on February 15<sup>th</sup>.

The Senate version, [SB 6150](#), is currently in Senate Rules and there is a proposed floor amendment posted that would add the dental association to the PMP stakeholder work group.

*Substance Disorder Treatment:* [2SHB 2572](#), sponsored by Rep. Cody, prohibits state health plans, private insurance plans, and behavioral health organizations from establishing prior authorization requirements for substance use disorder treatment and mandates coverage for up to 24 hours of acute

treatment and clinical stabilization services for substance use disorders. The bill was placed on second reading on February 9<sup>th</sup>.

*Chemical Dependency Prevention and Outreach:* [HB 2799](#), sponsored by Rep. Kagi, allows the local sales and use tax for chemical dependency and mental health to be used for prevention and outreach programs. The bill was placed on second reading on February 9<sup>th</sup>.

*Market Stabilization:* Insurance Commissioner Mike Kreisler's market stability proposal on reinsurance, [HB 2355](#), or Senate, [SB 6062](#), continues to have uncertainty on its path forward. While the House (HB 2355) or Senate (SB 6062) proposals moved quickly through committee early in session and both are in their respective Rules committees, neither bill had any activity last week. The apparent deadline for passing the proposal in time to meet the timeline for the federal 1332 waiver has lapsed. The federal waiver would have drawn down some federal funds to help implement the program. Even though the time has passed for the 1332 waiver, there is still interest from some stakeholders in establishing a reinsurance program, though the discussions about potential different approaches that could be taken remain private at this point. Both bills are currently still on second reading.

*Conversion Therapy:* [SB 5722](#), sponsored by Sen. Liias, restricts the practice of conversion therapy and makes it unprofessional conduct for a licensed health care provider to perform conversion therapy on a patient under the age of 18. SB 5722 passed out of the Senate on January 19<sup>th</sup> with a 32 – 16 vote count. Now in the House, it received a public hearing in the House Committee on Health Care and Wellness on February 7<sup>th</sup> and is scheduled for executive session February 16<sup>th</sup>.

*Preventive Services Coverage:* [HB 1523](#), sponsored by Rep June Robinson, would require health plans to cover, with no cost sharing, all preventive services required to be covered under federal law as of December 31, 2016. HB 1523 passed out of the House on January 31<sup>st</sup> with a 56-38 vote count and is now scheduled for a public hearing in the Senate Committee on Health Care & Long Term Care on February 16<sup>th</sup>.

*Managed Care:* [SSB 6573](#), sponsored by Sen. O'Ban, requires the Health Care Authority (HCA) to integrate risk for long-term involuntary civil treatment into managed care contracts by July 1, 2021, requires the Department of Social and Health Services (DSHS) to collaborate with HCA and appropriate stakeholders to develop a detailed transition plan to move the cost of state hospital civil treatment into managed care by December 30, 2019, requires HCA to develop a psychiatric managed care capitation risk model and submit a final draft by May 15, 2021, requires DSHS to purchase a portion of the state's long-term treatment capacity allocated to Behavioral Health Organizations (BHOs) from willing and able community hospitals, requires DSHS to enter into performance based contracts with willing and able facilities certified to provide 90 and 180-day involuntary treatment and clarifies that 90 and 180-day treatment under the Involuntary Treatment Act (ITA) may be provided at a state hospital or any willing and able community facility certified to provide such care. SSB 6573 was placed on second reading on February 8<sup>th</sup>.

*Mental Health Field Response Team:* [HB 2892](#), sponsored by Rep. Lovick, creates the mental health field response team grant program (program), administered by the Washington Association of Sheriffs and Police Chiefs and requires the Washington State Institute for Public Policy to conduct a study on whether the program improves outcomes of interactions with persons experiencing behavioral health crises. The bill passed unanimously out of the House on February 8<sup>th</sup>.

[2SSB 5970](#) sponsored by Sen. Frockt, creates a new grant-funded program based on local partnerships between law enforcement agencies and mental health providers, subject to appropriation, designate the Washington Association of Sheriffs and Police Chiefs (WASPC) as the program's implementing agency, and direct WASPC to consult with the Department of Social Health and Services' (DSHS) Research and Data Analysis office (RDA), Behavioral Health Organizations (BHOs), and Fully Integrated Managed Care Organizations to develop the program and grants must be awarded by October 1, 2018. 2SSB 5970 was placed on second reading on February 8<sup>th</sup>.

*Youth Mental Health:* [2SHB 2779](#), sponsored by Rep. Senn, is an omnibus bill that would reestablish the Children's Mental Health Work Group through the year 2020, allow provider reimbursement for supervision and partial hospitalization and intensive outpatient treatment programs, direct the Health Care Authority and the Department of Children, Youth, and Families to develop strategies for expanding home visiting, direct an advisory group to make recommendations regarding parent initiated treatment, and require the delivery of mental health instruction in two high school pilot sites. The bill was amended in House Appropriations to remove two sections of the original bill: 1) the child psychiatric residency at UW; and 2) a requirement focused on infant mental health for the department to contract with infant nurse consultants to work with child care providers caring for infants. The bill has been placed on second reading and has a proposed floor amendment that would add the UW residency position back in. 2SHB 2779 was placed on second reading on February 8<sup>th</sup>.

*Behavioral Health Facilities:* [SSB 6468](#), sponsored by Sen. Braun, authorizes the State Finance Committee (Committee) to issue up to \$500 million in general obligation bonds to finance community-based mental health facilities and to pay issuance and bond sale expenses and directs the Secretary of State to submit the bond authorization to a vote of the people. The bill was passed out of committee on February 6<sup>th</sup> and referred to Rules.

*Outpatient Behavioral Health Facilities:* [SSB 6491](#), sponsored by Sen. O'Ban, expands assisted outpatient mental health treatment (AOMHT) after April 1, 2018, to include substance use disorder treatment and renames it assisted outpatient behavioral health treatment (AOBHT), reduces eligibility criteria for AOBHT and extends and simplifies AOBHT filing processes, allows revocation to inpatient treatment for a person receiving less restrictive alternative treatment if the criteria for inpatient detention are met, allows a family member, guardian, or conservator of a person who files a court petition for review of a decision to not detain the person for involuntary treatment and to request that the court require the filing of an AOBHT petition. The bill was placed on second reading on February 8<sup>th</sup>.

*Essential Coverage:* [SB 6084](#), sponsored by Sen. Cleveland, originally aimed to require maintenance of minimum essential health care coverage. In other words, this bill would have established an individual mandate at the state level. The bill was first amended in the Senate Health & Long Term Care committee by adding on a task force to explore individual mandate enforcement mechanisms and the feasibility of other options to incentivize the maintenance of minimum essential coverage, and requires the task force to report on its findings to the legislature by December 1, 2018. The bill was further amended when it was brought to the Senate floor last week for debate and vote. The floor amendment that was adopted removed the individual mandate. At this point the bill no longer establishes an individual mandate, but instead it is a task force to look into individual mandate enforcement mechanisms. The bill was voted off the Senate floor on February 7<sup>th</sup> with a 25 – 23 vote count.

*Individual Market Access:* [HB 2408](#), sponsored by Rep Cody, would require a health carrier to offer qualified health plans in counties where it offers a health plan approved by the School Employees' Benefits Board and also reduces the premiums for enrollees in the Washington Health Insurance Pool in counties where there is no other individual market coverage available, passed out of House Appropriations last week with a vote of 19 – 13, and one without recommendation. The proposal has been placed on second reading.

*LGBTQ Long-term Care:* [SSB 5700](#), sponsored by Sen. Ranker, requires training for long-term care providers on the needs of the LGBTQ population. The bill is currently on third reading.

*Tobacco 21:* [HB 1054](#), requested by the Attorney General and the Department of Health, and sponsored by Rep Harris, raises the age at which a person may purchase and possess cigarettes, tobacco, and vapor products from 18- to 21-years of age and requires licensed retailers to display signs stating the age restriction for purchasing tobacco or vapor products. HB 1054 placed on second reading on February 8<sup>th</sup>. There are three floor amendments currently proposed: one that would change the purchase age to 19 instead of 21, and two others relating the purchase of tobacco products on tribal land by nontribal members.

*Employee Reproductive Choice Act:* [SSB 6102](#), sponsored by Sen. Ranker, makes it an unfair practice for employers to not provide its employees with contraception coverage at no cost to the employee and makes it an unfair practice for an employer not regulated by the state due to federal preemption, to not comply with the ACA and federal rules on barrier-free access to contraceptive coverage. The substitute bill was placed on second reading on February 8<sup>th</sup>.

*Drug Takeback:* [HB 1047](#), sponsored by Rep. Peterson, would require manufacturers that sell drugs into Washington to operate a drug take-back program to collect and dispose of prescription and over-the-counter drugs from residential sources. The proposal passed off the House floor on Friday with a vote of 86 – 12. There were several floor amendments proposed, but all except one were withdrawn or not considered. The one amendment that was adopted was a striker, which made several changes that are outlined in the effect statement on the last two pages of the amendment.

## **Education**

*Basic Education Provisions:* [2SSB 6362](#) –, requested by the Superintendent of Public Instruction and sponsored by Senator Wellman, is the comprehensive HB 2242 (2017) fix bill that continues to move forward this session. The bill covers per-pupil allocation reporting, K-3 class size, special education funding, regionalization, salaries, and levies. On February 6<sup>th</sup> the bill received executive action where it was significantly amended. Most changes amended into the bill were summarized by staff in [this document](#). The bill is now in the Rules Committee where it waits to be moved to second reading.

*Breakfast After the Bell:* [HB 1508](#), sponsored by Rep. Stonier, promotes student health and readiness through meal and nutrition programs (aka Breakfast After the Bell) passed off the Senate floor on January 31<sup>st</sup> with a strong bipartisan vote of 43 – 5 after passing off the House Floor on January 10<sup>th</sup> with an 83 – 15 vote count. The bill was amended in Senate Ways & Means to remove language that would limit the amount of added sugar to 25% by weight, which is not possible for schools to implement given current labeling requirements. Instead, language was added in requiring OSPI to develop guidance for low sugar foods. The amendment also removed language requiring school gardens to be “organic” after it was determined that this would be very difficult and cumbersome for

schools to implement. The House now needs to concur on these changes before the bill heads to the Governor for signature.

[SB 6003](#), sponsored by Sen. Wellman, concerns breakfast after the bell programs in certain public schools and requires high-needs schools to offer breakfast after the bell to each student beginning in the 2019-20 school year and only in years in which funding is specifically provided in a budget. The bill was voted off the Senate floor on January 19<sup>th</sup> with a 40 – 8 vote count and has been referred to the House Committee on Education.

*CTC Academic Employee Collective Bargaining*: [SSB 5993](#), sponsored by Sen. Keiser, authorizes boards of trustees of community and technical colleges to provide additional compensation to academic employees that exceeds the amount or percentage established by the Legislature. The bill was passed out of committee on February 6<sup>th</sup> and passed to Rules for second reading.

*Early Learning Levy*: [SSB 6458](#), sponsored by Sen. Billig, increases the maximum dollar amount a school district may collect through its enrichment levy by \$0.25 per \$1,000 of assessed values and requires the additional levy amount to be used exclusively for high quality early learning programs. SSB 6458 was passed out of committee on February 6<sup>th</sup> and passed to Rules for second reading.

*Evergreen Free College Act*: [2SSB 6101](#), sponsored by Sen. Ranker, Establishes the Evergreen Free College Program to provide free college tuition and fees to eligible residents seeking a bachelor's degree, associates degree, or certificate from a state institution of higher education. It establishes a six-step phase-in for the program based on when a student obtained a high school diploma, or equivalent, and their family income level. For the 2019-20 academic year, eligible students would receive an award for a free 13th year if they have graduated from high school within the past six months and have a family income that does not exceed 70 percent of the state MFI. This eligibility requirement would adjust each academic year until the 2024-25 school year, when an eligible student may receive an award for 12 academic quarters or the equivalent in semester hours if they have graduated from high school and have a family income that does not exceed the state MFI. The bill also requires development of a student success course, measurement of the impacts of the program, and establishment of an alternative grant program if appropriation levels are less than what is required for full implementation. The estimated expenditures for this bill are listed as indeterminate. The bill moved out of the Senate Ways and Means Committee on February 6th and is currently in the Rules Committee.

*Financial Aid and DACA students*: [SSB 5074](#), sponsored by Sen. Frockt, aligns residency requirements for certain state financial aid programs and includes individuals granted Deferred Action for Childhood Arrivals (DACA) status, if they meet other statutory requirements, under the term resident student, as well as establishes the term nonresident student does not pertain to certain visa holders that meet other statutory requirements regarding residency. The bill was voted off the Senate floor on January 24<sup>th</sup> with a 38 – 11 vote count and was referred to the House Committee on Higher Education on January 26<sup>th</sup>.

[3SHB 1488](#), sponsored by Rep. Hansen, expands higher education opportunities for certain students by allowing students who qualify for resident tuition under the “1079” category to be eligible for the College Bound Scholarship program. The bill placed on second reading on February 8<sup>th</sup>.

*Harassment and Bullying*: [SSB 5766](#), sponsored by Sen. Liias, requires school districts to adopt or amend a transgender student policy and procedure that incorporates a model policy and rules and

guidelines, directs school districts to designate a primary contact for the transgender student policy, with specified duties, requires development and offering of a mandatory training class for the primary school district contacts for the antiharassment, intimidation, and bullying policy and the transgender student policy, and provides for alignment of the questions in the Healthy Youth Survey with the model transgender student policy and procedure. The bill was voted off the Senate floor on January 19<sup>th</sup> with a 30 – 18 vote count. The bill received a hearing in the House Committee on Education on February 8<sup>th</sup>.

*Hunger-Free Student's Bill of Rights:* [SHB 2610](#), sponsored by Rep. Peterson, aims to reduce stigma on hungry students. The bill was amended in the House Committee on Appropriations so it no longer requires schools to serve a federally reimbursable meal even if a child has unpaid meal debt. However, the bill still prohibits public shaming tactics or other identifying strategies (such as making students do chores in exchange for a meal), and it also directs schools, districts, and OSPI to do more to enroll students in free and reduced price meals and to promote participation in Community Eligibility. The bill was passed out of committee on February 6<sup>th</sup> and has been referred to Rules.

*Lunch Co-Pays:* [SHB 2712](#), sponsored by Rep. Gregerson, originally aimed to eliminate lunch copays for students who qualify for reduced-price lunches. The bill was amended in House Appropriations to only eliminate lunch copays for grades pre-kindergarten to third grades and also requires the Office of the Superintendent of Public Instruction to develop and implement a plan to increase school participation in the Community Eligibility Provision, which provides free lunches to schools that meet certain criteria. The bill has been placed on second reading as of February 9<sup>th</sup>.

*McCleary Fix:* [SB 6352](#) - The Governor's bill to address compliance with the Supreme Court's November 15, 2017, Order. This would provide over \$600 million of the \$950 million to \$1.0 billion needed to comply with the Court Order. The remaining funds would come from reserves, with a plan to backfill those reserves with a new Carbon Tax. It is unclear if the Senate has an interest in moving this bill—or if they have their own compliance solution. It received a public hearing on February 1<sup>st</sup> but has not been scheduled for exec. This bill is likely considered NTIB.

*Opioid Medications:* [2SHB 2390](#), sponsored by Rep. Pollet, allows kindergarten through twelfth grade (K-12) schools to obtain, maintain, and administer opioid overdose medication through a standing order from a health care practitioner for the purpose of assisting a person at risk of experiencing an opioid related overdose. The bill includes provisions related to K-12 school opioid-overdose policies, staff trainings, and liability. It also requires certain public institutions of higher education to develop plans for the maintenance and administration of opioid overdose medication in and around the residence halls. 2SHB 2390 was placed on second reading on February 8<sup>th</sup>.

## **Public Safety**

*Body Cameras:* [SB 6408](#), sponsored by Sen. Padden, removes expiration dates, making current requirements and Public Records Act (PRA) provisions governing worn cameras permanent and applicable to all law enforcement and corrections agencies deploying body worn cameras, adds a definition of intimate images as it relates to body worn camera recordings, and clarifies records retention requirements for body worn camera recordings. SB 6408 passed unanimously out of the Senate on February 8<sup>th</sup> and has been scheduled for a public hearing in the House Judiciary Committee on February 15<sup>th</sup>.

*Closing Loopholes:* [SSB 6297](#), sponsored by Sen. Dhingra, allows restriction of firearm possession by people who have been found incompetent to stand trial and who have a history of one or more violent acts. The bill has been referred to the Rules Committee for second reading. [SB 6298](#), sponsored by Sen. Dhingra, adds domestic violence harassment to the list of offenses for which a person is prohibited from possessing a firearm. The bill was voted off the Senate floor on February 9<sup>th</sup> with a 34 – 13 vote count. [SSB 5441](#) allows the temporary restriction of firearm rights for individuals detained for 72 hours under the mental health involuntary treatment act. This bill has been referred to the Rules Committee where it waits to be placed on second reading.

*Domestic Violence:* [HB 2457](#), sponsored by Rep. Goodman, specifies timeframes for which domestic violence no-contact orders entered as a condition sentence remain in effect and extends the maximum time that a superior court may suspend a non-felony domestic violence sentence to five years. HB 2457 passed unanimously out of the House on February 8<sup>th</sup>.

*DNA Samples:* [SHB 2331](#), sponsored by Rep. Orwall, addresses the collection of DNA biological samples and applies the DNA collection and analysis law to persons convicted under a municipal ordinance that is equivalent to a state criminal statute for which DNA is collected upon conviction. The bill was placed on second reading by the Rules Committee February 6<sup>th</sup>.

*Driving While License Suspended 3e:* [HB 2481/SSB 6189](#), sponsored by Sen. Fain and Rep. Graves, reclassifies Driving a Motor Vehicle with a Suspended or Revoked Driver's License in the third degree from a misdemeanor criminal offense to a civil traffic infraction. SSB 6189 currently awaits executive action in the Senate Transportation Committee and HB 2481 awaits executive action in the House Public Safety Committee. These bills have been deemed NTIB.

*Pistol License Returned:* [HB 2519](#), sponsored by Rep. Lovivk, ensures a thorough background check and victim notification process is followed before a concealed pistol license is returned. HB 2519 was placed on second reading on February 6<sup>th</sup>.

*Electronic Monitoring:* [SB 6292](#), sponsored by Sen. Wilson, defines electronic monitoring to include electronic monitoring with victim notification technology (EMVNT) that is capable of notifying a victim or protected party if the monitored individual is nearby, requires the Administrative Office of the Courts to develop a list of vendors that can provide EMVNT and an informational handout for victims on the availability of EMVNT and, to the extent funds are appropriated, provide funding to counties to cover the cost of EMVNT. The bill also gives state and local government immunity from liability for the utilization of EMVNT unless it acted with gross negligence or in bad faith. The bill was voted off the Senate Floor on February 9<sup>th</sup> with a 46 – 0 vote count and has been scheduled for a public hearing in the House Committee on Public Safety on February 15<sup>th</sup>.

*Enhanced Assault Weapon Background Checks:* [SSB 5444](#), sponsored by Sen. Frockt, requires that people be 21 years old and pass an enhanced background check to own an assault weapon. The bill currently awaits action in the Senate Ways and Means Committee.

*First Informer Broadcasters:* [SHB 2415](#), sponsored by Rep. Chapman, requires the Military Department Emergency Management Division to authorize a private entity to establish a program for certifying first informer broadcasters and requires state and local governments to allow certified first informer broadcasters access to areas affected by emergencies in some circumstances. The bill was voted off the House floor on February 8<sup>th</sup> with a 95 – 2 vote count.

*Immigrant Crime Victim Participation:* [SHB 1022](#), sponsored by Rep. MacEwen, requires law enforcement agencies and other entities to complete victim certifications for U and T nonimmigrant visa applications for qualifying victims of certain crimes. The bill was voted off the House floor on January 18<sup>th</sup> with a 95 – 1 vote count. It received a public hearing in the Senate Committee on Law and Justice on February 7<sup>th</sup> and is scheduled for executive session on February 15<sup>th</sup>.

*Immunity from Prostitution Offenses:* [SHB 2361](#), sponsored by Rep. Pellicciotti, provides immunity from prosecution for prostitution if the evidence for the charge was obtained as a result of a person seeking emergency assistance in certain circumstances. The bill was voted off the House floor on February 9<sup>th</sup> with a 96 – 2 vote count and has been scheduled for a public hearing in the Senate Committee on Law & Justice on February 16<sup>th</sup>.

*Machine Gun Loophole -- Trigger Modification Devices:* [SB 5992](#), sponsored by Sen. Van de Wege, closes the machine gun loophole by prohibiting bump stocks designed to accelerate a firearm's rate. The bill was voted off the Senate floor on January 25<sup>th</sup> with a 29 – 20 vote count. The bill then received a public hearing in the House Committee on the Judiciary on February 9<sup>th</sup> and has been scheduled for executive session February 14<sup>th</sup>.

*Modifying Rape Offense:* [HB 2465](#), sponsored by Rep. Orwall, modifies the crime of Rape in the third degree by removing the language requiring that lack of consent was clearly expressed by the victim's words or conduct. Instead, a person commits Rape in the third degree when such person engages in sexual intercourse with another person where the victim did not consent to sexual intercourse with the perpetrator or where there is threat of substantial unlawful harm to the property rights of the victim. The bill passed unanimously out of the House on February 8<sup>th</sup> and has been scheduled for a public hearing in the Senate Committee on Law & Justice on February 16<sup>th</sup>.

*No-Contact Violations:* [SHB 2466](#), sponsored by Rep. Orwall, includes no-contact orders issued in Promoting Prostitution and Trafficking cases in the list of orders to which the warrantless arrest statute applies. The bill passed unanimously out of the House on February 7<sup>th</sup> and has been scheduled for a public hearing in the Senate Committee on Law and Justice on February 16<sup>th</sup>.

*Patronizing a Prostitute/Sexual Exploitation:* [SHB 2360](#), sponsored by Rep. Pellicciotti, renames the crime of "Patronizing a Prostitute" to "Sexual Exploitation" and raises the classification for any second or subsequent conviction for the crime of Sexual Exploitation from a misdemeanor to a gross misdemeanor. The bill passed unanimously out of the House on February 8<sup>th</sup> and has been scheduled for a public hearing in the Senate Committee on Law and Justice on February 16<sup>th</sup>.

*Repealing the Death Penalty:* [SB 6052](#), sponsored by Rep. Walsh, eliminates the death penalty and provides that all persons convicted of Aggravated First Degree Murder must be sentenced to life in prison without the possibility of release or parole. The bill has been passed to the Rules Committee for second reading as of January 26<sup>th</sup>.

*Reviewing Sexual Predatory Standards:* [SB 6217](#), sponsored by Sen. Dhingra, provides review standards for the court to follow in determining whether to order a full evidentiary hearing on whether to order the unconditional discharge or conditional release (CR) to a less restrictive alternative (LRA) of a person committed as a sexually violent predator (SVP). The bill has been referred to the Rules Committee for second reading.

*Sentencing Laws and Practice:* [4SHB 1789](#), sponsored by Rep. Jinkins, requires the Sentencing Guidelines Commission to conduct a comprehensive review of the Sentencing Reform Act and make recommendations to the Legislature and Governor. The house bill was passed out of committee on February 6<sup>th</sup> and has been referred to Rules.

*Sexual Assault, Statute of Limitations:* [HB 1155](#), sponsored by Rep. Griffey, eliminates the statute of limitations for felony sexual offenses, including rape in the first and second degrees, child molestation and sexual exploitation of a minor. The bill was voted off the House floor on February 8<sup>th</sup> with a 90 – 8 vote count.

*Sexual Harassment Unified Table:* [HCR 4413](#), sponsored by Rep. Tarleton, creates a unified table on sexual harassment and establishing a sexual harassment work force. The task force will be made up of eight legislators (representing the four corners), four lobbyists and one representative each from the Office of the Secretary of the Senate and the Chief Clerk of the House. It was adopted in the House on January 18<sup>th</sup> and has been placed on the Senate’s second reading calendar.

*Sexual Harassment Public Records:* [SHB 2778](#), sponsored by Rep. Jinkins, expands the public records exemptions to include personal information of an agency employee who makes a sexual harassment claim and requests that their information not be disclosed and subjects a person to civil liability who requests and obtains the personal information of an agency employee who makes a sexual harassment claim if the requestor uses the information to harass, stalk, threaten, or intimidate the employee. The bill passed unanimously out of the House on February 7<sup>th</sup>. The bill has been referred to the Senate Committee on State Government, Tribal Relations, and Elections.

*Suicide Prevention/Voluntary Waiver:* [SSB 5553](#), sponsored by Sen. Pedersen, is a suicide prevention policy that allows people to sign a voluntary waiver of firearms rights. Among other things, it requires entry of the voluntary waiver into the Washington State Patrol electronic database and prohibits transfer of a firearm to a person with a voluntary waiver in effect. The bill passed unanimously out of the Senate on January 24<sup>th</sup>. In the House, the bill received a public hearing in the Committee on the Judiciary on February 9<sup>th</sup> and has been scheduled for executive session on February 14<sup>th</sup>.

*Vacating Criminal Convictions:* [SHB 2890](#), sponsored by Rep. Hansen, modifies the process for obtaining a certificate of discharge and expands eligibility criteria for vacating criminal convictions. The bill was referred to the Rules Committee on February 2<sup>nd</sup>.

## **General Government**

*Capital Gains Tax and Property Tax Relief:* [HB 2967](#), sponsored by Rep. Lytton, would enact a capital gains tax and trim down the property tax hike enacted during the 2017 session to fund McCleary. It has been scheduled for a public hearing in the House Committee on Finance on February 16<sup>th</sup>.

*Distributed Energy Resource Planning:* [ESHB 1233](#), sponsored by Rep. Morris, authorizes an electric utility to develop an annually updated, Distributed Energy Resources Plan. The bill was voted off the House floor on February 8<sup>th</sup> with a 96 – 2 vote count.

*Electrical Billing:* [SSB 5624](#), sponsored by Sen. Hasegawa, requires each electric utility to provide either written or electronic notice of public hearings where changes in electricity rates will be considered or approved by the Utilities and Transportation Commission (UTC) or governing body and

requires that an electric utility must disclose the local tax rate imposed on the electric utility by a city or town on each billing statement. SSB 5624 has been placed on the second reading consent calendar.

*Internet Privacy:* [SSB 5919](#), sponsored by Sen. Ranker, requires broadband Internet providers to obtain opt-in consent to sell or transfer certain customer information and requires broadband Internet providers to obtain opt-in consent to send or display an advertisement to a customer based on certain customer information. SSB 5919 was passed out of committee on February 1<sup>st</sup> and has been passed to the Rules Committee for second reading.

*Net Neutrality:* [SHB 2282](#), sponsored by Rep. Hansen, prohibits Internet providers from engaging in certain types of conduct in the provision of service and requires Internet providers to make certain disclosures related to service. The bill was voted off the House floor on February 9<sup>th</sup> with a 93 – 5 vote count.

*Small Cell Deployment:* [SHB 2592](#), sponsored by Rep. Morris, creates a designation process for local governments that demonstrate investment readiness for small cell infrastructure. The bill has been referred to Rules for review.

[2SSB 5935](#), sponsored by Sen. Sheldon, requires cities and towns to enact an ordinance for issuing master permits for siting and installing small cell facilities, creates the Governor's Office on Broadband Access, authorizes certain public utility districts (PUDs) to provide end user internet services on the PUD's broadband network, and authorizes certain port districts to provide wholesale internet services. The bill was placed on second reading on February 8<sup>th</sup>.

## **Environment**

*Alternate Electricity and Natural Gas Regulation:* [SSB 6424](#) / [SHB 2839](#), sponsored by Sen. Carlyle, requires the Utilities and Transportation Commission (UTC) and electrical and gas companies to consider a greenhouse gas (GHG) planning adder when evaluating and establishing conservation policies, programs, and targets, defines GHG planning adder, and authorizes the UTC to consider alternative forms of regulation (AFORs) when energy utilities seek to recover costs incurred on behalf of customers. SHB 2839, sponsored by Rep. Morris, requires electrical companies, gas companies, and the Utilities and Transportation Commission (UTC) to use a greenhouse gas (GHG) planning adder when evaluating and selecting conservation policies, programs, and targets, requires the UTC to use the GHG planning adder in evaluating integrated resource plans and intermediate-term and long-term resource options selected by electrical and gas companies, and authorizes the UTC to regulate an electrical or gas company under an alternative form of regulation. SSB 6424 was placed on second reading on February 8<sup>th</sup>. SHB 2839 was voted off the House floor on February 9<sup>th</sup> with a 64 – 34 vote.

*Carbon Pricing:* [SSB 6203](#), requested by Governor Inslee and sponsored by Sen. Carlyle, was voted out of the Senate Committee on Energy, Environment & Telecommunications on February 2<sup>nd</sup>. The substitute bill would impose a \$10 tax per metric ton which would increase by \$2 per ton until a cap of \$30 per ton is reached. The bill is considered NTIB. We anticipate that the bill will receive action in the Senate Ways and Means Committee next week.

*Clean Energy Investments:* [SHB 2283](#), sponsored by Rep. DeBolt, suspends the 15 percent annual renewable resource target under the Energy Independence Act beginning January 1, 2028 and requires that electric utilities use electricity generated by clean energy resources to meet any new energy or

capacity need beginning January 1, 2028. It also establishes tax preferences for certain renewable energy and carbon reduction investments. Though the bill did not move out of the House Finance Committee, it is considered NTIB.

*Energy Efficiency:* [SHB 2931](#), sponsored by Rep. Doglio, establishes a lower efficiency, intermediate efficiency, and high efficiency option for the State Energy Code for residential structures beginning with the 2018 code cycle. The bill passed out of committee February 1<sup>st</sup> and was referred to Rules.

*Energy Independence Act:* [SHB 2402](#), sponsored by Rep. Tarleton, extends the requirement to pursue all available conservation that is cost-effective, reliable, and feasible under the Energy Independence Act (EIA) to small utilities and natural gas utilities. For consumer-owned utilities, the bill adds additional annual renewable resource targets under the EIA of at least 15% of the average of the average of their 2019 2020 loads beginning January 1, 2021, and each year thereafter. For investor owned utilities, the bill adds additional renewable resources targets of: at least 20% of their load by 2025; at least 30 percent by 2030; at least 40 percent by 2035; and 50 percent by 2040. It further prohibits each consumer-owned utility, small utility and market customer from meeting any new energy or capacity needs with certain generation resources. The bill was placed on second reading on February 9<sup>th</sup>.

*Fuel Content Standards:* [SHB 2757](#), sponsored by Rep. Doglio, amends the state Renewable Fuel Standard (RFS) to require that all diesel fuel sold or offered for sale in Washington for use in motor vehicles upon highways of the state must contain at least 5 percent biodiesel by volume beginning January 1, 2019 and amends or repeals certain provisions of the Motor Fuel Quality Act. SHB 2757 has been placed on second reading.

*Net Metering:* [SHB 2510](#), sponsored by Rep. Morris, increases the maximum capacity of systems eligible for net metering to 1,000 kilowatts, requires an electric utility to offer to make net metering available to eligible customer-generators until the cumulative generating capacity of net metering systems equals 2.5% of the utility's peak demand during 1996, and requires an electric utility that reaches its cumulative net metering generating capacity threshold to first engage in a distributed energy resources planning process that accomplishes certain goals before offering an alternative to net metering.. The bill has been placed on second reading.

[SSB 6081](#), sponsored by Sen. Palumbo, increases the 0.5% minimum threshold to 6% for the cumulative generating capacity that a utility must make available for net metering systems, requires, as of March 31<sup>st</sup>, any remaining unused kilowatt-hour (kWh) credit generated for the calendar year to be used to assist low-income residential utility customers, and requires electric or gas utilities to include on customer bills the total amount of kWh of electricity consumed for the most recent 12-month period. The bill was placed on second reading on February 8<sup>th</sup>.

*Oil Transportation Safety:* [SSB 6269](#), sponsored by Sen. Ranker, applies the barrel tax to crude oil received by pipeline, requires the Department of Ecology (Ecology) to review, assess, and provide a report on vessel traffic safety in northern Puget Sound, requires Ecology to establish the Salish Sea Shared Waters forum, requires Ecology to update contingency plan rules to address situations where oils may sink or submerge in water, and authorizes Ecology to require at least one joint large-scale, multiple plan equipment deployment drill of onshore and offshore facilities and covered vessels, every 3 years. The bill was referred to Ways and Means.

*On-Bill Repayment:* [SHB 2410](#), sponsored by Rep. Doglio, requires each electric utility, except for a small utility or a retail electric cooperative, to offer an on-bill repayment program option to its retail electric customers beginning January 1, 2020. The bill has been referred to Rules.

*Optional Alternative Energy Purchases:* [HB 2413](#), sponsored by Rep. Doglio, requires each electric utility to provide the voluntary option to purchase qualified alternative energy resources to each of its new retail electric customers at the time service is established and to provide the option to its existing customers through its website and through quarterly mailings and requires the Department of Commerce and the Utilities and Transportation Commission to jointly report findings and recommendations to the energy committees of the Legislature on best practices and policies for electric utilities to develop green tariffs or similar qualified alternative energy resource options for their retail electric customers. SHB 2413 was placed on second reading on February 8<sup>th</sup>.

*Pollution Liability Insurance:* [SHB 2872](#), sponsored by Rep. Peterson, establishes an aggregate limit of \$15 million per calendar year for pollution liability direct insurance provided by the Pollution Liability Insurance Agency. The bill was referred to Rules for review on February 6<sup>th</sup>.

*Reclaimed Water:* [SHB 2743](#), sponsored by Rep. Springer, requires a reclaimed water permit applicant or permittee to enter into certain written agreements with a Group A public water system before the applicant or permittee may use, store, or deliver reclaimed water within the service area of the Group A public water system, requires the written agreements between the reclaimed water permit applicant or permittee and the Group A public water system to address, among other subjects, protection of groundwater quality and other water resource, an identification of the areas in which reclaimed water will be provided, and rates and charges for reclaimed water and establishes a dispute resolution process in which a Group A public water system and a reclaimed water permit applicant or permittee may petition the Secretary of the Department of Health for a decision in the event the parties are not able to reach an agreement. SHB 2743 was referred to Rules on February 2<sup>nd</sup>.

*Renewable Energy Incentives:* [SHB 2281](#), sponsored by Rep. Morris, specifies that no Renewable Energy Cost Recovery Incentive Payment Program customer who recertifies their renewable energy system with the Washington State University Extension Energy Program (WSU Energy Program) may continue to receive incentive payments if the cumulative dollar amount of incentive payments made to the customer exceeds 100 percent of the total price of the renewable energy system, requires the WSU Energy Program to collect applicable system price data from each person or community solar project administrator applying for recertification under the Renewable Energy Production Incentive Program, establishes that only applicants whose systems were installed and operational after July 1, 2010, must provide system operation data such as global positioning system coordinates, tilt, estimated shading, and azimuth when applying to the WSU Energy Program for recertification, and authorizes the WSU Energy Program to waive the requirement to provide applicable system data when extraordinary circumstances exist that result in an unreasonable burden to the applicant. HB 2281 was passed out of Appropriations on February 6<sup>th</sup> and referred to Rules for review.

*Renewable Energy Standards:* [SSB 6253](#), sponsored by Sen. Ranker, establishes a clean, efficient, renewable energy standard. The bill would require all electric utilities and market customers to reduce total number of megawatt hours from fossil fuel generating resources with specific target dates for achieving progress and establishes fines for non-compliance. It also requires all electric utilities to eliminate from electric rates all costs associated with coal-fired generation by January 1, 2030.

*Solar Gardens:* [SHB 2280](#), introduced by Rep. Morris, authorizes an electric utility to submit a community solar garden plan to the Utilities and Transportation Commission or to its appropriate governing authority in order to operate a community solar garden program, requires an electric utility to first engage in a distributed energy resources planning process before developing a community solar garden plan, and establishes requirements for community solar gardens. SHB 2280 was placed on second reading on February 8<sup>th</sup>.

*Toxic Chemicals:* [SSB 6413](#), sponsored by Sen Van De Wege, prohibits the sale, manufacture, and distribution of firefighting foam that has perfluoroalkyl and polyfluoroalkyl chemicals (PFAS) intentionally added, requires sellers of firefighting personal protective equipment (PPE) containing PFAS, to notify purchasers of the equipment, and makes a violation of the act subject to a civil penalty not to exceed \$5000 for each first offense and up to \$10,000 civil penalty for subsequent violations. The bill passed off the Senate floor on February 10<sup>th</sup> with a 39 – 8 vote count.

*Transportation Electrification:* [SSB 6187](#), sponsored by Sen. Palumbo, authorizes the governing bodies of a municipal utility or a public utility district commission to adopt a transportation electrification plan that, at a minimum, establishes a finding that utility outreach and investment in the electrification of transportation infrastructure is cost-effective to ratepayers. The bill was placed on second reading on February 8<sup>th</sup>.

[HB 2897](#), sponsored by Rep. Morris, requires the governing authority of a municipal electric utility or the commission of a public utility district to engage in a distributed energy resources planning process that accomplishes certain goals before developing a transportation electrification plan and authorizes the governing authority of a municipal electric utility or the commission of a public utility district to offer programs in the electrification of transportation for its customers if it makes a cost-effectiveness determination in accordance with a transportation electrification plan. The bill was referred to Rules for review on February 2<sup>nd</sup>.

*Transportation Fuel Emissions:* [2SHB 2338](#), sponsored by Rep. Fitzgibbon, directs the Department of Ecology (Ecology) to adopt a rule establishing a Clean Fuels Program to limit the greenhouse gas emissions per unit of transportation fuel energy to 10 percent below 2017 levels by 2028; excludes exported fuel, fuel used by vessels, railroad locomotives, and aircraft, and certain other categories of fuel from the Clean Fuels Program requirements; requires the Clean Fuels Program to include processes for the tracking of compliance obligations and bankable, tradeable credits; requires annual reporting by Ecology on the Clean Fuels Program, as well as an analysis of the program's first five years by the Joint Legislative Audit and Review Committee; and retains the current distribution of revenue under the 2015 Transportation Revenue Package, eliminating changes that would have been triggered as a result of legislative enactment of a Clean Fuels Program. 2SHB 2338 was referred to Rules for review on February 7<sup>th</sup>.

*Underground Storage:* [SB 6159](#), requested by the Department of Ecology and sponsored by Sen. Takko, extends the expiration date for the state Underground Storage Tank program from 2019 to 2029. SB 6159 was voted out of the Senate Committee on Energy, Environment and Technology on January 18<sup>th</sup> and has been passed to the Rules Committee for second reading.

*Vehicle Fuel Standards:* [HB 2328](#), sponsored by Rep. Morris, adopts California vehicle standards for zero-emission vehicles and for medium duty trucks. The bill was referred to Rules for review on February 6<sup>th</sup>.

## **Transportation**

*Alaskan Way Viaduct:* [HB 2741](#), sponsored by Rep. Clibborn, establishes that tolls must be used to repay the transportation partnership account for any amounts transferred from the transportation partnership account to the highway bond retirement fund. HB 2741 was placed on second reading on February 9<sup>th</sup>.

*Autonomous Vehicle Working Group:* [SHB 2970](#), sponsored by Rep. Hudgins, tasks the Washington State Transportation Commission with convening an agency work group to develop policy recommendations to address the operation of autonomous vehicles (AVs) on public roadways in the state and requires an annual report to the Governor and the appropriate legislative committees, including recommendations on proposed modifications to state law and rules to address the emergence and deployment of AV technology in the state. The bill passed out of the House Committee on Transportation on February 6<sup>th</sup> and was referred to the Rules Committee.

*Electric Bicycles:* [SHB 2782/SSB 6434](#), sponsored by Rep. Kilduff and Sen. Rolfes, concerns electric-assisted bicycles, both bills have been substituted and contain amendments. SB 6434 was amended on the to provide state agencies and local jurisdictions the authority to regulate the use of both class 1 and class 2 electric-assisted bicycles and motorized foot scooters on facilities and properties under their jurisdiction and control. The adopted amendment also requires local regulation of electric-assisted bicycles to be consistent along the entire length of a shared use path that crosses two or more jurisdictional boundaries in order for the local regulation to be enforceable. SSB 6434 was voted off the Senate floor on February 9<sup>th</sup> with a 44 – 2 vote count. SHB 2782 was referred to Rules on February 6<sup>th</sup>.

*RTA Adjustment:* [SSB 5955](#), sponsored by Sen. Kuderer, requires a regional transit authority (RTA) to implement a market value adjustment program, which calculates a credit on motor vehicle excise taxes and requires the RTA to implement the program in a manner that allows the delivery of the system and financing plan approved by the RTA's voters to the extent practicable. The bill was placed on second reading on February 8<sup>th</sup>.

*Street Maintenance:* [SSB 6576/HB 2948](#) were sponsored by Sen. Mullet and Rep. Graves. HB 2948 raises the population threshold, at which a city or town must assume additional responsibility for streets within its boundaries that are also part of the state highway system, from 25,000 to 35,000. SSB 6576 raises from 25,000 to 27,500 the population threshold at which cities and towns must take over maintenance responsibilities of their streets that are part of the state highway system and phases in three additional increases every five years up to a 35,000 population threshold by 2033. HB 2948 was placed on second reading on February 8<sup>th</sup>. SSB 6576 has been referred to Rules Committee for second reading.

*Transit-Only Lane Enforcement Cameras:* [SHB 2403](#), sponsored by Rep. Fitzgibbon, allows local governments to enact an ordinance allowing for the use of transit-only lane enforcement cameras. The bill has been referred to the Rules Committee.

*Transportation Network Companies:* [SB 6043](#), sponsored by Sen. Hobbs, provides statewide uniform regulation for transportation network companies. SB 6043 was passed to Rules for second reading on February 6<sup>th</sup>.

## **Looking Ahead**

Council Lobby Day has been scheduled for Thursday, February 15<sup>th</sup>. We are actively scheduling legislator meetings, so be sure to finalize your attendance with OIR if you have not done so already.

As we get closer to the house of origin cutoff on February 14<sup>th</sup>, we are also getting closer to when we expect to see the first supplemental budget proposal. The next quarterly revenue forecast will come out on February 15<sup>th</sup> according to the Economic and Revenue Forecast council's website. The first budget proposal usually follows shortly after the forecast comes out, so we are likely to see budget proposals from both chambers the week of February 19<sup>th</sup>.
