# Council actions to SDOT 2021 budget

- Seattle City Council approved changes to the 9-year Move Seattle category spending, Council Bill 119930
- Seattle City Council made several amendments to revise the budget transmitted to by the Mayor's Office, including the following changes to the Levy portfolio:



### **Budget updates:** Vehicle License Fees


- Existing \$60 VLF I-976 was rejected by Washington Supreme Court
  - Enables programming of \$60 VLF, totaling \$23.7M in one-time funds for projects in support of transit, SDOT-wide
- New \$20 VLF Council has authorized collection of a new \$20 VLF via the 2021-22 Budget Ordinance
  - Will be programmed following stakeholder/community outreach for recommendations as to how the resources should be programmed
  - Estimated collection of \$3.6M in 2021 and \$7.2M in 2022

#### **Recommendations:** Safe Routes



- Recommend restart of 2 Vision Zero projects
- Safe Routes to School is on track to meet target
- Bike Safety is on track to meet 2018 target; most paused projects are in early planning/ design phase

## Recommendations: Maintenance & Repair



- No changes recommended to 7 paused projects
- Arterial paving (AAC) program
  - No longer on track to pave 162.5 lane-miles (2018 target)
  - Select reductions to 4 contractor projects (\$31.7M): not in construction, without grants, and can minimize impacts to SDOT crews
- Stairway Maintenance (3 projects)
  - On track to meet target of 5 rehab projects per year



## **Recommendations:** Congestion Relief



- Restart 23<sup>rd</sup> Ave project
- Restore funding for Route 7 sidewalks
- Restart other sidewalk projects (program \$)
- Defer Fauntleroy Blvd and Graham St
- Freight Spot and Transit
   Spot on track

# Other recommendations highlights

- Implement racial equity analysis recommendations to better incorporate equity considerations in prioritization
- Consider Neighborhood Street Fund (cycle 3) and \$60 vehicle license fee to fund \$6M in restorations
- Prioritize annual program investments in communities with greatest COVID-19 impacts
- No changes recommended to programmatic reductions (unspecified projects)
