
We believe that SBAB's objective is aligned with several key Seattle initiatives. We look forward to helping your administration achieve the goals set forth in the following plans:

- Seattle's Climate Action Plan: Your interest in decarbonizing transportation in Seattle is of utmost importance. SBAB believes transportation that prioritizes people riding bikes fits seamlessly into that goal. Hand in hand with your commitment to increase E-Bike usage, our residents need multimodal transportation infrastructure that prioritizes bikes and pedestrians over cars in order to achieve our Climate Action goals.
- **Vision Zero:** Seattle has a goal of ending traffic deaths and serious injuries by 2030. According to a recent <u>KUOW analysis of SDOT data</u>, "Seattle's pedestrian fatality rate was 150% higher in the five years after the launch of Vision Zero compared to the five years before." This is unacceptable. We look to you and your administration to take immediate and intentional action to reverse the upward trajectory of traffic deaths and serious injuries. SBAB is here to support your efforts towards achieving Vision Zero.
- Seattle's 2019-2024 Implementation Plan to the Bicycle Master Plan: The safety of our active transportation network is only as good as the weakest sections. Our neighbors in historically underserved areas have been deeply impacted by the inequitable allocation of resources for far too long. We call on you to deliver and execute on the Bike Master Plan while renewing the City's commitment to equitable infrastructure by implementing the strategies outlined in the Transportation Equity Framework.
