

**SEPA MITIGATED DETERMINATION OF NON-SIGNIFICANCE (MDNS)
SEATTLE DEPARTMENT OF TRANSPORTATION
NORTHGATE PEDESTRIAN AND BICYCLE BRIDGE PROJECT**

Description of proposal: SDOT is proposing to build a pedestrian/bicycle bridge over Interstate 5 (I-5) and pedestrian and bicycle facilities along 1st Ave NE in the Northgate neighborhood of Seattle, WA.

Location of proposal including street address, if any: The project will be located in the Northgate area of Seattle, WA generally bounded by College Way N on the west, First Avenue NE on the east, Northgate Way on the north and N 92nd Street on the south. This project area is bisected by I-5.

Lead Agency: SDOT

SDOT has determined that this proposal would not have a probable significant adverse impact on the environment. An environmental impact statement (EIS) is not required under RCW 43.21C.030(2)(c). There is no comment period.


