RAINIER VALLEY NEIGHBORHOOD SAFETY IMPROVEMENTS

In June, the Seattle Department of Transportation (SDOT) hosted a public meeting and gathered valuable input on building an east-west neighborhood greenway in Rainier Valley from the John C. Little, Sr. Park to Seward Park Avenue S. From the input we received and the evaluation, we recommend a neighborhood greenway on:

- 37th Avenue S between the Chief Sealth Trail/ John C. Little, Sr. Park and S Willow Street
- S Willow Street between 37th Avenue S and 52nd Avenue S
- 52nd Avenue S between S Willow Street and S Holly Street
- S Holly Street between 52nd Avenue S and the Martha Washington Park / 57th Avenue S

The recommended improvements (shown on the map) include traffic calming, stop signs, wayfinding signs, sharrow pavement markings, reducing the speed limit from 25 MPH to 20 MPH and pavement and sidewalk repairs.

Seattle is building a network of neighborhood greenways. Neighborhood greenways are safer, calmer residential streets for you, your family and neighbors. On streets with low car volumes and speeds a greenway can:

- Improve safety
- Help people cross busy streets
- Discourage cut-thru traffic
- Protect the residential character of our neighborhoods
- Keep speeds low
- Get people to where they want to go like parks, schools, shops and restaurants

This is the second of two public meetings. The first meeting shared traffic data and helped SDOT staff understand where people want to walk and bike and barriers to doing so. Please attend our September open house. We are interested in your feedback.
