

**SEPA DETERMINATION OF NON-SIGNIFICANCE (DNS)
SEATTLE DEPARTMENT OF TRANSPORTATION
VISION ZERO 35TH AVENUE SW AND SW ROXBURY STREET ROAD SAFETY CORRIDOR PROJECT**

Description of proposal: As part of the Vision Zero Safety initiative SDOT proposes to re-channelize SW Roxbury Street between 17th and 35th Avenues SW and 35th Avenue SW between SW Roxbury and SW Willow Streets. Re-channelized road sections will have one lane of travel in each direction and a center turn lane. On SW Roxbury Street SDOT will pave the roadway between 17th and 18th Avenues SW, install curb ramps, upgrade existing push buttons with new accessible pedestrian signal style push buttons at 17th Avenue SW, paint curbs at Delridge Way SW/SW Roxbury St/16th Ave SW, install signs to clarify the left turn movement from 4th Avenue SW to westbound SW Roxbury Street, install transit lanes between 25th and 30th Avenue SW and bike lanes between 18th and 24th Avenues SW and 30th and 35th Avenues SW. New speed and safety signs and lane markers will be added at selected sites throughout the corridor. Traffic signal heads and in-pavement vehicle detections will be adjusted for the new lane alignments. Signals will be synchronized for reduced speed limits.
