





Uptown / Lower Queen Anne Neighborhood Intercept Survey

Conducted for the Seattle Department of Transportation November 2017

Survey Overview

Purpose and Methodology Overview

- To better understand behaviors among people visiting and working in Lower Queen Anne.
- An intercept survey was conducted over a two week period. Interviewers were stationed at key intersections during weekdays and administered a brief survey to pedestrians passing by.

Objectives

- Gauge the general frequency and length of stay of visitors.
- Investigate the key reasons for visiting.
- Understand how visitors travel to/from Lower Queen Anne and parking behaviors of those who drive or carpool.
- Identify ways the City can help to sustain and improve visitation to the area.
- Quantify the demographic characteristics of visitors to the area.

Definitions

- Throughout this report the term "Visitors" refers to respondents who do not live nor work in Lower Queen Anne.
- The term "Workers" refers to respondents who work in Lower Queen Anne, but do not live there.
- The term "respondents" refers to all respondents regardless of their live / work situation.

Key Findings (1)

- **Residency**: Over one-third (37%) of survey respondents are "visitors", that is they neither live nor work in Lower Queen Anne.
- Mode Share: Overall, forty-one percent of respondents walked to get to Lower Queen.
 Anne making this the most commonly used travel mode.
 - 25% of respondents took a buss, and
 - 15% drove alone
 - **<u>Driving</u>**: Just under half (46%) of respondents who drive alone state the reason they choose to do so was because transit takes too long or is inconvenient.
 - ♦ Sixty-four percent of people who drive (alone or in carpool) parked in in an on-street parking spot.

Key Findings (2)

- <u>Trip Purpose</u>: Aside from residing in the neighborhood, working, shopping, and eating out are the most commonly mentioned primary reasons for being in Lower Queen Anne.
- Spending: Eighty-two percent of respondents plan on spending money while in the area.
 - The average anticipated spend is \$41.67
 - Visitors typically spend the most money (\$56.60) while in the area and workers the least (\$16.87).
 - Those who use a personal vehicle area likely to have the highest spend (\$49.30).


Methodology

- A total of 490 interviews were completed in the University District with an overall margin of error of +/-4.4% at the 95% confidence level.
- Two-interviewers were on-site to distribute and collect single page paper surveys and help respondents as needed. Interviewing took place over two the following dates and times (all in 2017).

 - Fri, Oct 6: 5pm-9pm Queen Anne Ave N & Mercer St (45 completes)
 - Sat, Oct 7: 12pm-4pm 1st Ave N & Mercer St (49 completes)
 - Sun, Oct 8: 10am-2pm Queen Anne Ave N & Mercer St (41 completes)
 - ♦ Tue, Oct 10: 12pm-4pm 1st Ave N & Mercer St (26 completes)
 - Wed, Oct 11: 12pm-4pm Queen Anne Ave N & Republican St (49 completes)
 - Thu, Oct 12: 12pm-4pm Queen Anne Ave N & Mercer St (37 completes)
 - Sat, Oct 14: 5pm-9pm Queen Anne Ave N & Republican St (64 completes)
 - ♦ Sun, Oct 15: 12pm-4pm Queen Anne Ave N & Mercer St (55 completes)
- Periods of inclement weather impacted response rates at times.
- Surveys were available in English only.

- The report makes reference to those who use a personal vehicle to get to the area. This includes people who drive alone as well as those drive alone as well as those who carpool.


Living and working in Lower Queen Anne

Neighborhood Residence

Overall forty-four percent of respondents live in Lower Queen Anne.

- 6 percent both live and work in Lower Queen Anne, and
- 38 percent live, but do not work in the area.


Over one-third (37%) of respondents are visitors, that is they neither live nor work in Lower Queen Anne.



Distance From / Housing Tenure near Intercept Location

Seven out of ten residents (those indicating they live in Lower Queen Anne) live within 5 blocks of 1st Ave and Mercer.

Over half (56%) of residents have lived in Lower Queen Anne for less than 5 years.





Years Worked in Lower Queen Anne

Two-thirds (64%) of employees (those who work in Lower Queen Anne regardless of if they live in the area) have worked in the area for less than 5 years.


Travel Behavior

Travel Behavior Findings

- Overall, walking is the most commonly used travel mode used to get to Lower Queen Anne—41% of respondents use this mode.
 - Twenty-five percent take a bus, and 15% drive alone.
- The vast majority of residents walk.
- Three-quarters of respondents used an alternative mode to get to Lower Queen Anne.
- The primary reason for driving alone is the feeling that public transportation is inconvenient or takes too long.

Travel Mode – All Respondents

Overall, the most commonly used travel modes to Lower Queen Anne are walking (41%), bus (25%), and driving alone (15%).



Travel Mode by Residency / Work Status (top 4)


Driving alone is most commonly seen among commuting workers.
Visitors use a variety of travel modes to get to the area.
The vast majority of residents walk. This is regardless of whether they also work here.



Personal Vehicle vs. Other Modes

Three-quarters (76%) of respondents used alternative transportation modes to get to Lower Queen Anne.

 Alternative modes include all modes other than driving alone, carpooling, carshare, or rideshare.








Personal vehicle is anyone who drove alone, carpooled. Carshare or rideshare is NOT a personal vehicle.

Personal Vehicle vs. Other Modes – Residents vs. Others

Workers are the most likely group to use a personal vehicle. None of the respondents who live and work in the neighborhood report using a personal vehicle.



Reason for Driving Alone

Overall, the primary reason for driving alone is that transit takes too long. This is followed by having a job that requires the use of a car.



Q9: Why did you choose to drive alone (including carshare)? Multiple response: may sum to > 100% Base: Those who drove alone (including carshare) (n=76)


Parking Place and Time to Find

Nearly two-thirds (64%) of those who took a vehicle parked in on the street. Sixty-four percent parked within two blocks of their final destination.



Parking Place for Workers Who do Not Live in the Area

Among those who work, but do not live, in Lower Queen Anne, 55 percent park in a paid parking spot: Twenty-nine percent in a paid on-street parking spot, and Twenty-six percent in a paid off-street parking spot.



Distance to Parking Spot Mean=1.9 Blocks





Travel – Use of Service or Apps

The vast majority of respondents did not use any services or apps to get to Lower Queen Anne.

Duration and Frequency of Visits

Duration and Frequency Findings

- The average duration of a trip to Lower Queen Anne is just under 4 hours, but varies by residency / work status.
 - Visitors indicate they are going to spend the least time in the area—averaging
 2.7 hours
 - Those who work in Lower Queen Anne, but don't live there indicate they will spend the most amount of time in the area—just under 7 hours.
- Overall, one third of respondents live in the neighborhood and an additional third are in the area 2 or more days per week.

Duration of Visit

Seventeen percent of respondents indicate they will spend 24 hours or more in the neighborhood—this almost exclusively consists of residents.

Fifty-nine percent of respondents indicate they will be in the area for 5 hours or less.

Duration of Visit (Mean=3.9 hours*)





Duration of Visit by Residency / Work Status

Visitors and residents indicate they are going to spend the least time in the area—averaging 2.7 hours

Those who work in Lower Queen Anne, but don't live there indicate they will spend the most amount of time in the area—just under 7 hours.





Duration of Visit by Travel Mode

On average, those who drove to Lower Queen Anne are most likely to be in the area the longest. There is no difference between those who walk and those who take public transit.



Frequency of Visits

One-third (32%) of respondents live in the neighborhood. An additional third (34%) are in the area 2 or more days per week.






Q14: How often do you typically visit the area?

Frequency of Visits by Residency / Work Status

Visitors have the lowest frequency to Lower Queen Anne—nearly half come to Lower Queen Anne less than once a month and 20 percent state this was their first trip to the area.



Frequency of Visits by Travel Mode

Those who walk or bike are in the area most often as the majority of them live there. Those who take a personal vehicle come to Lower Queen Anne the least often.


Reasons for Visiting

Reasons for Visiting Findings

- Aside from residing in the neighborhood, working, shopping, and eating out are the most commonly mentioned primary reasons for being in Lower Queen Anne.
 - While visitors and residents have a variety of trip purposes, those who work in Lower Queen Anne, but not live in the area, are in the area almost exclusively for work.
- When respondents were asked about their typical reasons for visiting Lower Queen Anne the most commonly mentioned reasons were for eating out and shopping.

Main Reason for Today's Visit

Aside from living in the neighborhood, working, shopping and eating out are the most commonly mentioned primary reasons for being in Lower Queen Anne.





While visitors and residents have a variety of trip purposes, those who work in Lower Queen Anne, regardless of if they also live in the area, are there primarily for work.



Main Reason for Today's Visit by Travel Mode

Eating out and shopping are cited as the main reasons among most respondents, particularly those who walked or biked to the area.

Work is the top reason among those who use a personal vehicle and those who use transit.





Reasons for Typical Visit

When respondents were asked about their typical reasons for visiting Lower Queen Anne the most commonly mentioned reasons were because they live in the area, eating out and shopping.



The findings for typical reasons are similar to the primary reason for being in Lower Queen Anne. Visitors and residents have a variety of trip purposes.

Workers are in the area almost exclusively for work.



Spending


Spending Findings

- Eighty-four percent (82%) of respondents plan on spending at least some money while in the area.
 - Among those who plan on spending money, the average spend is \$41.67.
 - Visitors typically spend the most money while in the area and workers the least.
 - Those who use a personal vehicle area likely to have the highest spend.



On average, visitors spend the most and workers spend the least.






Age and Gender by Residency / Work Status
