# Appendix C Plans and Regulations Consulted

Seattle's solid waste planning is informed by and must comply with various state and local regulations, guidelines, and plans, including requirements outlined in the Revised Code of Washington (RCW). Seattle's *2022 Solid Waste Plan Update (2022 Plan Update)* draws on the *2011 Solid Waste Plan Revision* while also considering the past decade of regulatory and planning developments around the solid waste industry and emerging social and environmental concerns.

Chapter 1, *Development of the 2022 Solid Waste Plan Update*, describes key plans and regulations that Seattle Public Utilities (SPU) reviewed and incorporated into the *2022 Plan Update*. SPU also reviewed the following plans and regulations for updates since the *2011 Solid Waste Plan Revision* and determined that they align with or do not alter SPU's Plan or current programming:
