a) 2023-2028 Capital Improvement plan

Maura Patterson, SPU Drinking Water Planning and Policy Advisor, gave a presentation on the Capital Improvement Plan and upcoming Workshops. A discussion ensued about how SPU and the various Operating Board member organizations measure success when implementing projects and how they plan for staff resources to best match projected spending.

b) Almost Spring Water Supply Update

Elizabeth Garcia, SPU Water Resources Hydrologist, provided an overview of Seattle's water supply system, sharing information about the protected forested watersheds, hydrology monitoring, river and reservoir management seasons, and how SPU manages the water supply for multiple objectives. Elizabeth also presented information on how things are looking for Water Year 2022 describing the stormy start and monitoring and management activities so far.

c) North Fork Tolt Opportunities

Alex Chen shared information and considerations related to future North Fork Tolt water supply options. A robust discussion ensued about current firm yield and long-range demand projections.
