Event:	Macy's Holiday Parade
Date(s):	Friday, November 23, 2018
Location:	Downtown/Westlake Park
Organizer(s):	Denise Hinton, Chris Levy

## Event Notes:

- 28<sup>th</sup> Annual My Macy's Parade (Citywide Event)
- Last year Denise Hinton will be producing Holiday Parade; Chris Leavy shadowing and will be producing 2019 event
- No changes from 2017 event; Staging and route staying the same
- Length of parade looks to be the same; Approximately 1 hour to 1 hour and 10 mins
- Expecting about 25 Macy's floats; Seattle Times and Warm 105.9 are both sponsors and may bring a wrapped vehicle
- Seattle Times will have an inflatable in parade
- About 11 floats so far
- Organizers do not know how many groups will be on foot; Applications are still being accepted; As of now there is no one new signed up for the parade

### Committee Discussion:

**SPD** – Staging for the floats should be reviewed as there is construction at Convention Place **Metro** – Bus tunnel entry where the floats have staged across from the Paramount is gone; Buses are now parked under the Convention Center at Convention Place; The only way access bus staging is on 9<sup>th</sup> Ave; We will need to find other locations for float staging on 9<sup>th</sup> Ave and near the paramount; 3 or 4 routes are affected; Organizers stages EMS, Port-a-potties, tent and other staging on 9<sup>th</sup> Ave between Pine and Olive Metro can't make a right turn onto Olive from 9<sup>th</sup> Ave; Only 9<sup>th</sup> Ave staging needs to be relocated, Metro reroutes off Pine St.

**SDOT** – Confirming Metro would like 9<sup>th</sup> Ave open from Convention Tunnel to Convention Place; Organizers asking to move staging to Boren Ave.; Boren Ave. has been under construction as part of the convention expansion, SDOT doesn't know the status of the roads; 8<sup>th</sup> Ave between Pine and Pike the Grand Hyatt has loading dock but there are some parking on the east lane on 8<sup>th</sup> Ave; Olive maintains east bound traffic, Macy's only closes one lane; SDOT suggests using bus lane between 9<sup>th</sup> Ave and Boren; Another option is to look at 8<sup>th</sup> Ave; Access will need to maintain access to Grand Hyatt but organizers could use east curb lane on 8<sup>th</sup> Ave and have Local Access Only to the Grand Hyatt; Denise, Mike and Glenn will talk offline about staging; Rainier Square project taken all the parking on Union, 5<sup>th</sup>, University and 4<sup>th</sup>; construction should not interfere with parade, but sidewalk is gone

SFD – Ambulance on 9<sup>th</sup> and olive; Organizers hire AMR

FAS – Needs list of vendors; Organizers will send to FAS

**DON** – If changes are made to staging on 9<sup>th</sup> Ave, let the new businesses know about staging area; Organizers work with Libby Dover from Dover Entertainment to send out one notification letter about the parade, star lighting and fireworks

### Event Notes:

• Organizers hired by DSA to work with stakeholders for Westlake tree lighting; Producing events for

the past 2 years

- 2018 event will look a lot like 2016 event; Adding more décor elements for this year •
- Following same street closures in the past 8:30 9:00am •
- Works with Macys and staff to have staff at all street closures •
- Will install some large lighting gobos that will scale the buildings with large snowflakes; Lighting on the building will start at sundown
- Starting at noon there will be amplified music from Westlake •
- Between 5 and 5:30pm organizers will work with SFD and SPD to get the right timing for the • fireworks
- There will be a small program starting about 5pmon the balcony of Westlake; emcee comes out with Santa
- The tree will be lit, then carousel, then the star, and finish with the fireworks •
- Timing could be off on the original run of show since working with SFD and SPD on site •
- Organizers are working with the tenants in the surrounding buildings for event and potential for other activations
- Macys have new vendor for fireworks Pyro Spectacular •
- Pine St. between 3<sup>rd</sup> and 4<sup>th</sup> Ave and 4<sup>th</sup> Ave between Pine and Olive is the firework exclusion zone; • Exclusion zone gets set up typically at 3 pm; Macys has 16 extra guards coming at 2pm to assist

### Committee Discussion:

**Chair** – Clarity on the gobos that will be used; Organizers explain they are essentially large moving light, not as big as spotlight; There will be 2 locations: balcony on Westlake mall and balcony of All Recipe building; Organizers are working with Westlake mall building, Macys, Westlake park, and other businesses on Pine, that are directly impacted by the lights

**SPD** – Organizers asking if need room for SPD inside of Macy's; SPD tree lighting deployment isn't going to be as big as past; If needed Denise will put SPD in contact with operations manager at Macy's and they will find a spot for SPD inside of the store; Communication contact with SPD West Precinct will be Lt. Moss SFD –Haven't seen a permit or plan from Pyro Spectacular about show; SFD needs a list of product and must approve products, previous conversations we talked about not having 1.3 product (no fallout); Organizers are working it out so contractor is providing everything asked for by SFD and building for the covering (tarping) and set up; Macys told tenants they couldn't have people on top of the building; SFD has no issues with that

**SFD/Medic1** – Typically doesn't hire out medic for event; There are no records of EMS covering event; There would be a contract if organizers needed medic onsite; No medic tent or station onsite; Organizers call 911 in case of emergency; Anticipating about 10,000 people that gather between 4:00-5:30pm Parks – Westlake just activated for events

**SDOT** – Pine St between 4<sup>th</sup> and 5<sup>th</sup> closed in the morning and keeps closed during the day; 3<sup>rd</sup> closed at 3:00pm but if needed earlier than they will earlier is possible if needed

Event:	Capitol Hill Block Party

Location:	Capitol Hill

**Event Notes:** 

- 23<sup>rd</sup> CHBP; Jason producing it for the past 5 years, a part of it for last 12 years
- Layout and set up the same to the last few years; Worked with the one construction site (old value) village); Organizers are assuming site will still be under construction for 2019 event
- Already started conversation with Noise Abatement for 2019 event variance

- A lot of communication with neighbors in area, immediate neighbors in the footprint and in the area
- Worked with neighborhood businesses for promotions; \$30,000 worth of tickets given to 14 businesses which returned \$20,000 in revenue that went back to the 14 businesses
- 8 community events/activations
  - Skate Competition; Partnered with 35<sup>th</sup> North Skate Shop, skate shop that's been there for about 20 years, for a skate competition at Cal Anderson park; Skate competition futured youth, women and sponsored skaters
  - CHBP poster show at Vermillion Art Gallery; Showcasing 40 local graphic designers to showcase their CHBP poster designs
  - CHBP Photo showcase at Café Vita; Showcasing local photographers who photographed CHBP in the past
  - Artist Panel series; Panel futured local musicians, artists, band managers, and industry experts
  - Courtyard Yoga in Chophouse Row; Partnership with Sweatbox Yoga to put on two yoga classes
  - Chophouse Row DJs; Live DJ sets in the courtyard all three days, Open and free to the public
  - SoundOptica Visuals at Northwest Film Forum; Presented a special audio-visual experience with Hush Records, SoundOptica and Northwest Film Forum
  - After Dark Programming at various venues; 7 venues on Capitol Hill, 15 Special Events, 20+ DJs
- Under the Block Party at Capitol Cider was not associated with CHPB; Capitol Cider reached out to Jason and he connected them with The City
- A lot of new activities and activations for 2018 event; Looking to see if can expand events or create more activations and business partnerships for 2019 event
- CHBP underwrites Capitol Hill art walk; Helps expand and makes more successful, participating stores don't need to pay to be a part of event; Support for visual artists and helps to gives back to community

## Committee Discussion:

**Chair** – Question to organizers about local talent percentage; Organizers state they book 65-70% local/regional acts; in 2018 it was 66% local, in 2016 Odesza headlined, in 2018 Father John Misty headlined, Pickwick has also headlined; Some local bands headline but majority focus is up and coming local bands **SPD East Precinct (Lt Leung)** – SPD needs to upstaff officers; Organizers did not put officers on application; East Precinct brings in officers for event starting at 11am to event end; In peak time there could be an increase of 24 officers; For 2017, about 30 incidents that needed to handle for weekend with 5 arrests made **SPD Patrol (Assistant Chief Greening)** – Concern is that event is bringing in all these officers and resources, but the reimbursement to the City is not there; The appropriate amount of officers needed for the event is beyond on duty resources which causes the precincts to bring in more officers; SPD wants to know how many officers organizers feel like need and how many officers they are willing to pay for

**Organizers** – Were told several years ago by SPD East Precinct that they did not want SPD inside event footprint; Were told at previous meeting that there were no significant incidents this year; Organizers can handle the internal event footprint, hiring 120 private security; Organizers are willing to talk with SPD for staffing

**SPD Patrol (Assistant Chief Greening)** – Within footprint organizers are not requesting SPD staffing in the permit application; Any officers assigned within footprint the organizers will need to reimburse The City; Organizers won't be billed for officers outside of the fence; Organizers are not allowed to hire King County officers inside of the footprint

**Organizers** – In years past, organizers have hired King County officers to secure the gas station, per conversations with SPD East Precinct

**SPD East Precinct (Lt Leung)** – SPD has concerns with the lack of presence inside the footprint of the event; One arrest from 2018, patron was leaving the block party and became victim of robbery, but because of

officer presence they were able to make the arrest; There were a few fight disturbance outside of the venue; four arrests made inside of the event (from officer working there); Additional personal is needed for inside of the venue; Due to the increase of activity in the neighborhood, additional staffing is needed outside of the venue

**Chair** – Per staffing information given by SPD to Special Events and Organizer, the 2018 invoice included an increase in officers posted in the event footprint; A separate subcommittee between SPD and organizers will be scheduled to discuss what staffing organizers are expecting, and the expectation of officer staffing by SPD **SFD** – Serpentine on Broadway through the Shell lot is wide open area; Down by 11<sup>th</sup> there look like a 45 degree angle; The 60 ft truck need clearance so need to be arranged so there is enough room for the trucks to come into festival; Organizers had conversation with ladder crews heading north taking a left to Pike and they were ok with the turn; Organizers have staffing is at every road closure locations so crews at the gate can move barricades in case of emergency; There is established security at locations, minimum of two security and usually an SPD patrol car; Send diagrams of beer gardens by spring for approval and occupancy load

**SFD/Medic1** – Organizers hire bike medics for event – 2 paramedics; 3<sup>rd</sup> party that has come on for event medics, but after 2018 event organizers are looking to work with SFD; Organizers already had good conversation to bring in SFD for 2019 event; Normally have 3-4 EMT depending on event duration; Organizers should work with Lt. Curtis for staffing numbers

**WSLCB** – Confirming same layout; Layout has worked for WSLCB; The VIP lounge sponsored, email sponsored info to Lt. Rieder; There is a new officer assigned to Capitol Hill area and Lt. Reider will make introduction

**Parks** –Parks will not approve skate park activation in the tennis court for 2019 event; No problem with the activation but with the collateral with the activation; Parks does not want others to see CHBP set up in the space and then think they can do the same set up in the space; Chair requests side conversation with Parks to discuss this policy, concerned that the policy penalizes parties who permit because of parties who don't permit

**SDCI Noise** – SDCI Noise abatement working with the crew; Working with Carlson Audio; final determination not yet made

**SPU** – Questions on Waste Management plan, Organizers hire crews that do sweeps every night and ongoing throughout the event; Organizers rent parking lot for waste management, crews sweep the parameter and grounds keeping every night; Organizers check in with businesses to see if missed anything **DON** – Outreach that organizers have been doing has been great; DON wants to make sure that all of the apartment buildings are notified; DON wants list of contacts for the area that organizers contact; Organizers will follow up with Karen Ko for contact list, and will invite Karen Ko to meetings

**SDOT** – Will continue to work with new construction or projects that will affect event; Will look at parking and staging locations

FAS – Closer to event, will need a list of vendors, food trucks, event supply companies

**Health** – Will need a list of food vendors; Food Trucks must have their annual King County permit for food trucks; Hot running waters and restrooms must be available for the food trucks; Restaurants that prepare food outside need permit

**Chair** – Reminder that unless significant changes are made within the event, organizers cannot be charged more than 10% increase in SPD fees each year; Additional meetings will be set so conversations can happen between organizers and SPD regarding staffing and expectations

## Event Notes:

- Event starting in early 2019; Exact date will be determined by WSDOT
- Grand opening for SR99 Tunnel; Farewell to the viaduct; Look ahead to the future of the Waterfront
- Most of the festivities happening in the North Portal; South Portal will have activation in the parking lot behind the Pyramid Brewery
- Saturday Events
  - o 7:30am 12:00pm Fun Run
  - 11:30am 12:30pm Ribbon Cutting; Ribbon cutting will be in the south end of the portal; Public event with Elected Officials invited to attend; Elected Officials will be able to park within closure of event
  - 11:00am 6:30pm Public Festival; Festival will be in north end of portal; 2 stages at festival site with vendors, booths, Port-a-Potties
  - 12:30pm 6:00pm Hello Tunnel; Pedestrian walkway and tunnel walk; Tunnel walk will be timed and ticketed; 10,000 participants will be able to enter the tunnel each hour
  - Viaduct walk; Pedestrians can walk the viaduct (top deck) by entering through Seneca St or the Battery St. Tunnel
- Sunday Events
  - 7:30am 11:00am Bike Ride; Bike ride will be put on by Cascade Bicycle Club
- Organizers are going to fully close Aurora Ave between Roy St to south of Denny starting on Saturday morning to Sunday
- Pedestrian tunnel walk will be timed and ticketed; Maximum 10,000 per hour; Pedestrian tunnel walk there is a dip in about 1,200 ft for participants to go in and turn around; Organizer expects about 50% of participants to utilize
- Metro shuttles will be going only north bound; No entry from the south end of tunnel; Organizers will activate Pyramid parking lot; Metro shuttles start will be there
- Incident command center will be in the north operations building near Seattle Center; All public departments are invited to participate
- Line control and line management put in place due to a free ticketed event
- Viaduct Walk
  - Access through Seneca St or the Battery St Tunnel
  - Office of Arts and Culture is helping curate programing; Temporary art instillations, interactive art activities, speeches and performances will be happening throughout the day
  - All activation will be on the upper level of the viaduct; The west side of the viaduct will be the fire lane, there will be a 5 ft buffer on each side of the viaduct for safety
- 8K fun Run
  - Packet pickup, registration and queuing will now be at Seattle Center; 3-4-day expo prior to event
  - Runners will be placed into groups; Holding sections are identified within festival site leading up to the starting line; 10-15 wave start to help clear participants;
  - 7:30am start; Majority of finishers will be done by 9:30am
  - Most of the route will be on WSDOT property, will utilize some of 1<sup>st</sup> Ave and Columbia St.
- Bike Ride
  - Sunday morning event; Time frame between 7am 12pm
  - Start and finish will be identical to the run; Stage all the riders on the 6<sup>th</sup> Ave access road;
     Additional staging will be to Harrison St. and Taylor St.
  - Bike Tunnel Route
    - Head south into the tunnel on the southbound deck
    - Continue in the tunnel all the way to the end at East Marginal Way and South Idaho Street

- Make a U-turn (to the left) on E Marginal Way at South Idaho Street and return north on SR 99 mainline
- Enter the tunnel at the northbound on-ramp and continue through the tunnel, exiting at the SR 99 off-ramp to Republican Street
- At the top of the ramp, take a right onto Dexter Avenue North
- Continue south for one block and then take a right onto Harrison Street
- At the intersection of Aurora Avenue North and Harrison Street, riders will be able to make a choice; If the riders just wanted to ride the tunnel then the ride is over – estimate this loop would be 8.5 miles
- Viaduct Bike Route
  - Riders can choose to continue onto the viaduct (see below)
  - Take a left heading south onto Aurora Avenue North (heading south in the current northbound/left lanes) and into the Battery Street Tunnel
  - Continue through the BST and onto the top deck of the viaduct heading south to the Seneca off-ramp
  - Take a left to exit onto the Seneca off-ramp to First Avenue and take a right to head south onto First Avenue
  - Continue First Avenue for 4 blocks to the Columbia Street on-ramp
  - Turn right onto the Columbia Street on-ramp and then turn right onto the lower deck of the viaduct
  - Head north on the lower deck of the viaduct and back through the Battery Street Tunnel
  - The finish line will be on Harrison, near the Operations Building estimate this loop would be 4 miles
  - Riders just doing the tunnel will be able to finish on 6<sup>th</sup> Ave; There will be finish line and expo booths set up

### Committee Discussion:

**Chair** – Question on estimated attendance numbers; Organizers estimates is larger than 520 opening, some impacts on weather – estimating 80,000 – 100,000; SR520 had about 50,000 attendees; Hoping that nature of fun run and ride will attract people

**SPD** – Lt. Clenna questions about the procession onto the viaduct; Organizers will stage at the Harbor Steps, estimated between 30 and 250 participants and will use the Seneca onramp to enter the viaduct; Organizers will work will SPD for number of participants; Processional will start at 12:30, Staging will start at 11:30, viaduct activation will end approximately at 6:30

**Chair** – Requesting more details on procession; Include map of route and a separate map showing the layout activity on the viaduct; submit to SEO for distribution to Committee

**SFD** – Submit list of food vendors for approval; Organizers anticipating a flow rate up to 10,000 participants per hour; Organizers planning to run ventilation system; 120 peer security hired

Metro – Will keep working on plan

**SDCI Noise** – Set up early in the morning may require a TNV; SDCI needs information for the start line and if set up; Organizer will send speaker location map, announcements, and timing of announcements to SDCI Noise

**DON** – Contact some of the neighborhood groups and council groups in the area; Will want to talk to community groups for the events

**Seattle center** – Key Arena demo will be going on; Potential conflict on campus since some of the haul routes will go on campus then to Harrison to Aurora – running all night 11pm to 7am

SDOT – For bike ride, come off Seneca to Columbia, either rules of the road or can stop riders?; Lt. Clenna thinking about shutting down south bound lanes and rerouting – will need to figure out; Depends on how many bikes are apart of the event; SDOT will continue conversations about the procession
 Health – Annual food truck permits and temporary food permits for vendors cooking outside are required
 Chair – Subcommittee meeting will be scheduled for December

- Seattle Womxn Marching Forward produced 2017 event; Charmane Sly was the emcee for 2017 march; Liz and Liberty worked with planning and executing 2017 march; Seattle Womxn Marching Forward is affiliate with the State and National organization
- 2018 event was not produced by them
- Organizers are looking for feedback from the City and willing to work with the City to produce a successful event for 2019; Ideally would like a rally and a march
- Expect that we could see as many as 70,000 participants; Cannot predict due to political news
- Date: Saturday, January 19, 2019
- The Special Events Office scheduled presentation after email communication with Charles Weber with Seattle Action Group; Seattle Womxn Marching forward will reach out to Charles Weber
- Ideally would like Seattle Center as the finish location, so rooms on campus can be utilized for breakout and information sessions
- Organizers are flexible on the start time; There will be 20-30 minutes of programming before stepping off
- Cal Anderson is likely not being considered for 2019 event

## Committee Discussion:

**Chair** – Permanent Viaduct Closure (PVC) of 1/11/19 through about 2/1/19 means Committee will need to work with organizer to identify a rally starting point, route, and dispersal location that will not conflict with restrictions

**Seattle Center** –Jan 19<sup>th</sup> available; The Kea Arena construction will be happening at that time, there will be construction around the clock; 2<sup>nd</sup> Ave will be taken for construction; More information to come on construction and haul route for the construction; Organizers should connect with Michelle Blackmon for use of Seattle Center

**SDOT** – During PVC we are restricting north, south, east and west activity in the downtown core; The event will happen, not sure if we can dictate if the event happen, but we can suggest routes; Considering using the express lanes; Express lanes are WSDOT and will probably have the same restrictions due to PVC, but if express lanes are open could use UW for start; Organizers would need to talk with UW for use of parking lot or surrounding areas for starting location

**SPD** – Sgt. Bailey likes the idea of setting up at UW; Could use the express lanes to Mercer St to Seattle Center

**Metro** – Preference is to find a starting location that is easily accessible to a transit station; Last year there were metro shuttles to take participants back down to downtown to take transit; If can direct participants to light rail stations then it will avoid some congestion through downtown Seattle; Transportation depends on how many people and how we can access; Metro will adapt to situation; Metro can assist depending on location

**Sound Transit** – Confirming there will be a rally before march; Sound Transit found that rider ship increased as marchers reached Westlake since they didn't want to march whole route; Need to keep in mind the exit

points along the route; Should explore use of express lanes with WSDOT

**Chair** – Recommend also consider starting at CenturyLink to Seattle Center, if downtown is allowed; Necessity to keep it straight route and the committee can assess based on time, place and nature; Distance from Cal Anderson to Seattle Center – 1.8 miles, CenturyLink to Seattle Center – 1.6 miles, UW to Seattle Center – 4miles, Judkins Park to Seattle Center 4miles; Downtown core must be used for this, will need to work with SDOT and SPD for routes

**DON** – Would say should stay out of CID; When organizers do settle on route, keep DON in loop for notification

#### A Seattle Special Events Team (ASSET)

David Doxtater Presenter

- ASSET is an organization of event producers
- Group started in the 90s and has been around for the past 30 years; Dox was a part of the original group
- Purpose is to promote and tell the story of Seattle special events, sporting events, etc.; ASSET wants to give events a voice about the issues that affect the event organizers and community
- Events are the soul and spirt of the community and help promote the community; Events are what you do in the time away from work
- ASSET is concerned with the future of events in Seattle specifically with congestion in the City, cost savings in the City, discussions of cost recovery, and fee increases
- ASSET worries that without some sort of feedback from ASSET, some of the events will go away due to increasing costs or ability to host on Seattle streets
- Washington Festival and Event Association (WFEA) is the current home for ASSET
- David Doxtater and Beth Knox are current co-chairs for ASSET
- Two primary functions asset brings
  - 1. Helped form the committee itself and Special Events ordinance (1991); asset work with the City to bring about the ordinance and committee; ASSET group is influential of city policy and policy work
  - 2. City legislation Special Events Office and The City will work with ASSET when considering large or major events i.e. MLB all-star game, bid for host city for FIFA

### Washington Festivals and Event Association (WFEA)

- WFEA is the trade association for events in Washington; Around for 25 years; Providing networking and education for event organizers
- Seminar for event organizers is scheduled for October 25 at Bertha Knight Landes Room at City Hall
